Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of Pitlik & Wick, Inc. 401(k) Profit Sharing Plan ("the plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of Pitlik & Wick, Inc. 401(k) Profit Sharing Plan ("the plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). 1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Method of accounting - The Pitlik & Wick, Inc. 401(k) Profit Sharing Plan ("the plan") follows the accrual method of accounting wherein additions and deductions are reflected in the period earned or incurred.

Accounting estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Subsequent events - The financial statements include management's evaluation of the events and transactions occurring subsequent to January 31, 2025 through November 14, 2025, which is the date the financial statements were available to be issued.

Risks and uncertainties - The plan invests in various investments. Investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

Key parties of the plan - Pitlik & Wick, Inc. is the plan sponsor, employer and plan administrator. Granite Management, LLC is a participating employer. Voya Institutional Trust Company is the plan's trustee that holds custody of plan assets. Voya Retirement Insurance and Annuity Company is the plan's recordkeeper that maintains investment and participant records, third party administrator that maintains plan documents and tax counsel that performs various compliance tests. The two related entities are collectively referred to as "Voya". Heck Capital Advisors is the plan's investment advisor.

Investments - The plan sponsor determines the investments available to plan participants. The participants allocate their contributions and transfer existing balances to these investment options. The net appreciation (depreciation) in fair value of investments bought, sold and held during the years is reflected in the accompanying statements of changes in net assets available for benefits. Participants should refer to the prospectuses and annual reports for more information.

Fair value measurements - GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical investments (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1 - Valuation is based upon quoted prices in active markets for identical investments.
- Level 2 - Valuation is based upon other significant observable inputs (including quoted prices for similar investments).
- Level 3 - Valuation is based upon significant unobservable inputs (including the plan's assumptions in determining the fair value of investments).

The following is a description of the valuation methodologies used for investments measured at fair value.

Mutual funds - Valued at the daily published quoted market prices as reported by the funds. The mutual funds held by the plan are registered with the U.S. Securities and Exchange Commission, are required to publish their daily net asset value ("NAV") and are deemed to be actively traded.

Common trust fund - The plan invests in the T. Rowe Price Stable Value Common Trust Fund which is a direct filing entity. The plan values this investment at NAV based on the underlying unit value as reported by the plan's trustee. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the plan intends to sell the investment for an amount different from the reported NAV.

2. DESCRIPTION OF PLAN

The following description of the plan provides general information. Participants should refer to the plan documents for a more complete description of the plan's provisions.

General - The plan was established on March 31, 1970 as a defined contribution plan with a 401(k) salary deferral arrangement. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and subsequent amendments.

Eligibility - Employees are immediately eligible to participate in the plan once they have reached age 18.

Contributions - Contributions are recorded in the year in which eligible compensation is paid. Contributions to the plan can be made in the following ways:

- a. Participants may contribute a percentage of their compensation subject to certain limitations (elective deferral contributions). The plan also permits Roth elective deferral contributions. New employees are automatically enrolled in the plan and have 5% of eligible compensation withheld as elective deferral contributions. Such participants have the option to increase, decrease or stop the deferral by completing the necessary documentation.
- b. Rollover contributions are accepted by the plan from other qualified plans.

- c. The plan sponsor periodically provides contracting work for federally funded contracts which are subject to prevailing wage provisions under the Davis-Bacon Act. For these contracts, to comply with the prevailing wage provisions, employers must determine if additional payments need to be made to their workers (calculated based on a "prevailing" hourly rate). If additional payments are required, the employees have the option of taking these amounts as compensation or as contributions to the plan (employer Davis-Bacon contributions). These contributions are funded coinciding with each pay period.
- d. Annual employer profit sharing contributions may be made at the discretion of the employer's board of directors. Employees are eligible to receive discretionary profit sharing contributions if they have completed at least 1,000 hours of service during the plan year. The contributions are allocated following a permitted disparity schedule as defined in the plan agreement and are reduced by any prevailing wages contributions.

Participant accounts - Earnings, including the fair value appreciation or depreciation, are allocated to participant accounts on a daily basis based upon the performance of the investment options selected. Each participant's account is credited with the participant's elective deferral contributions, rollover contributions, any prevailing wage contributions and an allocation of employer profit sharing contributions. Participants are allowed to transfer funds between the various investment options and change their deferral percentage each pay period.

Vesting - Participants are always 100% vested in their employee elective deferral contributions, rollover contributions, prevailing wage contributions and related earnings. Participants become 25% vested in their profit sharing contributions and related earnings upon two full years of service. Participants then vest at the rate of 25% each year thereafter until they are fully vested. Upon death, disability or attainment of normal retirement age while employed, participants become 100% vested.

Payment of benefits - Benefits are recorded when paid. Benefit payments may commence upon termination of employment, death, disability or retirement. Distributions are generally required to be in the form of a single lump sum or partial withdrawals. In addition, hardship withdrawals are permitted under certain circumstances. In-service withdrawals can commence upon attaining the age of 59½.

Forfeitures - Forfeited nonvested amounts are used to pay plan administrative fees or reduce employer contributions. Forfeitures used to reduce employer contributions were \$29,000 in fiscal 2025 and \$16,000 in fiscal 2024. Unapplied forfeitures were \$22,000 and \$13,000 as of January 31, 2025 and 2024.

Administrative expenses - Certain fees and expenses of the plan are paid by the plan sponsor. Certain other administrative expenses are paid by the plan using plan assets and recorded as administrative expenses in the accompanying financial statements. Administrative expenses paid by the plan consist of participant directed charges for distribution processing fees and nonparticipant directed charges for certain administrative and investment advisory services. The nonparticipant directed fees are allocated to participants on an account value basis.

Notes receivable from participants - Participant loans are not permitted by the plan.

3. PARTY-IN-INTEREST TRANSACTIONS

Voya provides certain administrative services to the plan pursuant to a service agreement between the plan sponsor and Voya. Direct administrative fees paid to Voya by the plan, included as a component of administrative expenses in the accompanying financial statements, were \$36,000 in fiscal 2025 and \$29,000 in fiscal 2024. Voya also receives indirect compensation from mutual fund service providers for services Voya provided to the funds. This indirect compensation is used to offset certain other amounts that would otherwise be owed by the plan to Voya for its administrative services to the plan. Transactions between the plan and Voya qualify as party-in-interest transactions. All such party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

4. TERMINATION OF PLAN

Although it has not expressed any intent to do so, the employer has the right to terminate the plan subject to the provisions of ERISA. In the event of plan termination, participants would become fully vested in their profit sharing contributions and related earnings.

5. INCOME TAX STATUS

The plan is operating under a Voya Retirement Insurance and Annuity Company non-standardized pre-approved profit sharing plan that received a favorable opinion on June 30, 2020, in which the Internal Revenue Service stated that the plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The plan administrator has not obtained a separate Internal Revenue Service opinion or determination letter for the plan; however, the plan administrator and tax counsel believe the plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code, and, therefore, believes the plan is qualified, and the related trust is tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the plan and recognize tax liabilities (or assets) for any uncertain tax positions taken by the plan that more likely than not would not be sustained upon examination by the applicable authorities. Plan management analyzed the requirements for accounting for such uncertain tax positions taken and determined the plan was not required to recognize any tax liabilities (or assets) related to uncertain tax positions taken as of January 31, 2025 and 2024. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress.

6. INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE

Management has obtained certifications from the plan's trustee, a qualified institution under the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, that state the following information with respect to assets held for investment of the plan is complete and accurate.

- a. Investments held and the fair values of such as of January 31, 2025 and 2024;
- b. Dividends and interest income from investments and net appreciation (depreciation) in fair value of investments during fiscal 2025 and fiscal 2024; and
- c. Contributions to, withdrawals from, purchases and sales of investments and interfund transfers between accounts during fiscal 2025 and fiscal 2024.

7. RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

As discussed in Note 1, the plan follows the accrual method of accounting for financial statement purposes. The Form 5500 is prepared on a cash basis. As a result, the accompanying statements of net assets available for benefits and the related statements of changes in net assets available for benefits differ from the Form 5500. The following table reconciles the financial statements to the applicable Form 5500.
