Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Twin Landfill 401(k) Profit Sharing Plan, (formerly Twin Landfill/ACZ Labs 401(k) Profit Sharing Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of January 3, 2025 and December 31, 2024, and the related statement of changes in net assets available for benefits for the period ended January 3, 2025, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Twin Landfill 401(k) Profit Sharing Plan performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of January 3, 2025 and December 31, 2024, and for the period ended January 3, 2025, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

NOTES TO FINANCIAL STATEMENTS

NOTE 1 - DESCRIPTION OF PLAN

The following description of Twin Landfill 401(k) Profit Sharing Plan, (formerly Twin Landfill/ACZ Labs 401(k) Profit Sharing Plan), (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

Plan Merger and Subsequent Transfer

On January 3, 2025, the Plan adopted and was merged with the Apex Waste Solutions 401(k) Retirement Plan sponsored by Apex Waste Solutions. Plan assets were transferred from John Hancock as of January 3, 2025, as certified by John Hancock. These assets were received by ADP, the new plan recordkeeper, January 7, 2025.

Plan period end is January 3, 2025, based on this being the adoption date of the new plan. Net assets available for benefits for the Twin Landfill 401(k) Profit Sharing Plan have been reported at zero as of January 3, 2025, as the legal responsibility for these assets was transferred to the new plan on that date.

General

The Plan was a defined contribution plan covering all employees of ACZ Laboratories, Inc. and Twin Landfill Corporation of Fremont County that are employers in a controlled group that have adopted the plan. On June 13, 2024, Twin Landfill Corporation of Fremont Count was sold to an unrelated company. ACZ Laboratories, Inc. transferred the assets of their employees out of the Plan on September 27, 2024. Employees are eligible to participate if they have reached age 21 and after completing one year of service with at least 1000 hours. Plan entry dates are the first day of each quarter. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees is responsible for oversight of the Plan. The Plan's Board of Trustees determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Contributions

Each year, participants were able to contribute up to 100% of pretax annual compensation as defined by the Plan. Participants who attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). Participants directed the investment of their contributions into various investment options offered by the Plan. The Plan offered various pooled separate accounts as investment options for participants. The Company matched 50% of participants' deferrals up to 6% of eligible compensation. Additional profit-sharing amounts may be contributed at the option of the Company's board of directors. In 2025, there were no profit-sharing contributions. Contributions are subject to certain statutory limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's discretionary nonelective contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

NOTES TO FINANCIAL STATEMENTS

NOTE 1 - DESCRIPTION OF PLAN (Continued)

Vesting

Participants were immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant was 100% vested after 6 years of credited service.

Notes Receivable from Participants

Participants could borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes were secured by the balance in the participant's account and bore interest at rates of 4.25% to 9.25%, which are commensurate with local prevailing rates as determined quarterly and are set at 1% above the prime rate by the plan administrator. Principal and interest were paid through payroll deductions.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant could elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a 10-year period. If the vested balance in a participant's account does not exceed \$5,000, the payment was required to be a lump-sum distribution.

Forfeited Accounts

At January 3, 2025 and December 31, 2024, forfeited nonvested accounts totaled \$\$8,416 and \$8,340, respectively. These accounts will be used to reduce the Plan's administrative expenses and then to reduce future employer contributions with the plan the assets were transferred to.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The presentation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Contributions from the Plan participants and the matching contributions from the Company were recorded in the year in which the employee contributions are withheld from compensation.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Investment Valuation and Income Recognition

Investments were reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and custodians. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the period.

Notes Receivable from Participants

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of January 3, 2025 and December 31, 2024.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS were recorded as a liability with a corresponding reduction to contributions.

Payment of Benefits

Benefits were recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan unless otherwise paid by the Company. Expenses that were paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants were charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in the net appreciation of fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through November 12, 2025, the date the financial statements were available to be issued.

NOTE 3 - CERTIFIED INVESTMENTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at January 3, 2025 and December 31, 2024, and net appreciation in fair value of investments, interest and dividends and interest income on notes receivable from participants for the period ended January 3, 2025, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Life Insurance Company (U.S.A.) (the custodian of the Plan).

NOTE 4 - FAIR VALUE MEASUREMENTS

The Plan's investments were reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. The Investment Committee determines the Plan's valuation policies. Although the Plan believes its valuation methods were appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to the unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Observable inputs such as unadjusted quoted prices in active markets;

Level 2 - Inputs, other than quoted prices in active markets, which are observable either directly or indirectly; and,

Level 3 - Unobservable inputs where there is little or no market data, which requires the reporting entity to develop its own assumptions.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets that are measured at Net Asset Value (NAV) as the practical expedient to estimate fair value and are aggregated in the fair value hierarchy as follows. There have been no changes in the methodologies used at January 3, 2025 and December 31, 2024.

Pooled Separate Accounts: Valued at the net asset value per unit based on either the observable net asset value of the underlying investment or the net asset value of the underlying pool of securities. Net asset value is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The NAV is used as the practical expedient to estimate fair value. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Fair Value of Investments in Certain Entities That Calculate Net Asset Value Per Share (or its Equivalent, Net Unit Value):

- (1) Seeks high total return through its target retirement date, with a great focus on income beyond target date.
- (2) Seeks long-term growth of capital.
- (3) Seeks maximum total and real return, consistent with preservation of capital and prudent investment management.
- (4) Seeks long-term capital appreciation.

Gains and losses (realized and unrealized) included in net assets available for benefits for the period ended January 3, 2025, are reported in net appreciation in fair value of investments.

The Plan's policy is to recognize transfers between Levels 1 and 2 and into and out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the period ended January 3, 2025, there were no significant transfers between Levels 1 and 2 and no transfers into or out of Level 3.

NOTE 5 - RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments were managed by John Hancock Life Insurance Company (U.S.A.), the Plan's custodian, and therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services were included in net appreciation in fair value of investments, as they were paid through revenue sharing, rather than a direct payment. As described in Note 2, the Plan made a direct payment to various parties in interest of the Plan for administrative fees of \$0 for the period ended January 3, 2025, which was not covered by revenue sharing. The Plan sponsor pays directly any other fees related to the Plan's operations.

These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 6 - TAX STATUS

The Plan used a Prototype Plan document sponsored by Ascensus LLC received an opinion letter from the Internal Revenue Service ("IRS), dated June 30, 2020, which stated that the Volume Submitter document plan satisfies the applicable provisions of the Internal Revenue Code (IRC). The Plan itself has not received a determination letter from the IRS. The Plan document has been amended since receiving the opinion letter. However, the Plan's management believes that the Plan was designed and being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified, and the related trust is tax-exempt.

NOTE 6 - TAX STATUS (Continued)

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of January 3, 2025, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan was subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 - RISK AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
