Opinion

Opinion

We have audited the accompanying financial statements of Inland Refrigeration and Air Conditioning Paid Time Off Benefit Fund (the "PTO Fund"), which is a part of Inland Refrigeration and Air Conditioning Health and Welfare Trust Fund (the "Fund"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), which comprise the statements of net assets available for benefits as of January 31, 2025 and 2024, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of the PTO Fund as of January 31, 2025 and 2024, and the changes in its net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the PTO Fund's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

NOTE 1 - DESCRIPTION OF THE FUND

Inland Refrigeration and Air Conditioning Health and Welfare Trust Fund (the "Fund") was organized to provide medical, surgical, hospital, dental, vision, life and prescription benefits to employees (and their dependents) of companies that have signed applicable collective bargaining agreements, or participation agreements for employees not covered under collective bargaining agreements. Since the merger with Inland Refrigeration and Air Conditioning Paid Time Off Benefit Fund on February 1, 1978, paid time off benefits are also provided to eligible employees. The Fund is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The disbursements of the Fund are under joint control of labor and management trustees.

THE PLAN DOCUMENT AND THE SUMMARY PLAN DESCRIPTION INCLUDE DETAILED RULES FOR EACH SITUATION. PARTICIPANTS SHOULD REFER TO THESE DOCUMENTS AND ANY AMENDMENTS THERETO REGARDING SPECIFIC PROVISIONS OF THE FUND.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The financial statements of the Fund are prepared on the accrual basis of accounting.

B. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

C. Employer Contributions

Employer contributions are recorded on the accrual basis. Employer contributions as reported are contributions made by employers on behalf of employees for the hours worked during the year. Employer contributions receivable is estimated based on the contributions received subsequent to the end of the year. No allowance is provided for estimated uncollectible accounts.

Employer contributions are made by employers in accordance with the collective bargaining and participation agreements at a fixed rate per hour.

The January 31, 2025 employer contributions receivable includes \$239,803 from four employers. Employer contributions from these four employers totaled \$3,283,665 or 59% of total employer contributions for the year ended January 31, 2025. The January 31, 2024 employer contributions receivable includes \$253,865 from four employers. Employer contributions from these four employers totaled \$3,058,767 or 58% of total employer contributions for the year ended January 31, 2024.

D. Employer Payroll Compliance Program

Employer remittance reports were accepted as submitted, without examination or verification of employers' payroll records. The system of internal control provides for examination of employers' records under a separate payroll compliance program.

E. Investment Valuation and Income Recognition

Accounting standards establish a fair value hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market.

Level 1 – Inputs based on quoted prices for identical instruments in active markets.

Level 2 – Inputs based on quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data.

Level 3 – Inputs are generally unobservable and typically reflect management's estimates of assumptions that market participants would use in pricing the asset or liability.

Level 1 investments consist of mutual funds that are actively traded on a national exchange.

Purchases and sales of securities are recorded on the trade date basis. Dividends are recorded on the ex-dividend date and interest income is recorded on the accrual basis. Realized and unrealized gains and losses are computed using investments' carry values for financial statement purposes.

F. Tax-Exempt Status

No provision for federal or state income tax is made. The Fund has received tax-exempt status from the federal government under Internal Revenue Code Section 501(c)(9) and from the state of California under Revenue and Taxation Code Section 23701i.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Fund and recognize a tax liability if the Fund has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Fund is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

G. Risk and Uncertainties

The Fund invests in investment securities that are exposed to various risks, such as interest rate, market fluctuations and credit risks. Due to the risk associated with investment securities, it is at least reasonably possible that changes in market values, interest rates or other factors will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

NOTE 3 - GENERAL INFORMATION

A. Administration

Southern California Pipe Trades Administrative Corporation provides administrative services to the Fund. The quarterly fee is \$2,170.50, plus miscellaneous administrative expenses.

B. Eligibility for Health Benefits

1. Initial Eligibility

Eligibility commences on the first day of the second calendar month following the date a participant has been credited by a contributing employer or employers with at least 500 hours of work within a period of not less than three nor more than six consecutive calendar months.

2. Maintenance of Eligibility

Once initial eligibility has been established, maintenance of eligibility requires one hundred (100) hours of work per month.

3. Continuation of Benefits

Under certain circumstances, a participant who would otherwise lose eligibility may continue benefits under the provisions of COBRA by making self payments.

C. Estimated Future Benefits Based on Participants' Accumulated Eligibility

Fund participants are allowed to accumulate a maximum of six hundred (600) hours to provide for future eligibility. Participants who have less than one hundred (100) hours reported in a given month may use their hour bank to obtain eligibility for that month. The estimated future benefits based on participants' accumulated eligibility provision is a six month maximum (600 hours) per participant.

D. Paid Time Off Benefits

Contributions received are credited to each participant's paid time off account for work performed between November 1st of each year through the last day of October in the following year. The paid time off benefits are paid annually on December 1st. If the participant fails to cash a paid time off check during either of the two calendar years following the date of issuance, the paid time off benefit is forfeited and the participant shall be deemed to have elected to contribute such amount to the cost of maintaining the PTO Fund. Participants may withdraw an interim payout of all or part of their accrued paid time off account balance before the December 1st annual payout. Only one interim payout may be paid each quarter, not to exceed the balance in his or her PTO account at the time of withdrawal. No interim withdrawals are permitted in November or December due to the proximity to the December annual payout.

NOTE 4 - HEALTH AND WELFARE FUND - COVERAGE ON NON-BARGAINING EMPLOYEES

The Fund provides current health and welfare benefits to corporate officers, who are covered under the terms of a non-bargaining agreement. No such persons were covered during this reporting period.

NOTE 5 - PRIORITIES UPON FUND TERMINATION

Upon the termination of the Fund, its assets will be used to provide benefits to eligible participants and to meet administrative expenses, until no assets remain.

NOTE 6 - PAID TIME OFF BENEFITS PAYABLE
