INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator

Opinion

We have audited the accompanying financial statements of N.A. Property, Inc. Medical and Dental Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA) which comprise the statements of net assets available for benefits and benefit obligations – modified cash basis as of January 31, 2025 and 2024, and the related statements of changes in net assets available for benefits and changes in benefit obligations – modified cash basis for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits and benefit obligations – modified cash basis of N.A. Property, Inc. Medical and Dental Plan as of January 31, 2025 and 2024, and the changes in net assets available for benefits and changes in benefit obligations – modified cash basis for the years then ended in accordance with the modified cash basis of accounting described in Note 2.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of N.A. Property, Inc. Basis of Accounting

We draw attention to Note 2 of the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note 2; this includes determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

NOTES TO FINANCIAL STATEMENTS

NOTE 1 - DESCRIPTION OF PLAN

The following description of N. A. Property, Inc. Medical and Dental Plan (Plan) provides only general information about the Plan's provisions. Participants and others should refer to the plan document and summary plan description (SPD) for a more complete description of the Plan's provisions, copies of which may be obtained from the Plan Sponsor.

General - The Plan provides medical, dental and prescription drug benefits to eligible employees (those who average 30 hours per week), and their dependents, of N. A. Property, Inc. (Plan sponsor), which includes nine related divisional entities. The Plan was established February 1, 2010 and is self-funded for most claims. A stop loss insurance policy is maintained which reimburses the Plan in the event claims exceed \$200,000 per person. A laser has been set for an individual which raises the deductible amount to \$1,550,000. The Plan is subject to the Employee Retirement Security Act of 1974 (ERISA), as amended.

NOTE 2 - ACCOUNTING POLICIES

Basis of Accounting

These financial statements have been prepared using the modified cash basis of accounting. The modified cash basis of accounting means that contributions and other revenues are recognized when received and claims and other expenses are recognized when paid. Benefit obligations have been included in these statements as discussed in Note 6 below.

Use of Estimates

The preparation of financial statements in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts in the financial statements and related footnotes. Actual results could differ from those estimates.

Contributions

In addition to deductibles and copayments, participants contribute specified amounts based upon estimates and at rates determined by the Plan Administrator for the benefits desired. No post-retirement coverage is available. Contributions are also received by eligible, inactive employees under the COBRA provisions of Federal law. The Plan sponsor contributes the amount necessary, in excess of the participants' contributions, to timely fund all claims as they are presented for payment.

Benefits

Benefits are recorded when claims are paid by the third-party claims processor. Amounts due to claims processors that have not been reimbursed by the Plan are recorded as payables to claims administrators in the accompanying statements of net asset available for benefit – modified cash basis. Provider refunds and discounts are netted against benefits paid.

Administrative Expenses

The Plan pays administrative expenses that consist primarily of administrative fees paid to third party claims administrators, the trustees, and actuary. These expenses are reported on the statement of changes in net assets available for benefits-modified cash basis as administrative expenses. All other administrative expenses, such as professional fees are paid by the Plan Sponsor on behalf of the Plan, as well as personnel who work on various aspects of the Plan.

NOTE 2 - ACCOUNTING POLICIES (Continued)

Reclassifications

Certain disclosures in the 2024 financial statements have been reclassified for comparative purposes to conform with the presentation in the 2025 financial statements.

NOTE 3 - CONCENTRATIONS OF CREDIT RISK

The Plan maintains its cash balances in one financial institution. The balances are insured by the Federal Deposit Insurance Corporation (FDIC) up to \$250,000. At January 31, 2025, and 2024 there was \$210,775 and \$131,162, respectively, in uninsured balances.

NOTE 4 - TAX STATUS

The Plan is not qualified pursuant to Section 501(c)(9) of the Internal Revenue Code (VEBA Trust), and as such, is not exempt from income taxes. However, the Plan is operated in a manner whereby any tax effects are borne by the Plan Sponsor. Accordingly, no tax provisions have been recorded for the 2025 or 2024 financial statements.

The modified cash basis of accounting require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if it has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service, or Department of Labor. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress from the Internal Revenue Service.

The Plan has an ongoing Department of Labor audit in progress that began in June '22 and continues as of the date of the audit report. There is currently no indication of potential outcomes for this audit.

NOTE 5 - PLAN TERMINATION

Although it has not expressed any intention to do so, the Plan Sponsor has the right under the Plan to modify the benefits provided to, and contributions required, participants to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on accounts of participants. No asset of the Plan may revert to the Company or be used for purposes other than for the exclusive benefit of the Plan's participants.

NOTE 6 - BENEFIT OBLIGATIONS

The Plan's benefit obligations and changes in thereto, are being reported within the financial statements in accordance with FASB ASU 965. The benefit obligations were based upon estimates developed by the Plan's Third-Party Administrator, which are reviewed, accepted and approved by the Plan sponsor.

The Medicare Prescription Drug, Improvement and Modernization Act of 2003 was passed into law and affects Plans providing prescription drug benefits to retirees. The Plan does not offer post-retirement benefits to retirees and therefore is not affected by these provisions.

NOTE 7 - PARTY IN INTEREST

The Plan receives contributions from the Plan sponsor as discussed in Note 1. All funds contributed were used to maintain the plan and provide benefits for participants in the Plan in accordance with the provisions of the Plan Document. These transactions are party in interest transactions under ERISA.

NOTE 8 - RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

The financial statements were prepared using the modified cash basis of accounting. However, the Plan utilizes the cash method of reporting for their 5500 filing. Accordingly, the following is a reconciliation between the financial statements and the Form 5500:

NOTE 9 - AMENDMENTS & EVENTS

The Plan was amended, effective February 1, 2025 to delete and replace the “Member Aetna Discount” program with the “VSP Discount” program; nutritional counseling is expanding to include state medical and mental health conditions, and to include coverage related to gender affirming care.

The Administrative Services Agreement was amended, effective February 1, 2024 to delete and replace the fees set forth under article V. Fees which will continue through January 31, 2026.

The Plan was amended, effective February 1, 2024 to delete and replace the Medical Schedule of Benefits – Gold Plan with a new Exhibit A indicating the revised schedule of benefits. The Plan was also amended effective February 1, 2024 to delete and replace the Appointment of Authorized Representative subsection under Claims Procedures with a revised claim procedure.

The Administrative Services Agreement was amended, effective February 1, 2023, to extend the term of the agreement through and including January 31, 2024 as found in Article II Termination. The amendment also made changes to Article III Meritain’s Responsibilities; Article V Fees; Article VII Miscellaneous with such changes outlined in detail within the amendment.

The Plan sponsor approved the above amendments, and their opinion is that the amendments do not materially, negatively affect the operations of the Plan as it was designed. Please refer to the amendments for more details. Subsequent events were evaluated through November 15, 2025, which is the date the financial statements were available to be issued.
