Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Luckey Farmers, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of January 31, 2025 and 2024, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Luckey Farmers, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the years ended January 31, 2025 and 2024, stating that the certified investment information, as described in the notes to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section -

- the amounts and disclosures in the financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis of Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Luckey Farmers, Inc. 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter

As discussed in the notes to the financial statements, effective February 1, 2024, the Plan was amended to merge an existing plan into the Plan. In addition, the Plan was amended February 1, 2025, subsequent to the Plan year, to allow for another plan merger. The amendments had a significant impact to the results of the Plan's financial statements for the receipt of transferred plan assets and a reallocation of Plan investments. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Luckey Farmers, Inc. 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

NOTES TO FINANCIAL STATEMENTS

January 31, 2025 and 2024

DESCRIPTION OF PLAN

The following brief description of Luckey Farmers, Inc. 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more comprehensive description.

General

The Plan is a defined contribution retirement plan sponsored by Luckey Farmers, Inc. (the Plan Sponsor) for the benefit of its eligible employees. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan's effective date was February 1, 1991 and was most recently amended February 1, 2024. The Plan was amended in conjunction with a plan merger where Luckey Farmers, Inc. 401(k) Plan was the surviving plan. The Plan's merger resulted in a significant transfer of assets into the Plan and a reallocation of the Plan's investments. Cash due from brokers represents pending cash settlements from the Plan's reallocation of its investments at the Plan year end.

Eligibility

An employee must be at least 18 years of age and have completed six months of service (previously one year of service with at least 1,000 hours) prior to entering the Plan. Entry dates into the Plan occur on the first day of each month (previously each quarter) following the date that the eligibility requirements are satisfied.

Contributions

To participate in the Plan, an eligible employee must enter into a contribution agreement with the employer, authorizing the employer to deduct and withhold from such employee's compensation a specified amount, or percentage thereof, and to contribute such amount to the employee's account in the Plan. In accordance with Section 401(k) of the Internal Revenue Code, all amounts withheld from wages and contributed to a participant's account, up to the maximum allowed, shall be excluded from gross income of the participant for federal income tax purposes, except for amounts contributed under the Roth retirement plan option. Employer matching contributions expressed as a percent of qualified wages are as follows:

Effective February 1, 2024, the employer will make a nonelective safe harbor contribution for the Plan year to the account of each eligible participant in an amount equal to 3% of the participant's qualified wages.

All amounts contributed by the employee and the earnings thereon are immediately vested.

Investment Options

Upon enrollment in the Plan, a participant may direct employee and employer contributions to selected investments as made available and determined by the Trustees. Participants may change their investment options any time throughout the year via internet or direct phone access to the custodian. The change becomes effective the next business day.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Plan Sponsor's contribution, (b) Plan earnings, and (c) an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as provided in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Administrative Fees and Other Expenses

The Plan Sponsor absorbs a portion of trustee and administrative fees and expenses.

A participant's account shall be payable to him or her, or in the event of death to a beneficiary, upon the earlier of disability, termination of employment or retirement date. Participants may elect to receive a lump sum distribution, receive annual installments, or roll their account into another plan. Normal retirement date is upon attainment of age 65.

Notes Receivable from Participants

Participant loans are permitted under the Plan and must be approved by the Plan administrator. A participant must repay the loan within five years, unless the loan is being used to purchase a primary residence. The maximum amount available to a participant is the lesser of 50% of his or her vested account balance (less any outstanding loans) or \$50,000 reduced by the highest outstanding loan balance in the past twelve months, even if amounts have been repaid. One loan per participant is allowed at any one time, with a few noted exceptions, with \$1,000 being the minimum amount available for each loan. The loans are secured by the balance in the participant's account and bear interest at local prevailing rates as determined by the Plan administrator.

Forfeited Accounts

Forfeitures of participant's non-vested accounts may be used to pay Plan expenses or reduce employer contributions. The Plan held \$0 and \$4,020 of accumulated forfeitures as of January 31, 2025 and 2024, respectively. Forfeitures of \$270 and \$1,000 were used to reduce plan expenses during 2025 and 2024, respectively. Forfeitures of \$23,188 and \$14,852 were used to reduce employer contributions during 2025 and 2024, respectively.

SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The financial statements were prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America and those common to employee benefit plans. Following are the significant accounting policies adopted by the Plan and used in the preparation of these financial statements:

SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - Continued

Investments

Investments are reported at fair value or its equivalent, using a practical expedient. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants on the measurement date. See "FAIR VALUE MEASUREMENTS" note for further information and disclosure related to fair value measurements. Purchases and sales of securities are recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net investment income (loss) includes the Plan's gains and losses on investments bought and sold as well as those investments held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income (\$6,823 and \$7,891 for the years ended January 31, 2025 and 2024, respectively) is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of January 31, 2025 and 2024. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Contributions

Contributions are recorded as earned on the accrual basis when withheld from the participant's earnings.

Risks and Uncertainties

The Plan provides for various investment options in certain pooled separate accounts. The underlying investment securities are exposed to various risks, such as interest rate and market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits and the statement of changes in net assets available for benefits.

Use of Estimates

The preparation of the financial statements in conformity with generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Although these estimates are based on the Plan administrator's knowledge of current events and actions it may undertake in the future, they may ultimately differ from actual results.

PLAN TERMINATION

Although it has not expressed any intent to do so, Luckey Farmers, Inc. has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their entire account.

REPORTABLE TRANSACTIONS

The Plan's assets are participant-directed, and thus, the schedule of reportable transactions is not required.

INCOME TAX STATUS

Luckey Farmers, Inc. 401(k) Plan became effective February 1, 1991. The Plan Sponsor adopted a prototype plan on which an opinion letter relating only to the acceptability of the form of the Plan was obtained on March 31, 2008; however, a determination letter from the Internal Revenue Service has not been requested specifically for the Plan. Even though there have been amendments to the Plan in order to comply with changes in rules and regulations over the years, the Plan administrator and trustees are not aware of any provision, action or event that has occurred that might affect the Plan's qualified status.

The Plan complies with Accounting Standards Codification (ASC) 740-10 related to uncertain tax positions. This standard prescribes a recognition threshold and a measurement attribute for financial statement recognition and measurement of a tax position taken or expected to be taken on a tax return. The Plan administrator is not aware of any tax positions taken by the Plan that they consider to be uncertain. Tax returns for the years ended 2022, 2023 and 2024 are still open and subject to examination by the Internal Revenue Service and Department of Labor.

PARTY-IN-INTEREST TRANSACTIONS

Pooled separate accounts and the common collective trust include shares of mutual funds, fixed income securities, or units of the general portfolio of the custodian of the Plan. The Standard serves as the custodian of the Plan's assets as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee received compensation from the Plan. Certain administrative expenses of the Plan are paid directly by the Plan Sponsor and are not charged to the Plan.

BHM CPA Group, Inc. serves as the Plan's auditors and qualifies as a party-in-interest.

FAIR VALUE MEASUREMENTS

The Plan complies with ASC 820 *Fair Value Measurements and Disclosures* to account for and report fair value. ASC 820 provides a single definition of fair value, a framework for measuring fair value and expanded disclosures concerning fair value. It also defines fair value as the price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date.

Fair value of certain assets and liabilities are determined based on the fair value hierarchy established in the standard, which requires an entity to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. Observable inputs are inputs that reflect the assumptions market participants would use in pricing the asset or liability developed based on the best information available in the circumstances.

The standard describes three levels within its hierarchy that may be used to measure fair value which are:

Level 1

Values are based on unadjusted quoted prices in active markets for identical assets or liabilities.

Level 2

Values are based on quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.

Level 3

Values are generated from unobservable inputs that are supported by little or no market activity and that are a significant component of the fair value of the assets or liabilities. These unobservable inputs would reflect management's estimates of assumptions that market participants would use in pricing related assets or liabilities. Valuation techniques might include the use of pricing models, discounted cash flow models or similar techniques.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

A financial asset or liability's classification within the hierarchy is determined based on the lowest level input that is significant to the fair value measurement. The assessment of the significance of a particular input to the fair value measurement requires judgment and may affect the classification of fair value assets and liabilities within the fair value hierarchy levels. Following is a description of the valuation methodologies used for assets measured at fair value.

Pooled separate accounts

Investments in pooled separate accounts are valued using the unadjusted net asset value (NAV) as of the reporting date, which is the basis for current transactions. The NAV is used as a practical expedient to estimate fair value. Pooled separate accounts are valued based on the underlying investments (i.e., common stock, mutual funds, and short-term securities) in the separate account as reported by The Standard Insurance Company. While the majority of the underlying asset values are based on quoted prices, NAV of the pooled separate accounts are not publicly quoted. The NAV is reported as of the financial statement date based on recent transaction prices. The pooled separate accounts held by the Plan provide for daily redemptions by the Plan at reported NAV with no advance notice requirement.

Common collective trust

The common collective trust is valued at the NAV of the trust's units. The NAV, as provided by The Standard Insurance Company, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund, less its liabilities. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of its holdings in the trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that the securities liquidation will be carried out in an orderly business manner. The common collective trust has a daily redemption frequency, a redemption notice period of one year and no unfunded commitments.

Life insurance policies

The life insurance policies are not actively traded, and significant other observable inputs are not available. The policies are stated at cash surrender value, the amount that would be received upon termination of the policy. As a result, they are classified as Level 3.
