INDEPENDENT AUDITORS' REPORT

To the Trustees of and Participants in the

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Southlake Orthopaedics Sports Medicine & Spine Center, P.C. 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of January 16, 2025, December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the period January 1, 2025 to January 16, 2025 and the year ended December 31, 2024, and the related notes to the financial statements.

Basis for Opinion

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings and certain internal control related matters that we identified during the audits.

Other Matter

Supplemental Schedules Required by ERISA

The supplemental schedule of delinquent participant contributions for the year ended December 31, 2024, and schedule of assets (held at end of year) as of December 31, 2024, are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

1. DESCRIPTION OF THE PLAN

The following description of the Southlake Orthopaedics Sports Medicine & Spine Center, P.C. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

During the year ended December 31, 2024, the trustees elected to merge the Plan into the Southern Orthopaedic Alliance 401(k) Retirement Plan (SOA Plan). All eligible employees of the Plan became eligible to participate in the SOA Plan effective January 1, 2024, therefore no contributions were made to the Plan in 2024 or during the period January 1, 2025 to January 16, 2025. Plan investments were transferred to the new custodian in 2025.

The following provisions are relative to the Plan prior to the Plan merger.

General

The Plan is a defined contribution plan covering all of the employees of Southlake Orthopaedics Sports Medicine & Spine Center, P.C. (the Company or the Sponsor) who have at least one year of service and are age 21, with the exception of leased employees. Each employee becomes a participant on the first day of the calendar quarter coinciding with or next following the date they meet the eligibility requirements. The Plan is subject to the provision of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The trustees are various members of management and are responsible for oversight of the Plan, determining the appropriateness of the Plan's investment offerings and monitoring investment performance.

Administration

The Plan's administrator is the Company. Delaware Charter Guarantee and Trust Company (doing business as Principal Trust Company) (Principal) has been appointed as the custodian of the Plan's assets with the exception of the pooled separate accounts which are held by Principal Life Insurance Company (PLIC).

Contributions

Each year, participants may contribute a portion of their annual compensation as pretax or Roth after-tax contributions, as defined in the Plan document. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions, subject to certain limitations under the Internal Revenue Code (IRC). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan requires the Sponsor to make a safe harbor contribution equal to 3% of the participant's eligible compensation as defined in the Plan document. In addition, the Sponsor may make a discretionary profit-sharing contribution to the Plan. In order to receive an allocation of the profit-sharing contribution, participants must complete one year of service and be employed at the end of the year. All contributions during a Plan year are subject to maximum dollar limitations established by the IRC.

Participant Accounts

Each participant account is credited with the participant's contributions, the Sponsor's safe harbor and profit-sharing contributions, and an allocation of net Plan investment earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from a participant's vested balance.

Vesting

Participants are immediately vested in their contributions and the Sponsor's safe harbor contributions plus actual earnings thereon. Vesting in the Sponsor's discretionary profit-sharing contributions portion of their accounts is based on the following schedule:

Payment of Benefits

Upon termination of service, as defined, or upon attaining age 55 with seven years of service, while still employed (in-service), a participant may elect to distribute an amount equal to the value of the participant's vested interest in their account as a lump-sum payment or rollover payment into another qualified plan or account.

A participant may also withdraw money from their account in the event of financial hardship. Hardship withdrawals may not exceed the amount of the participant's cumulative deferrals.

A participant with an account balance of less than \$5,000 must take a lump-sum payment as soon as practicable following termination.

Forfeitures

The unvested portion of discretionary profit-sharing contributions in a terminated participant's account may be subject to forfeiture. Any accumulated benefits forfeited during a Plan year due to a participant's withdrawal prior to full vesting will be used to reduce future Plan Sponsor contributions or to pay Plan expenses, as specified by the Plan. As of January 1, 2025, December 31, 2024 and 2023, there were forfeited account balances of \$0, \$7,909 and \$12,419, respectively. For the period January 1, 2025 to January 16, 2025 and the year ended December 31, 2024, \$5,797 and \$17,045 of forfeited accounts were used to pay administrative expenses, respectively.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan provides for investment options in a variety of investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, market volatility and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

Investment Valuation and Income Recognition

Investments are reported at fair value, with the exception of the fully benefit-responsive investment contract which is valued at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for the valuation methodologies of the Plan's investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Substantially all administrative expenses of the Plan are incurred and paid by the Sponsor. Fees related to the recordkeeping transactions and investment advisor fees are paid by the Plan and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments. The Sponsor, on behalf of the Plan, paid all other administrative expenses of the Plan, and those expenses are excluded from these financial statements.

3. ANNUITY CONTRACT

The Plan holds investments in the Principal Fixed Income Guaranteed Option (Fixed Option) which is a guaranteed general-account backed group annuity contract issued by PLIC. Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement attribute for the portion of net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made, plus interest at the contract rate, less funds used to pay participants' benefits. The Fixed Option held by the Plan is fully benefit-responsive; therefore, contract value reporting is required.

The Fixed Option is part of the general account of PLIC and is guaranteed against loss of principal and accumulated interest. The Fixed Option does not permit PLIC to terminate the agreement prior to the scheduled maturity date. Interest is credited daily at an interest rate that will not be less than the minimum rate, per the contract specifications.

The crediting interest rates are announced semiannually and are guaranteed for a six-month period. The guarantees are based on PLIC's ability to meet its financial obligations from the general assets of PLIC.

4. INFORMATION CERTIFIED BY PLAN CUSTODIANS

Certain information related to the pooled separate accounts disclosed in the accompanying financial statements, including net appreciation in fair value of investments totaling \$28,944 for the period January 1, 2025 to January 16, 2025, was obtained by management and agreed to or derived from information certified as complete and accurate by PLIC and furnished to the Plan administrator.

Certain information related to investments disclosed in the accompanying financial statements and the ERISA-required supplemental schedules, including investments held as of December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividend income for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal and PLIC and furnished to the Plan administrator.

5. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB), Accounting Standards Codification (ASC) 820, *Fair Value Measurements*, are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual funds: Mutual funds are publicly traded investments and are valued daily at the closing price reported on the active market on which the funds are traded.

Pooled separate accounts (PSAs): Pooled separate accounts are valued at the net asset value (NAV) as provided by PLIC. The NAV is based on the fair value of the underlying investments held by the pooled separate account less its liabilities. There were no unfunded commitments or redemption restrictions related to the PSAs.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while Plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different estimate of fair value at the reporting date.

6. PARTY-IN-INTEREST TRANSACTIONS

The Plan invests in the fixed income guaranteed option and units of pooled separate accounts managed by PLIC; therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to PLIC and the third-party administrator for administrative and investment advisory fees for the period January 1, 2025 to January 16, 2025 and the year ended December 31, 2024, are included in administrative expenses in the statements of changes in net assets available for benefits.

7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Company discretionary profit-sharing contributions, if any.

8. TAX STATUS

Effective January 1, 2022, the Company adopted a non-standardized profit-sharing plan document sponsored by CCH Incorporated, which received an opinion letter from the IRS dated June 30, 2020, indicating that the prototype plan and trust are designed in accordance with the applicable sections of the IRC. The Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and therefore

believes that the Plan is tax-exempt as of the financial statement date. Accordingly, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. DELINQUENT PARTICIPANT CONTRIBUTIONS

During the Plan years ended December 31, 2020 and 2019, certain participant contributions totaling \$5,907 and \$5,382, respectively, were not remitted within the appropriate time period by the Sponsor. These contributions were fully corrected during 2024.

10. SUBSEQUENT EVENTS

Management has evaluated subsequent events through November 17, 2025, which is the date the financial statements were available to be issued, and has determined there are no subsequent events which require disclosure under FASB ASC Topic 855, *Subsequent Events*.



