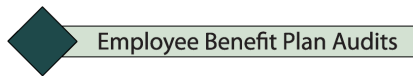

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Romex Pest Control 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Romex Pest Control 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

## Notes to Financial Statements

December 31, 2024

### **1. Description of the Plan**

The following brief description of the Romex Pest Control 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan agreement for complete information. The Plan is a defined contribution 401(k) plan covering substantially all employees of Romex Pest Control, LLC (the “Company”). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and qualifies under Section 401(a) of the Internal Revenue Code (“IRC”). The trustee is Reliance Trust Company (“Reliance”).

#### **SECURE 2.0**

An expansion of Setting Every Community Up for Retirement Enhancement Act of 2019 (“SECURE 2.0”) was signed into law on December 29, 2022, as part of the Consolidated Appropriations Act of 2023. The effective dates of provisions within SECURE 2.0 vary through 2026. The Company has until December 31, 2026 to amend the Plan for the changes related to SECURE 2.0. The Plan has not been formally amended to adopt these provisions as of the date the financial statements were available to be issued.

#### **Eligibility**

Employees are eligible to participate in the Plan upon attainment of age 18 and completion of two months of service. Eligible employees may enroll on the 1<sup>st</sup> day of each month. Non-resident aliens and residents of Puerto Rico are not eligible to participate. Eligible employees are automatically enrolled in the Plan with a deferral percentage of 2% as soon as administratively feasible, unless the employee completes an enrollment form with specific instructions or elects to opt out of the Plan.

#### **Contributions**

Participants may contribute a percentage of their eligible compensation on a pre-tax and after tax (“Roth”) basis not to exceed the annual limit established by the IRC. A participant’s pre-tax and Roth deferrals will be separately accounted for, as will gains and losses attributable to each. Participants who have attained age fifty before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

# Romex Pest Control 401(k) Plan

## Notes to Financial Statements (continued)

### 1. Description of the Plan (continued)

The Company may make discretionary employer matching contributions. For the year ended December 31, 2024, the Company elected to make a matching contribution of 100% of participant contributions up to 3% of compensation not to exceed \$1,500.

Participants direct the investment of the contributions into various investment options offered by the Plan.

### Participant Accounts

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contribution, the Company's contribution and Plan earnings and losses, and is charged with withdrawals and applicable administrative expenses. Plan earnings are allocated based on the participant's share of the net earnings or losses of their respective elected investment options. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

### Vesting

Participants are immediately vested in their contributions and rollover contributions plus actual earnings thereon. Vesting in the discretionary employer matching contributions is according to the following schedule:

### Payment of Benefits

Vested benefits are paid to participants upon death, disability, retirement or termination of employment by either arranging for a rollover to another plan, lump sum payment or installment payment. For terminated participants' account balances that are less than \$5,000, the plan administrator may distribute the entire amount in a lump sum without the participant's consent. If the participant's vested portion is greater than \$5,000, the participant may elect to maintain the vested portion in the Plan.

### Notes to Financial Statements (continued)

#### **1. Description of the Plan (continued)**

##### **Forfeitures**

Forfeitures by participants of unvested Company contributions are used to reduce future employer contributions, reduce Plan administrative expenses, or can be allocated to remaining participants. There were no forfeitures used by the Plan during 2024. As of December 31, 2024 and 2023, forfeited unvested account balances totaled \$7,597 and \$0, respectively.

##### **Notes Receivable from Participants**

Participants are permitted to borrow a maximum amount of the lesser of \$50,000 or 50% of their vested account balance. The minimum that can be borrowed is \$500 and only one loan can be outstanding at a time. Notes receivable from participants are secured by the balance in the participant's account and bear interest at a reasonable interest rate at the prime rate plus 2%. Notes receivable from participants terms range from one to five years or a reasonable amount of time for the purchase of a principal residence. Principal and interest is paid through payroll deductions with equal installments made each pay period.

##### **Administrative Expenses**

All reasonable expenses related to Plan administration will be paid by the Company.

##### **Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts and distributions will be made as soon as administratively practicable after the Plan terminates.

#### **2. Summary of Significant Accounting Policies**

##### **Basis of Accounting**

The Plan's financial statements are reported on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States. Benefits are recorded when paid to participants.

### Notes to Financial Statements (continued)

#### **2. Summary of Significant Accounting Policies (continued)**

##### **Contributions and contributions receivable**

Contributions from the employer and the participants are due to the Plan in the period the contributions are earned and deducted from the paycheck. Contributions receivables are contributions earned or withheld as of December 31 which were transferred to the Plan subsequent to year end.

##### **Risks and Uncertainties**

The Plan holds various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits and participant account balances.

##### **Accounting Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect certain amounts reported in the financial statements and the accompanying notes and schedules. Accordingly, actual results could differ from these estimates.

##### **Valuation of Investments and Income Recognition**

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note 4 for further discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### **Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the plan document.

### Notes to Financial Statements (continued)

#### 3. Investments

All investment information disclosed in the accompanying financial statements, notes and schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends and interest income from notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Reliance, the trustee.

#### 4. Fair Value Measurements

Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1—Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2—Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liabilities;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability

Level 3—Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liabilities fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

### Notes to Financial Statements (continued)

#### 4. Fair Value Measurements (continued)

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. Common collective trusts are valued at the NAV of units of a bank collective trust. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. These securities are redeemable at fair value on a daily basis. There are no unfunded commitments as of December 31, 2024.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumption to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. The following table represents the Plan's fair value hierarchy for its financial assets measured at fair value on a recurring basis as of December 31, 2024 and 2023:

#### **5. Party-in-Interest Transactions**

Plan investments are managed by Reliance, the trustee. Transactions such as these qualify as party-in-interest transactions. These transactions are exempt from the prohibited transaction rules.

#### **6. Income Tax Status**

The underlying non-standardized prototype plan has received an opinion letter from the Internal Revenue Service (“IRS”) dated October 6, 2020, stating that the form of the plan is qualified under Section 401(a) of the IRC, and therefore, the related trust is tax exempt. The plan administrator has determined that it is eligible to and has chosen to rely on the current IRS prototype plan opinion letter. Subsequent to receiving the IRS opinion letter, the Plan was amended. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan, as amended, is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **7. Delinquent Participant Contributions**

During the year ended December 31, 2024, the Company inadvertently failed to deposit \$14,754 of participant contributions within the required timeframe prescribed by the Department of Labor Regulation 29 CFR 2510.3-102. The delayed contributions are considered prohibited, or nonexempt, transactions. The Plan administrator is in the process of taking corrective action, including payment of lost interest and related taxes and penalties.

#### **8. Subsequent Events**

The Plan has evaluated subsequent events through November 11, 2025, the date the financial statements were available to be issued. Effective January 1, 2025, the trustee changed from Reliance to ADP Retirement Trust Services, LLC (“ADP Trust”).

This letter serves as our reasonable cause statement for the late filing of the Form 5500 for Romex Pest Control LLC's employee benefit plan for the plan year ending 2024.

The delay in filing occurred during a period of internal transition. At the time, we were undergoing a financial audit while also switching to a new payroll provider. These simultaneous changes temporarily disrupted our standard reporting and data verification processes. As a result, the Form 5500 was initially submitted one day before the deadline; however, a schema error led to its rejection, and the filing was ultimately not completed by the deadline.

As soon as we became aware of the oversight, we acted promptly to gather the required information, coordinate with our plan administrator, and complete the filing. The late filing was unintentional and not due to willful neglect.

To prevent future delays, we have strengthened our internal controls by assigning clear responsibility for all compliance filings, enhancing communication between finance, and our HR administrator, and creating a formal compliance calendar to track all benefit plan due dates.

We respectfully request that the Department of Labor consider this explanation as reasonable cause for the late filing and that any associated penalties be waived or reduced accordingly.
