## Notes to the Financial Statements

Years Ended February 28, 2025 and February 29, 2024

---

### 1. Description of Plan

The following description of the Ozark Opportunities, Inc. 403(b) Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General:** The Plan is a 403(b) plan covering substantially all employees of Ozark Opportunities, Inc. (the plan sponsor). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Employees are eligible to begin making elective deferrals to the plan upon hire. Employees are eligible to receive an employer contribution on the first of the month following their completion of three months of service. Prior to October 2023, the service requirement was one month of service.

Effective October 27, 2023 all plan assets were transferred from Mutual of America to American Limited Life Insurance Company (AUL).

**Contributions:** Participants may contribute up to 100% of their annual wages, subject to certain IRS limitations, through pre-tax contributions or after-tax Roth contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The plan sponsor may make a discretionary matching contribution to the Plan, allocated to each participant as a percentage of participant deferrals. The plan sponsor did not make discretionary matching contributions to the Plan during 2025 or 2024. The plan sponsor may make discretionary nonelective contributions equal to a percentage of the participant's eligible compensation. For the years ended February 28, 2025 and February 29, 2024, the plan sponsor made nonelective contributions of 5% of eligible participant compensation totaling \$142,432 and \$141,278, respectively.

**Participant accounts:** Each participant's account is credited with (a) the participant's contribution, (b) the plan sponsor's discretionary nonelective and matching contributions (if any) and (c) Plan earnings. Net income and asset revaluations are allocated to each participant based upon the earnings of the investments selected by the participant. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting:** Participants are immediately 100% vested in their voluntary contributions plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of credited service. A participant becomes 25% vested after 2 years of service and 100% vested after 3 years of service.

**Payment of benefits:** A distribution of a participant's vested account balance can be made due to hardship, attainment of age 59 ½, death, disability, retirement, qualified military service, when required by law, or upon termination of service with the plan sponsor. A distribution of a participant's rollover balance can be made at any time, regardless of the limitations described below.

Participants who terminate service and have account balances of \$7,000 or less will receive an automatic distribution of that balance. Participants with account balances that exceed \$7,000 may elect

to receive a lump-sum amount equal to the value of the vested interest in their account or installments for a fixed period not to exceed their assumed life expectancy.

**Forfeitures:** Forfeitures of employer contributions can be used to pay plan expenses or reduce future employer contributions to the Plan. As of February 28, 2025 and February 29, 2024, forfeitures available totaled \$42,319 and \$18,449, respectively. During 2024, available forfeitures were used to reduce employer nonelective contributions by \$7,858. In addition, Plan expenses of \$1,250 and \$524 during 2025 and 2024, respectively, were paid using available forfeitures.

## 2. Summary of Accounting Policies

**Basis of accounting:** The financial statements of the Plan are prepared on the accrual basis of accounting.

**Estimates:** The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment valuation and income recognition:** Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 9 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of benefits:** Benefits are recorded when paid.

**Expenses:** Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments.

**Subsequent events:** Management has evaluated subsequent events between the end of the most recent fiscal year end and November 14, 2025, the date the financial statements were available to be issued.

## 3. Plan Termination

Although it has not expressed any intent to do so, the plan sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 % vested in their account balances.

### 4. Certified Information

Certain information in the accompanying financial statements and ERISA required supplemental schedule, including investments from participants held at February 28, 2025 and February 29, 2024, and net appreciation in fair value of investments, interest and dividends for the years ended February 28, 2025 and February 29, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by the plan asset custodians, Mutual of America Life Insurance Company (for the period March 1, 2023 to October 26, 2023) and American United Life Insurance Company (for the period October 27, 2023 to February 28, 2025).

### 5. Separated Participants

At February 28, 2025, \$6,086 of the net assets available for benefits were for those participants who have separated from active service with the Company with a balance of less than \$7,000, and are due a distribution in accordance with the plan document.

### 6. Related-Party Transactions and Party In Interest Transactions

Substantially all of the administrative costs of the Plan are paid by the plan sponsor. Certain employees serve as the Plan's administrators. The administrators do not receive any compensation for services rendered to the Plan.

The Plan holds investments in funds managed by the Plan's asset custodian, AUL. Investments in these funds totaled \$2,032,992 and \$2,052,792 at February 28, 2025 and February 29, 2024, respectively.

### 7. Tax Status

The prototype document adopted by the Plan, obtained its opinion letter on November 22, 2017, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since receiving the opinion letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of February 28, 2025 and February 29, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. A tax liability would be recognized if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

## 9. Fair Value Measurement

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 – inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets
- quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability
- and inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at February 28, 2025 and 2024.

**Group annuity contract separate account investments:** Valued at the net asset value of the units held by the group annuity contract provider using the quoted net asset value of the shares of the underlying mutual funds adjusted for any dividends or distributions received by AUL and the daily equivalent of any fee charged pursuant to the contract. Mutual funds are registered with the Securities and Exchange Commission and are carried at the net asset value at which the mutual fund shares are actively traded.

**Stable value account:** Group fixed annuity supported by underlying AUL general account assets. The unit value equals its previous daily unit value multiplied by 1 plus the daily equivalent of the guaranteed annual effective rate of interest credited daily as determined by AUL at the beginning of the year.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
