Note 1. Description of the Plan

The following description of the Womble Bond Dickinson (US) LLP Savings and Self Employed Retirement Plan A (the “Plan” or “Plan A”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan which covers certain eligible employees and equity partners of Womble Bond Dickinson (US) LLP (the “Firm” or “Plan Sponsor”). Employees with a social security number ending with an even number (the “Non-Partner Participants”), participants who are equity partners (the “Partner Participants”) and the Chief Operating Officer of the Firm participate in Plan A for purposes of making salary reduction contributions and receiving Firm matching (if eligible) and profit-sharing contributions. Firm profit-sharing contributions on behalf of the Partner Participants and the Chief Operating Officer of the Firm are allocated to Plan A at 50% and 50% are allocated to the Womble Bond Dickinson (US) LLP Savings and Self Employed Retirement Plan B (“Plan B”).

Until December 31, 2024, the assets of Plan A and Plan B were combined in the Womble Bond Dickinson (US) LLP Savings and Self Employed Retirement Plan Master Trust (the “Master Trust”). The Master Trust was terminated effective December 31, 2024. The value of the Plan’s interest in the Master Trust is based on the beginning of year value of the Plan’s interest in the Master Trust, plus the value of the participants’ accounts that were transferred from Plan B, plus actual contributions and allocated investment income (losses), less actual distributions and allocated administrative expenses. At December 31, 2023, the Plan’s interest in the net amounts of the Master Trust was approximately 66%. Investment income (losses) and administrative expenses relating to the Master Trust are allocated to the individual plans based upon participant balances in each plan. See Note 3 for a summary of net assets and net investment gain of the Master Trust.

Eligible employees enter the Plan and become a participant as of the eligible employee’s date of hire. Employees are eligible to receive matching and profit-sharing contributions after one year of service. The Retirement Plan Committee of the Firm controls and manages the operation and administration of the Plan. Vanguard Fiduciary Trust Company (“Vanguard”) serves as trustee of the Plan (“trustee”). On December 22, 2024, the Plan initiated a transfer of the Plan’s assets, including notes receivable from participants, from Vanguard to Charles Schwab Trust Bank. As of December 31, 2024, the asset transfer was pending, therefore, the Plan recorded a due from broker in the amount of \$400,749,581. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions

Each year, participants may elect to contribute from 2% to 75% of pretax annual compensation, as defined in the plan document, subject to Internal Revenue Code (“IRC”) limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also make Roth after-tax contributions and may contribute amounts representing distributions from other qualified defined benefit and defined contribution plans. The Firm matches 25% of the first 4% of base compensation that a participating employee contributes to the Plan. Partner Participants are not entitled to receive matching contributions under the Plan.

Additionally, the Firm makes a profit-sharing contribution to the Plan from current or accumulated net profits. For participants hired prior to October 1, 2009 (other than Partner Participants and those classified as Associates hired prior to October 1, 2005), the profit-sharing contributions are calculated as 5% of qualified wages below the maximum social security wage base, plus 10% of wages in excess of the social security wage base. For participants hired after September 30, 2009 (other than Partner Participants), profit-sharing contributions are calculated as 5% of total qualified wages. Associates hired on or after October 1, 2005 are not entitled to profit-sharing contributions.

Profit-sharing contributions for Partner Participants and the Chief Operating Officer of the Firm are determined under a separate allocation formula defined in the plan document. Contributions are subject to certain limitations.

Investment Options

Participants direct the investment of their accounts into various investment options. The Plan currently offers various mutual funds and common collective trusts as investment options for participants. In addition, in accordance with the Plan document, participants may utilize an individual self-directed brokerage option to invest in a variety of securities including stocks, bonds, mutual funds, certificates of deposit, money market funds, other debt instruments, and cash and cash equivalents.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of the Firm's matching and profit-sharing contributions, Plan earnings (losses) and charged with benefit payments, transaction fees related to notes receivable from participants and benefit payments, and allocations of administrative expenses. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions and the Firm's matching contributions plus actual earnings thereon. Participants become fully vested in profit-sharing contributions plus actual earnings thereon upon completion of three years of service, attainment of normal retirement age, disability, death while in service, or termination of the Plan by the Firm, whichever occurs first.

Notes Receivable from Participants

Participants may borrow from their account balances a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined by the plan administrator. At December 31, 2024, outstanding notes bore interest rates ranging from 3.50% to 9.50%. Principal and interest are paid ratably over a period not to exceed five years.

Payment of Benefits

Upon termination of service due to death, disability or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount or various installment options as provided by the Plan. Prior to termination of service, amounts contributed on a before-tax basis may only be withdrawn upon demonstration of financial hardship or after the participant reaches the age of 59½ years.

Forfeitures

Forfeited non-vested accounts can be used to reduce future employer contributions or to pay Plan administrative expenses. There were no significant unused forfeited non-vested accounts at December 31, 2024 and 2023. During the year ended December 31, 2024, \$217,457 of forfeitures were used to offset Employer contributions or reduce Plan expenses.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The Plan prepares its financial statements on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (“GAAP”).

Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect certain reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. The fair value of the Plan’s interest in the Master Trust has been determined based on the Plan’s interest in the net assets of the Master Trust reflecting all of its investments at fair value. Fair value as defined under GAAP is an exit price, representing the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities held by the Master Trust are recorded on a trade-date basis. Interest income from notes receivable from participants is recorded when received. Other interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net investment gain from the Master Trust includes the Plan’s interest in the Master Trust’s gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant notes are reclassified as distributions based upon the terms of the plan document.

Payments of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

The Plan’s administrative expenses are paid by either the Plan or the Firm, as determined by the Firm. Certain administrative functions are performed by employees of the Firm. No such employee receives compensation from the Plan. Expenses paid by the Plan which relate to specific participant transactions (notes receivable from participants, distributions, and expenses related to individual directed accounts) are charged directly to the participant’s account.

Subsequent Events

The Firm has evaluated the effects subsequent events would have on the financial statements through November 17, 2025, which is the date the financial statements were available to be issued. See Note 10.

As a result of the Master Trust termination on December 31, 2024, there were no net assets of the Master Trust as of December 31, 2024. The Plan's interest in net investment gain of the Master Trust for the year ended December 31, 2024 amounted to \$47,087,433. At December 31, 2023, the Plan's sole investment was its interest in the Master Trust.

Note 4. Fair Value Measurements

Fair value as defined under GAAP is an exit price, representing the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

GAAP establishes a three-tier fair value hierarchy, which prioritizes the inputs used in measuring fair value. These tiers include:

- Level 1** Observable inputs such as quoted prices in active markets.
- Level 2** Inputs other than quoted prices in active markets that are either directly or indirectly observable.
- Level 3** Unobservable inputs about which little or no market data exists, therefore requiring an entity to develop its own assumptions

Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement requires judgment, and may affect the valuation of assets and liabilities and their placement within the fair value hierarchy levels.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

When quoted prices are available in active markets for identical instruments, investment securities are classified within Level 1 of the fair value hierarchy. Level 1 investments include mutual funds, exchange traded funds, common and preferred stocks, other debt instruments, and cash and cash equivalents.

Level 2 investment securities include common stocks and corporate bonds, which are valued based on yields currently available on comparable securities of issuers with similar credit ratings.

The common collective trust funds are valued based upon the net asset value of the underlying investments. These investments are not required to be classified within a level on the fair value hierarchy.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

As of December 31, 2024, there were no Master Trust assets that were required to be presented within a level on the fair value hierarchy. Note 6. Exempt Party-in-Interest Transactions

Certain Master Trust investments are common collective trusts managed by Vanguard. Vanguard is the trustee as defined by the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions. Certain fees paid by the Plan for investment management services were included as a reduction of the return on the related investments. Other administrative and transaction fees paid to Vanguard and its affiliates amounted to \$146,100 for the year ended December 31, 2024.

Note 7. Plan Termination

The Firm has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 8. Tax Status

The Internal Revenue Service has determined and informed the Firm by letter dated February 24, 2017, that the Plan and related trust are designed in accordance with the applicable sections of the IRC. The Plan has been amended since receiving the determination letter. However, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC. Therefore, the plan administrator believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9. Contingencies and Uncertainties

The Master Trust invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 10. Subsequent Events

Subsequent to December 31, 2024, the Plan Administrator resolved to merge Plan B into Plan A effective January 1, 2025. The Plan Administrator amended and restated Plan A effective as of January 1, 2025 to be known as the Womble Bond Dickinson (US) LLP 401(k) and Profit Sharing Plan and to merge and continue the WBD Plan B with the restated Plan A.
