NOTES TO FINANCIAL STATEMENTS

Year Ended December 31, 2024

1 DESCRIPTION OF PLAN

The following description of the Golden Route Operations, LLC 401(k) Savings Plan (the Plan), provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

GENERAL -- The Plan is a defined contribution plan of Golden Route Operations, LLC (the Company). The Plan was established in January 2024 from a spin-off due to the Company's partial stock acquisition of Golden Entertainment, Inc. The Plan covers employees who are at least 21 years of age and have at least one month of service. Entry dates are the first of any month following the date eligibility requirements are satisfied. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is governed by the Company's Board of Directors.

CONTRIBUTIONS -- Participants may elect to contribute, on a pre-tax or post-tax basis, up to the I.R.C. 402(g) limit (\$23,000 for the year ended December 31, 2024) of covered compensation. Participants age 50 or over may elect to make a catch-up contribution, on a pre-tax or post-tax basis, up to the I.R.C. 414(v) limit (\$7,500 for the year ended December 31, 2024) of covered compensation. Participants direct their contributions into various investment options offered by the Plan. Contributions made on a pre-tax or post-tax basis are subject to certain maximum limitations as defined by the IRS.

Participants may elect to have all or any portion of his or her deferral contributions and catch-up contributions treated as designated Roth contributions. For the calendar year, the maximum amount of elective contributions that a participant can designate as Roth contributions equals the maximum amount of deferral contributions and catch-up contributions according to the I.R.C. limits above, reduced by the aggregate amount of the participant's deferral contributions and catch-up contributions for the calendar year that the employee does not designate as Roth contributions.

For Participants who have at least one year of service, the Company matches 25% of salary deferrals, up to the first 4% of the employee deferral, with a maximum Company match of \$1,000. All contributions are invested as directed by each individual participant. Contributions are subject to certain limitations under the Internal Revenue Service. The Company can also make a discretionary nonelective contribution to all eligible participants without regard to employee contributions. Such contributions, if any, are allocated to participants in the ratio that each participating employees' compensation bears to the total compensation of all participants. The Company did not make a discretionary contribution for 2024.

PARTICIPANT ACCOUNTS -- Each participant's account is credited with the participant's contributions, the Company's contributions, and Plan earnings which is charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

VESTING -- All participant contributions and income thereon are fully vested at all times. Vesting of any amounts related to Employer contributions is based on years of service. A participant is 20% vested after one year, 40% vested after two years, 60% vested after three years, 80% vested after four years, and 100% vested after five or more years of service. Any Company discretionary contributions and income thereon vest immediately in the case of death or permanent disability.

1 DESCRIPTION OF PLAN (Continued)

NOTES RECEIVABLE FROM PARTICIPANTS -- Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms generally range from two to five years. The loans are secured by the participant's vested account balance and bear interest at the prime interest rate plus 1%, ranging from 4.25% to 9.50% at December 31, 2024. Principal and interest is paid ratably through payroll deductions. Participants are allowed one outstanding loan at a time.

PAYMENT OF BENEFITS -- On termination of service, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, substantially equal installments, or partial withdrawals of any dollar amount. An eligible rollover distribution is also permitted. If the value of a participant's account is less than \$7,000, a lump sum distribution can be made without regard to the consent of the participant as soon as administratively feasible.

The Plan also allows for in-service distributions once a participant has attained age 59 1/2.

FORFEITURES -- Forfeitures are applied to reduce the contributions of the Employer. At December 31, 2024, forfeited non-vested accounts totaled \$2,231.

TRANSFER FROM SEPARATE PLAN -- In January 2024, from the above described spin-off which established the Plan, 584 participants were transferred into the Plan. Assets totaling approximately \$2,100,000 were transferred into the Plan from the spin-off. The participant balances were immediately fully vested.

2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

BASIS OF PRESENTATION -- The accompanying financial statements of the Plan have been prepared on the accrual basis and present the net assets available for plan benefits and changes in those net assets, except for benefits, which are recorded when paid.

USE OF ESTIMATES -- The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

INVESTMENT VALUATION AND INCOME RECOGNITION -- The Plan's investments are stated at fair value, except for the fully benefit-responsive common collective trust, which are reported at contract value as described below. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investment contracts with an insurance company held by a defined contribution plan are reported at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive common collective trusts and investment contracts, because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. At December 31, 2024, the Plan invested in a common collective trust that is considered to be fully benefit-responsive, through an insurance company.

NOTES RECEIVABLE FROM PARTICIPANTS -- Notes receivable from participants are measured at their unpaid balance plus any unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and expensed when they are incurred. No allowance for credit losses had been recorded as of December 31, 2024. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

EXCESS CONTRIBUTIONS PAYABLE -- Any amounts payable to the Employer for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan may offset Employer matching contributions with any excess contributions payable subsequent to year end.

ADMINISTRATIVE EXPENSES AND PARTICIPANT TRANSACTION FEES -- Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to Plan administration are charged directly to the participant's account. Distribution and loan fees are charged to the individual participant's account incurring the distribution or loan. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

3 INFORMATION CERTIFIED BY THE TRUSTEE

The Plan has elected the method of compliance permitted by Section 2520.103-8 of the Department of Labor Rules Regulations for Reporting and Disclosure under ERISA. As permitted under such election, the Plan has obtained a certification from ADP Retirement Trust Services, LLC (the Trustee) for 2024, that certifies the completeness and accuracy of certain information which management used in preparing these financial statements. Accordingly, this information was not audited. The information certified is as follows:

4 STABLE VALUE FUND

As of January 1, 2024, the Plan entered into an Agreement of Participation with the Trustee to invest in the Reliance Trust Company Stable Value Fund Collective Investment Trust MetLife Series 25053 Class 0. The stable value fund had a balance of \$842 at December 31, 2024. Contributions to the Fund are held in a general trust account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract provides for a fixed interest rate for a fixed period that will apply to the entire guaranteed value. The interest rate is reset every quarter as determined by MetLife.

4 STABLE VALUE FUND (Continued)

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The Fund imposes certain restrictions on the Plan, and the Fund itself may be subject to circumstances that affect its ability to transact at contract value, as described in the following paragraph. The Plan Administrator does not believe that the occurrence of any such event, which would cause the fund to transact at less than contract value, is probable.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) Participants make withdrawal requests with advice or direction from the plan sponsor, plan administrator, plan fiduciary or agent of any of the foregoing to do so, (2) an investment option has been established by the participating plan or the investment objective of an existing investment option of the participating plan has been modified so as to constitute or create a competing fund, (3) The plan sponsor, plan administrator, plan fiduciary, or any agent of any of the preceding, of the participating plan establishes a new eligible plan or amends an existing eligible plan and such plan covers participants in the participating plan and offers participants a competing fund, and (4) participating plan makes a withdrawal for any reason, except for a participant-directed withdrawal.

5 FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measure the fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. No Level 2 or 3 inputs were available to the Plan.

Level 1 Fair Value Measurements - The fair value of registered investment company shares is based on unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

6 PLAN TERMINATION

The Plan was established January 1, 2024. Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to provisions of ERISA.

7 TAX STATUS

The Internal Revenue Service has determined and informed the prototype sponsor (ADP, LLC), by a letter dated December 6, 2020, that the Plan, as then designed, is in accordance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving that letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore believes that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by a plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions. However, there are currently no audits in progress for any tax periods.

8 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits and the Statement of Changes in Net Assets Available for Benefits.

9 PARTY-IN-INTEREST TRANSACTIONS

Fees incurred by the Plan for investment management services are included in net appreciation in fair of the investments, as they are paid through revenue sharing, rather than direct payment. Fees paid by the Plan to the third-party administrators for record keeping and administration fees totaled \$7,377 for 2024. The Plan also transacts with certain parties who may perform services to the Plan. Such parties qualify as parties-in-interest under ERISA.

10 SUBSEQUENT EVENTS

Subsequent events were evaluated through the date of the Independent Auditor's Report, which is the date the financial statements were available to be issued. Subsequent to 2024, a new entity, Leisure Gaming, INC will begin as a new participating employer to the Plan, effective January 1, 2025.
