### NOTE 1 - DESCRIPTION OF PLAN

The following description of the **Innomark Communications 401(k) Employee Benefit Plan** (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General** - The Plan is a defined contribution plan covering substantially all salaried and hourly wage earning employees of Innomark Communications, LLC; Concept Imaging Group, Inc; and Pakmark, LLC (collectively the Company or Plan Sponsor) as a controlled group. The Plan allows all eligible employees of the Company to participate upon the date of hire, given that they have attained age 20. Effective May 1, 2024, all eligible employees must complete 3 months of service to participate in the Plan. Collective bargaining employees are not eligible to participate in the Plan. Additionally, the Plan contains an automatic enrollment provision. Under this provision, unless notified otherwise, upon meeting the requirements for eligibility, all eligible employees are enrolled in the Plan at a deferral rate of 4%. Also, the Plan includes a provision that the participants with a deferral rate greater than zero will have their deferral rate increased annually by 1% until a deferral rate of 6% is reached. Effective May 1, 2024, this threshold was increased to 8%. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Effective July 1, 2024, the Printing Service Company 401(k) Plan merged into the Plan.

**Contributions** - The Plan provides for employee salary deferrals within statutory limits, as defined in the Plan, each year as an elective deferral. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants who have attained age 50 by the end of the Plan year are eligible to make catch-up contributions. In addition, the Plan allows Roth 401(k) contributions.

The Company's matching contribution is 25% of the first 4% of elective deferrals and 50% of the next 2% of elective deferrals that a participant contributed to the Plan. The Company also may make additional discretionary contributions to the Plan. Participants become eligible for these contributions if employed on the last day of the Plan year and upon completion of 1,000 hours of service during the Plan year. For the years 2024 and 2023, the Company did not make discretionary contributions to the Plan. No contributions shall be made on behalf of a participant to the extent that, when added to the participant's salary deferral contributions, it would cause the amounts allocated to exceed the limitations allowed by the Internal Revenue Service.

**Participant Accounts** - Lincoln Financial Group Trust Company was Custodian of Plan investments through April 30, 2024. Effective May 1, 2024, Ascensus Trust Company is Custodian of the Plan. Each participant's account is credited with the participant's contributions, Company contributions, net earnings or losses, forfeitures, distributions, and withdrawals. Company contributions are allocated based on participants' compensation as defined by the Plan Agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs both separately, and distinctly, into which investment option the participant contribution, employer match, and discretionary contribution are to be invested.

### NOTE 1 - DESCRIPTION OF PLAN - CONTINUED

**Vesting** - Participants are immediately vested in their voluntary contributions, rollovers, employer matching contributions and corresponding earnings. The following schedule will be used to determine vesting in the additional discretionary contributions and corresponding earnings:

**Notes Receivable from Participants** - Participants may borrow from the Plan in any amount between \$1,000 and \$50,000, but not more than 50% of their vested balance. The notes bear interest at an agreed-upon percentage based on prevailing market rates, subject to applicable usury limits. Loan terms are for a period not exceeding five years. A longer term may be approved by the Plan if proceeds are to be used for the purchase of a primary residence. Loans are secured by the balance in the participants' accounts. Principal and interest are paid ratably through payroll deductions. Participants may have only one loan outstanding at any given time.

**Benefits Paid** - Upon termination of service by reason of retirement, death, permanent disability, or otherwise, participants, or designated beneficiaries, may elect to receive their vested balance either in a lump-sum amount, or payments over a period of time in cash installments, or in a form agreeable to the Plan Administrator. If the participant's account balance is \$5,000 or less, the Plan Administrator may elect to automatically distribute the balance to the participant in a single-sum payment. In addition, participants may receive distributions of the employee deferral amount for qualified financial hardships. In-service distributions may only be taken from accounts which are 100% vested and after the participant has attained the Normal Retirement Age as defined by the Plan.

**Forfeitures** - Forfeited balances of terminated participants' non-vested accounts are used to reduce future Company contributions and pay Plan expenses. No forfeitures were used during 2024 and 2023. There were \$3,066 and \$0 of unallocated forfeitures at December 31, 2024 and 2023.

**Investment Options** - Upon enrollment in the Plan, a participant must currently direct contributions to one or more of the funds as determined by the Plan's investment committee, or one of the investment models using these mutual funds which are based upon the projected date of retirement and risk tolerance. In addition, participants have the option to direct contributions into a self-directed brokerage account. Participants may change their investment profile at any time via phone or the Internet. Deferral percentages can be changed at any time via the enrollment form or the Internet.

### NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting** - The financial statements of the Plan are prepared using the accrual method of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

**Financial Estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's Administrator to make estimates and assumptions that affect the reported amounts of net assets, and disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of revenue and expenses during the reporting period. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition** - Investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset, or paid to transfer a liability, in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

**Notes Receivable from Participants** - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment.

**Payment of Benefits** - Benefits are recorded when paid.

**Administrative Expenses** - The Company pays certain administrative expenses of the Plan, and the Plan participants will bear the responsibility of the remaining expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

The Plan had an ERISA Spending Account (Spending Account) that held miscellaneous amounts remitted to the Plan, which included revenue sharing earned from investments held by Lincoln. Amounts allocated to the Spending Account were to be applied to pay reasonable Plan expenses no later than the end of the Plan year following the Plan year in which the amounts were allocated to the Spending Account. Any excess amounts held in the Spending Account were to be allocated to participants in a reasonable manner. The ERISA Spending Account was terminated when Plan assets were transferred to Ascensus Trust Company effective April 30, 2024.

Revenue deposits in the Spending Account are included in other investment income and totaled \$30,062 and \$45,981 for the years 2024 and 2023. The Spending Account was used to pay \$31,679 and \$45,002 of administrative expenses of the Plan in 2024 and 2023. The balance in the Spending Account was \$1,591 at December 31, 2023.

**Subsequent Events** - In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through October 6, 2025, the date the financial statements were available to be issued.

#### NOTE 3 - CERTIFIED INVESTMENTS

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, net appreciation (depreciation) in fair value of investments, interest and dividends, and other investment income for the years 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Lincoln Financial Group Trust Company and Ascensus, LLC, as an authorized representative of Ascensus Trust Company and Newport Trust Company (the Custodians of the Plan).

#### NOTE 4 - FAIR VALUE MEASUREMENTS

Accounting standards provide a framework for measuring fair value. This framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements), and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under the accounting standards are described as follows:

**Level 1** - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs, and minimize the use of unobservable inputs.

### NOTE 4 - FAIR VALUE MEASUREMENTS - CONTINUED

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

*Mutual funds and self-directed brokerage account:* Valued at the closing price reported on the active market on which the individual securities are held.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### NOTE 5 - FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Plan has entered into a fully benefit-responsive investment contract with Lincoln Financial Group referred to as the Lincoln Stable Value Account. Lincoln Financial Group maintains the contributions in a general account. The account is credited with earnings of the underlying investments and is charged for participant withdrawals and administrative expenses. The contract is included in the statements of net assets available for benefits at its contract value.

Certain events, such as premature termination of the contract by the Plan or the termination of the Plan, would limit the Plan's ability to transact at contract value with Lincoln Financial Group. The Plan Administrator believes the occurrence of such events, which would also limit the Plan's ability to transact at contract value with Plan participants, is not probable.

#### **NOTE 6 - RELATED PARTY TRANSACTIONS**

Certain Plan assets were held and managed by Lincoln Financial Group Trust Company through April 30, 2024, and then held and managed by Ascensus Trust Company effective May 1, 2024. Thus, Lincoln Financial Group Trust Company and Ascensus Trust Company, as Custodians defined by the Plan, qualify as parties-in-interest.

Lincoln Financial Group, as third party administrator through April 30, 2024, qualifies as a party-in-interest. Fees paid by the Plan for these services amounted to \$24,329 and \$88,818 for the years 2024 and 2023.

Ascensus, LLC, as third party administrator effective May 1, 2024, qualifies as a party-in-interest. Fees paid by the Plan for these services amounted to \$17,513 for the year 2024.

Atomi Financial Group, as investment advisor for the Plan, qualifies as a party-in-interest. Investment advisory services paid by the Plan totaled \$56,038 and \$45,002 for the years 2024 and 2023

The Plan Sponsor provides certain accounting, record keeping, and administrative services to the Plan, for which it receives no compensation.

#### **NOTE 7 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan subject to the provisions of ERISA and its related regulations. In the event of Plan termination, participants will become 100% vested in the employer discretionary contributions.

#### **NOTE 8 - TAX STATUS**

The Plan adopted a Non-Standardized Pre-Approved Profit Sharing Plan with a cash or deferral arrangement which received a favorable opinion letter from the Internal Revenue Service on June 30, 2020, which stated that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan Sponsor believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. generally accepted accounting principles require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
