### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Asheville Eye Associates, PLLC 401(k) Plan, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. **Note 1. Description of Plan**

The following description of the Asheville Eye Associates, PLLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

***General***

The Plan is a defined contribution multiple employer plan sponsored by Asheville Eye Associates, PLLC (the “Company”). The Plan covers all full-time employees of the participating employers who are not leased employees. Employees who have one year of service and are age eighteen or older may participate in the Company’s profit-sharing and safe harbor contributions. The Retirement Committee of the Board of Directors of Asheville Eye Associates, PLLC controls and manages the operation and administration of the Plan. Ascensus Trust Company (“Ascensus”) is the custodian of the Plan and Ascensus, LLC is the recordkeeper. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Empower was the custodian of the fixed annuities from January 1, 2023 through January 12, 2023. The fixed annuities were converted to cash and transferred to Ascensus on January 13, 2023.

Employers participating in the Plan are Asheville Eye Associates, PLLC and WNC Eye Surgery Centers, Inc. (known collectively as “Employers”).

***Contributions***

Each year, participants may contribute compensation, as defined in the plan document, subject to certain Internal Revenue Code (“IRC”) limitations. Participant’s salary deferrals may be Traditional 401(k) (pretax) or Roth 401(k) (after tax). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Employers make safe harbor contributions of 3% of eligible participant compensation. Additional profit-sharing and/ or matching amounts may be contributed at the option of the Company’s Board of Directors. Profit-sharing contributions of 4% (1.5% for monthly employees and \$35,650 for partners) of eligible participant compensation were made on the participants’ behalf for the year ended December 31, 2024. Contributions are subject to certain limitations.

***Investment Options***

Participants direct the investment of their accounts into various investment options offered by the Plan. The Plan currently offers mutual funds and a money market fund as options.

***Participant Accounts***

Each participant’s account is credited with the participant’s contribution and allocations of the Company’s contributions, and plan earnings and charged with benefit payments, transaction fees, allocations of administrative expenses, and plan losses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Participants with individually directed accounts receive allocations of earnings and losses and expenses only from their own self-directed accounts. The benefit to which a self-directed participant is entitled is the balance of the participant’s self-directed account as of the date of the distribution.

***Vesting***

Participants are immediately vested in their contributions and the Employers’ safe harbor contributions plus actual earnings thereon. Vesting in the Employers’ matching and profit-sharing contribution portion of their accounts plus

actual earnings thereon is based on years of continuous service. A participant is 100% vested after six years of credited service.

***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at prime rate plus one percent. At December 31, 2024, outstanding loans bore interest rates ranging from 4.25% to 9.50%. Principal and interest are paid ratably through payroll deductions.

***Payment of Benefits***

On termination of service due to death, disability, retirement or other reasons, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount or various installments and annuity options as provided by the Plan. Amounts contributed on a before-tax basis may only be withdrawn upon demonstration of financial hardship, disability, or after the participants reach the age of 59.5 years.

***Forfeitures***

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$132,399 and \$112,218, respectively. These accounts will be used to pay administrative expenses and then reduce employer contributions. During 2024, forfeitures of \$4,675 were used to pay administrative expenses and \$4,347 were used to reduce employer contributions.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

***Estimates***

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect certain reported amounts, changes therein and disclosures. Accordingly, actual results may differ from those estimates and assumptions.

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the custodian. See Note 3 for discussion of fair value measurements.

Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

***Contributions***

Contributions from Plan participants and the safe harbor and profit-sharing contributions from the Employers are recorded in the year in which the employee contributions are withheld from compensation.

***Payment of Benefits***

Benefits are recorded upon distribution.

***Administrative Expenses***

The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the plan document. Certain administrative functions are performed by employees of the Company. No such employee receives compensation from the Plan. Expenses relating to specific participant transactions (notes receivable and distributions) are charged directly to the participant's account.

***Subsequent Events***

The Plan has evaluated the effects subsequent events would have on the financial statements through November 17, 2025, which is the date the financial statements were available to be issued.

**Note 3. Fair Value Measurements**

Fair value, as defined under GAAP, is an exit price representing the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. GAAP establishes a three-tier fair value hierarchy, which prioritizes the inputs used in measuring fair value. These tiers include:

- Level 1:** Observable inputs such as quoted prices in active markets.
- Level 2:** Inputs other than quoted prices in active markets that are either directly or indirectly observable.
- Level 3:** Unobservable inputs about which little or no market data exists, therefore requiring an entity to develop its own assumptions.

Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement requires judgment and may affect the valuation of fair value assets and liabilities and their placement within the fair value hierarchy levels.

There have been no changes in the methodologies used at December 31, 2024 and 2023. The following is a description of the valuation methodologies used for assets measured at fair value:

***Mutual Funds and Money Market Funds***

Mutual funds are publicly traded investments and are valued daily at the closing price reported on the active market on which the funds are traded.

***Self-directed Brokerage Accounts***

Mutual funds, stocks, and bonds are publicly traded investments and are valued daily at the closing price reported on the active market on which the funds are traded.

**Note 5. Exempt Party-in-Interest Transactions**

Certain plan investments were shares of fixed annuities managed by Empower. Empower was the custodian of the fixed annuities from January 1, 2023 through January 12, 2023. Ascensus was the custodian of the plan assets,

excluding the fixed annuities as of December 31, 2024 and 2023. Oakbridge Financial Group serves as the Plan's investment advisor. These transactions qualify as exempt party-in-interest transactions.

Certain fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund. Fees paid to Ascensus by the Plan for administrative services were \$116,721 for the year ended December 31, 2024.

**Note 6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their accounts.

**Note 7. Tax Status**

The Plan has not obtained a determination letter from the Internal Revenue Service (the "IRS") stating that the Plan was in compliance with the applicable requirement of the IRC. The Plan is relying on the IRS approval of the prototype plan that it is utilizing. The IRS has determined and informed the document sponsor by a letter dated June 30, 2020 that the prototype plan document was designed in accordance with applicable sections of the IRC. Although the Plan has been amended since recording the above mentioned letter, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the plan administrator believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 9. Non-Exempt Party-in-Interest Transaction**

There were unintentional delays by the Company in submitting participant contributions to the custodians in the amount of \$187,135 and \$107,487 for the years ended December 31, 2024 and 2023, respectively. These delinquent contributions constitute prohibited transactions and the Company has made contributions to the affected participants' accounts to compensate those participants for this amount. The Company plans to calculate and remit to the Plan lost earnings related to these contributions.
