Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of OCI Americas Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from The Standard Insurance Company, a qualified institution, as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. Note 1 – Description of Plan

The following description of the OCI Americas Savings Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more comprehensive description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible full-time and part-time employees of OCI USA Inc., OCI GP LLC, N-7 LLC, OCI NYC LLC and OCI Clean Ammonia LLC (collectively known as Company).

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company is responsible for oversight of the Plan. The Standard Insurance Company (The Standard) serves as the Plan's trustee and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Contributions

Each year, participants may contribute up to the maximum percentage allowable under the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants may direct contributions into the assets of any retirement plan maintained by the Company and which qualifies under IRC Section 401(a) and may be held as a single fund under one or more trust instruments, provided that the value of each plan's assets can be determined at any time. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation, to increase by 1% each year in the second and third years to a maximum of 5%. Their contributions are invested in a designated balance fund until changed by the participant. The Company contributes 100% of the first 6% of base compensation that a participant contributes to the Plan. The Company makes additional safe harbor contributions to the Plan in the amount of 3% of base compensation, regardless of the participant's contributions.

Under the terms of the Plan, the Company may make discretionary profit sharing contributions. Profit sharing contributions are determined by the employer and are allocated to participants on a pro rata basis. Pro rata basis is the ratio that each participant's compensation bears to the compensation of all eligible participants. Limitations on Company contributions are defined in the Plan agreement and are intended to comply with the maximum amounts allowed under Section 415 of the IRC and regulations thereunder. During the year ended December 31, 2024, the Company did not make a profit sharing contribution to the Plan.

Participant Accounts

Each participant's account is credited with the participant's contribution, Company's matching and safe harbor contributions, allocations of the Company's profit sharing contributions and Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific transactions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. The Plan allows each participant to choose their own investment mix for Company and participant contributions. Participants may change their investment elections at any time, but are restricted by two transfers in and out of an account each quarter.

Vesting

Participants are immediately 100% vested in their contributions, Company contributions, and profit sharing contributions. Effective August 29, 2024, Iowa Fertilizer Company LLC (IFCO) was sold to a third party. As a result, all employees of IFCO were terminated under the Plan. Based on DOL regulations, the Plan was considered partially terminated. The impacted participants were fully vested in their account balance prior to August 29, 2024, so there was no effect on their vesting.

Notes Receivable from Participants

Participants may borrow from their fund accounts in the event of a financial hardship or an unusual or special situation in their financial affairs. The maximum loan amount cannot exceed the lesser of \$50,000 or one-half the present value of the vested account balance of the participant, and the minimum loan amount is \$1,000. The maximum number of loans outstanding at any time is two. The loans are secured by the balance in the participant's account. Loans must be repaid over a period not extending beyond five years from the date of the loan. Payments must be made through ACH through a personal bank account unless it is a prepayment, which can be made by check. Interest is charged at a rate to be fixed by the Plan administrator when taking into consideration interest rates currently being charged on similar commercial loans by persons in the business of lending money. The Plan's loan policy outlines the interest rate will be based on the Wall Street Journal prime rate plus one percent. Currently, the loans bear interest ranging from 4.25% to 9.50%.

Payments of Benefits

Upon retirement, participants receive the amount credited to their accounts. A similar benefit is paid upon disability or death. In the event of termination of employment, participants will receive the vested balance of their account. Benefits are paid to participants or their beneficiaries in a lump sum or in installments.

Administrative Expenses

The Plan administrator, The Standard Insurance Company, may allocate none or any portion of the Plan's expenses to participant accounts. The Plan administrator may allocate such expenses using any reasonable method that does not violate title I of ERISA and does not discriminate in favor of highly compensated employees. Such methods may include, but are not limited to, allocating expenses only to current or former employees, allocating expenses directly to individual employees, allocating expenses under the per capita or pro rata method, or any combination of the above.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America require the Plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction. See Note 7 for discussion on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis and continues to accrue until delinquent participant loans are reclassified as a distribution. The Plan administrator monitors delinquent notes in order to estimate the allowance for credit losses for notes receivable. As of December 31, 2024, and 2023, the allowance for credit losses for notes receivable is zero. Delinquent participant notes are reclassified as distributions based upon the terms of the Plan agreement.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants, administration of benefits paid and custodial fees are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Note 4 – Investment Contract with Insurance Company

The Plan maintains an investment contract with The Standard Insurance Company. The Standard Insurance Company is a segregated investment account maintained by The Standard Insurance Company with respect to a portion of its assets in connection with this contract and certain other group annuity contracts.

Assets of this variable account equivalent to the reserve for this contract will be invested in shares of the specific funds elected in the contract application. The assets of the variable account will be held for the sole benefit of all contracts. All income, gains, losses, and expenses, whether or not realized from assets held in the variable account for each series, shall be credited to or charged against the variable account series without regard to the other income, gains, or losses of The Standard. Assets of the variable account may not be used by The Standard to satisfy the liabilities of its general account.

Note 5 – Related Party Transactions and Party-in-Interest Transactions

Transactions resulting in Plan assets being transferred to or used by a related party are prohibited under ERISA unless a specific exemption applies. The Standard Insurance Company, as trustee, is a party-in-interest as defined by ERISA as a result of investing Plan assets in its own funds. However, such transactions are exempt and are not prohibited by ERISA. Fees totaling \$52,642 were paid by the Plan to The Standard Insurance Company for transactional fees for the year ended December 31, 2024.

Note 6 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

Note 7 – Fair Value Measurements

Financial Accounting Standards Board's Accounting Standards Codification (Professional Standards) establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under Professional Standards are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets and liabilities in active markets
- quoted prices for identical or similar assets and liabilities in inactive markets
- inputs other than quoted prices that are observable for the asset or liability
- inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value:

Pooled Separate Accounts: The values are based on the net asset value (NAV) of the fund, where the unit value is the result of the accumulated fair values of the underlying investments. The NAV, as provided by the fund manager, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different from the NAV. Participant transactions (purchases and sales) may occur daily.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 8 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in Company contributions.

Note 9 – Tax Status

The Company adopted a new prototype plan on January 1, 2018, developed by The Standard (formerly Minnesota Life Insurance Company). Effective January 1, 2022, the Plan was restated to adopt all regulatory changes that have occurred since the last plan document was adopted. The Plan's latest prototype plan received a letter from the Internal Revenue Service as to its qualified status dated June 30, 2020. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Professional standards require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods. The Plan administrator believes the Plan has open tax years for the three years prior to December 31, 2024.

Note 10 – Subsequent Events

The Company performed an evaluation of subsequent events through November 12, 2025, which is the date the financial statements were available to be issued. In September 2024, an agreement was signed to sell OCI Clean Ammonia LLC to Woodside Energy Group Ltd. The sale will not be finalized until the construction project is completed in 2026. N-7 LLC was dissolved in February 2025. OCI GP LLC sold to Methanex Corporation in June 2025.
