- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Williamsburg Regional Hospital Employees' Pension Plan and Tax Deferred Annuity Plan (collectively the Plans)'s internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the Combining Financial Statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Williamsburg Regional Hospital Employees' Pension Plan and Tax Deferred Annuity Plan (collectively the Plans)'s ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the Combining Financial Statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the Combining Financial Statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

***Other Matter — Supplemental Schedule Required by ERISA***

The supplemental schedule of delinquent participant contributions for the year ended December 31, 2022 is presented for purposes of additional analysis and is not a required part of the combining financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the combining financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

***Emphasis-of-Matter***

As discussed in Note 1 and Note 7 to the Combining Financial Statements, the Plans were terminated effective December 31, 2022 and management determined the liquidation to be imminent. All assets were transferred out of the Plans by December 28, 2022. As discussed in Note 2 to the Combining Financial Statements, in accordance with accounting principles generally accepted in the United States of America, the Plan has changed its basis of accounting from the ongoing plan basis used in presenting the 2021 Combining Financial Statements to the liquidation basis used in presenting the 2022 Combining Financial Statements. Our opinion is not modified with respect to this matter.

**NOTE 1 DESCRIPTION OF PLANS**

The following description of the Williamsburg Regional Hospital (the Hospital) Employees' Pension Plan (the Pension Plan) and Tax Deferred Annuity Plan (the TDA Plan) provides only general information. Participants should refer to the Plans' document for a more complete description of the Plans' provisions.

During 2019, the Plan Sponsor signed an agreement with the Medical University of South Carolina to construct and operate a new hospital which would replace the Williamsburg Regional Hospital. It was determined that the Pension Plan and TDA Plan would terminate effective December 31, 2022 and contributions were ceased in October 2022. All assets were distributed by December 28, 2022. The new hospital opened in January 2023.

**The Pension Plan**

The Pension Plan was a defined contribution plan established effective October 1, 2001, that had been amended and restated throughout the years. The Pension Plan was most recently restated effective January 1, 2016, and most recently amended effective February 1, 2019. The Pension Plan covered all eligible employees of the Hospital who had completed 90 days of service and were age 18 or older. The Pension Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Hospital may have made a discretionary contribution to participants of the Pension Plan provided they had worked at least 1,000 hours during the Plan year. For the period ended December 28, 2022, the Hospital made a discretionary contribution to the Pension Plan of 1% of participants' eligible compensation. Participants may also have contributed amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Contributions were subject to certain Internal Revenue Service (IRS) limitations.

**The TDA Plan**

The TDA Plan was a defined contribution plan established on October 1, 2002, and had been amended and restated throughout the years. The TDA Plan was most recently restated on December 19, 2019. The TDA Plan was intended to qualify under Section 403(b) of the Internal Revenue Code (IRC). The TDA Plan covered all eligible employees of the Hospital. The TDA Plan was subject to the provisions of the ERISA.

Each year participants may have contributed a percentage of pretax annual compensation, as defined in the TDA Plan. Participants may also have contributed amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants age 50 and older were allowed to make catch-up contributions. Contributions were subject to certain IRS limitations.

**Participant Accounts**

Each participant's account was credited with the participant's contribution and allocations of the Hospital's contribution, and an allocation of Plans' earnings or losses. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings or account balances, or participant transactions, as defined. The benefit to which a participant was entitled was the benefit that could be provided by the participant's account.

**NOTE 1 DESCRIPTION OF PLANS (CONTINUED)**

**Vesting**

Participants were immediately vested in their contributions to the TDA Plan plus actual earnings thereon. Vesting in the Pension Plan was based on years of continuous service. A participant vested in Hospital contributions based on the following schedule:

Notwithstanding the above, participants were immediately vested in their account upon reaching normal retirement age or becoming disabled. All participants in the Plans became fully vested upon the termination of the Plans.

**Notes Receivable from Participants**

Participants may have borrowed from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The Plans allowed participants to borrow funds from the Plans based on certain conditions. The notes were secured by the balance in the participants' accounts and bore interest at a rate commensurate with local prevailing rates as determined quarterly by the Plans administrator. Notes were repaid through payroll deductions.

**Benefit Payments**

Benefit payments were to be equal to the amount that could be provided pursuant to the form of distribution purchased by the participant's individual participant account. A participant may have elected in writing an optional form of distribution other than a qualified joint and survivor annuity for a married participant and a life annuity for an unmarried participant. The optional forms of benefit available were life annuity (for a married participant with spousal consent), certain and life annuity, joint and survivor annuity (for an unmarried participant and a designated beneficiary), installment refund annuity, fixed period annuity, and lump sum payment. In the event of a participant's death, the benefit was to be paid to the participant's beneficiary not earlier than the first day of the month coinciding with or immediately following the participant's death. This benefit was allowed to be paid pursuant to one of the alternate forms of benefit.

**Forfeited Accounts**

Forfeited nonvested accounts were used to reduce administrative expenses and to reduce the Hospital's contribution to the Pension Plan. There were no forfeited nonvested accounts as of December 31, 2022 and 2021. There were approximately \$4,900 of forfeitures used to reduce Hospital contributions for the year ended December 31, 2022. There were no forfeitures used to pay administrative expenses for the year ended December 31, 2022.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting and Combining Financial Statement Presentation**

The combining financial statements of the Plans as of December 28, 2022 and for the period January 1, 2022 through December 28, 2022 are prepared on the liquidation basis of accounting. The combining financial statements of the Plans as of December 31, 2021 are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of combining financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the combining financial statements. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

The Plans' investments were reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Investment income was recorded on the accrual basis. Net appreciation included the Plans' gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and were expensed when they were incurred. No allowance for credit losses has been recorded as of December 28, 2022 or December 31, 2021. Delinquent notes receivable were recorded as distributions on the basis of the terms of the Plan document.

**Benefit Payments**

Benefit payments were recorded when paid.

**Administrative Expenses**

Certain expenses of maintaining the Plans were paid directly by the Hospital and were excluded from these combining financial statements. Fees related to the administration of notes receivable from participants and benefit payments were charged directly to the participant's account and were included in administrative expenses. Investment related expenses were included in net (depreciation) appreciation of fair value of investments.

**Subsequent Events**

The Plans have evaluated subsequent events through September 26, 2023, the date the combining financial statements were available to be issued.

**NOTE 3 CERTIFICATION**

American United Life Insurance Company, the qualified institution of the Plan, has supplied the Plans administrator with a certification as to the completeness and accuracy of all investment information and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 28, 2022 (in liquidation) and 2021 (ongoing), and the statement of changes in net assets available for benefits for the period from January 1 through December 28, 2022 (in liquidation).

**NOTE 4 FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

**NOTE 4 FAIR VALUE MEASUREMENTS (CONTINUED)**

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2022 and 2021.

*Pooled Separate Account:* Valued at the net asset value (NAV) of units as determined by the insurance company. NAV is a readily determinable fair value and is the basis for current transactions.

**NOTE 5 GROUP ANNUITY CONTRACT WITH INSURANCE COMPANY**

The Plan was privy to a traditional fully benefit-responsive guaranteed investment contract with American United Life Insurance Company (AUL). AUL maintained the contributions in a general account. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer was contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate was based on a formula established by the contract issuer but may not have been less than 4%. The crediting rate was reviewed on a quarterly basis for resetting. The guaranteed investment contract did not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

**NOTE 5 GROUP ANNUITY CONTRACT WITH INSURANCE COMPANY (CONTINUED)**

This contract met the fully benefit-responsive investment contract criteria and therefore was reported at contract value. Contract value was the relevant measure for fully benefit-responsive investment contracts because this was the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by AUL, represented contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, and (4) a material amendment to the agreement without the consent of the issuer.

**NOTE 6 RISKS AND UNCERTAINTIES**

The Plans provided for investment in a variety of investment funds. In general, investments are exposed to various risks, such as interest rate, credit, and overall market volatility risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of the investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the combining statements of net assets available for benefits.

**NOTE 7 PLANS' TERMINATION**

The Hospital had the right under the Plans to discontinue their contributions at any time and to terminate the Plans subject to the provisions of the income tax and employee benefits acts in and of ERISA. Effective December 31, 2022, the Plans were terminated, at which time all participants of the Plans became fully vested. The assets of the Plans were distributed as of December 28, 2022.

**NOTE 8 PLANS' TAX STATUS**

The Plan placed reliance on an opinion letter from the IRS on the prototype plan indicating that the Plan was designed in accordance with the applicable section of the IRC. The Plan was amended since receiving the opinion letter. However, the Plans administrator believed that the Plan was designed and operated in compliance with the applicable requirements of the IRC and, therefore, believed that the Plan was qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America required Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan had taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan was subject to routine audits by taxing jurisdictions; however, there were no audits for any tax periods in progress when the Plans were terminated.

**NOTE 9 PARTY-IN-INTEREST TRANSACTIONS**

The investments were managed by American United Life Insurance Company, the qualified institution of the Plans. Therefore, investment transactions qualified as party-in-interest transactions. These party-in-interest transactions were exempt from the prohibited transaction rules of ERISA.

**NOTE 10 RECONCILIATION OF COMBINING FINANCIAL STATEMENTS TO FORMS 5500**

The Variable Account is a pooled separate account, as classified in the combining financial statements included herein. The pooled separate account did not file as Form 5500 for the direct filing entity; therefore, the underlying assets have been reported on the Form 5500, Schedule H.

**NOTE 11 NONEXEMPT TRANSACTIONS**

During the years ended December 31, 2020, 2019, and 2018, the Company failed to remit employee deferral contributions to the TDA Plan for certain payroll periods within the timeframe prescribed by the Department of Labor totaling \$84,374, \$71,862 and \$35,831, respectively (the aggregate of \$192,067 being reported on schedule h, line 4a). This is deemed a prohibited transaction in accordance with ERISA and the IRC.
