**NOTE 1 – PLAN DESCRIPTION**

The following description of the Huizenga Manufacturing Group Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General: The Plan is a multiple-employer defined-contribution 401(k) plan covering eligible employees of Huizenga Manufacturing Group, Inc.; Competition Engineering, Inc.; Datum Industries, LLC; Parkway Electric and Communications, LLC; Monroe, LLC; Sixarp, LLC d/b/a Praxis Packaging; PE 36th, LLC d/b/a Precise Engineering; Pinnacle Tool, LLC; Lakeland Finishing Company, LLC; A&K Acquisitions, LLC; Unette, Inc.; Churchill Technologies, LLC; Bulldog Acquisitions, LLC; Capitol Special Police LLC; Capital Special Patrol LLC; and Sapphire Valley Public Safety, Inc; and GRGSE Holdings, LLC d/b/a GSE Automation (collectively, the Companies). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

In general, a full-time employee may become a participant in the Plan on the Plan entry date (January 1, April 1, July 1, October 1) following the date on which they attain age 18 and the completion of 90 days of service.

Contributions: A participant may make elective salary reduction contributions in amounts not to exceed the maximum allowable under the Internal Revenue Code (IRC). The Plan provides for employer matching contributions as determined by the Companies for their respective participants, based on the matching contribution allowable as a deduction under the IRC. Matching contributions of approximately \$450,000 were made by the Companies in 2024.

The Plan includes an auto-enrollment provision whereby newly eligible employees at all Companies except Capital Special Police LLC; Capital Special Patrol LLC; and Sapphire Valley Public Safety, Inc. are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation, and their contributions are invested in a designated balanced fund until changed by the participant.

In addition, the Plan provides for a discretionary employer contribution to the Plan, which is to be determined each year by the board of directors of each participating company. No discretionary employer contributions were made by the Companies in 2024.

Vesting: Participants are immediately vested in their contributions and rollover contributions plus actual earnings thereon. Vesting in the employers' matching and discretionary contributions plus actual earnings thereon is based on years of service. A participant vests 20% for each credited year of service and is 100% vested after five years of service.

Benefit Payments: Upon termination of service, death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested account balance or periodic payments, at least annually, of substantially equal amounts over a period not to exceed the joint life expectancy of the participant or beneficiary. The Plan allows for withdrawal prior to retirement if the participant meets certain age or hardship withdrawal requirements. Such withdrawals may be subject to approval by the Plan Administrator.

Forfeitures: If a participant is not fully vested on their termination date, the non-vested amount of the account is forfeited. Forfeitures are used to reduce future contributions of the Companies or pay for Plan expenses. For the year ended December 31, 2024, no forfeitures were used to reduce future contributions of the Companies or pay for Plan expenses. The total balance in the forfeitures account as of December 31, 2024 and 2023 was approximately \$50,000 and \$42,500, respectively.

Plan Transfers: In 2024, the Plan approved the transfer of loans from another qualified plan to certain participant accounts in the amount of \$6,385.

Participant Accounts: Each participant's account is credited with the participant's contribution and allocations of the Companies' contributions and Plan earnings. Allocations are based on participant compensation or account balances, as defined in the Plan Agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

Notes Receivable From Participants: Participants may borrow from their accounts subject to certain maximum and minimum amounts as prescribed in the Plan and the IRC. The period of repayments for participant notes receivable is fixed and cannot exceed five years. Notes receivables are collateralized by the participant's account balance and bear interest at a rate commensurate with local borrowing rates. Interest rates on notes outstanding at December 31, 2024 range from 4.25% to 9.50%.

Plan Termination: Although it has not expressed any intent to do so, the Companies have the right under the Plan agreement to discontinue contributions at any time and to terminate the Plan subject to provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company's contributions and earnings thereon.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting: The accompanying financial statements of the Plan have been prepared under the accrual method of accounting.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of net assets and changes therein. Actual results could differ from those estimates.

Risks and Uncertainties: The Plan holds various investment securities. The underlying investment securities are exposed to various risks, such as interest rate, market, liquidity and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits and participants' individual account balances.

Investment Valuation and Income Recognition: The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset (an exit price) in the principal or most advantageous market for the asset in an orderly transaction between market participants on the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Benefit Payments: Benefits are recorded when paid.

Administrative Expenses: Various administrative costs are paid by the Companies. Certain administrative expenses, which consist of loan fees, expedited distribution fees and a quarterly administrative charge for terminated participants with balances in the Plan are paid directly out of the applicable participant accounts. In addition, certain expenses are paid using a revenue-sharing arrangement and are included in administrative expenses on the statement of changes in net assets available for benefits. Total investment advisory and other fees paid out of this revenue-sharing arrangement were approximately \$72,000 for the year ended December 31, 2024.

Subsequent Events: Plan management has performed an analysis of activities and transactions subsequent to December 31, 2024 to determine the need for any adjustment to and/or disclosures within these financial statements for the year ended December 31, 2024. Plan management has performed their analysis through October 15, 2025, which was the date that the financial statements were available to be issued and has determined that there are no subsequent events to recognize or disclose.

**NOTE 3 – CERTIFIED INVESTMENTS**

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedules, related to investments and notes receivable from participants held as of December 31, 2024, and net appreciation in fair value of investments, interest and dividends and interest income on notes receivable from participants for the year then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by State Street Bank and Trust Company, a qualified institution.

**NOTE 4 – FAIR VALUE MEASUREMENTS**

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

*Level 1*: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

*Level 2:* Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

*Level 3:* Significant unobservable inputs that reflect the Plan’s own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following presents of the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

Mutual Funds: The fair values of mutual fund investments are determined using the market approach by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Common Collective Trust: The common collective trust (CCT) is valued at the NAV of units of a collective trust fund. The NAV, as provided by the trustee of the CCT, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. There are no unfunded commitments relating to this investment. The investment is a direct filing entity.

Self-Directed Accounts: Self-directed accounts are underlying investments consisting of mutual funds. See the valuation methodology for this type of investment above.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value for certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 – TAX STATUS**

The Internal Revenue Service has determined and informed the Company by a letter dated June 28, 2023 that the Plan is designed and operating in accordance with applicable sections of the Internal Revenue Code. The Plan has been subsequently amended and the Plan administrator still believes the Plan is being operated in compliance with the applicable regulations.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**NOTE 6 – PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by employees or officers of the Company. Certain professional fees for the administration and audit of the Plan were paid by the Company. Investment management and custodial fees paid by the Plan to State Street Bank and Trust Company and Transamerica Retirement Solutions qualify as party-in-interest transactions. Notes receivable from participants also qualify as party-in-interest transactions.
