EXPLANATION OF REASONABLE CAUSE FOR LATE FILING

DURING 2025, THE YEAR AFTER THE PLAN YEAR-END OF 12/31/24, THE CONTROLLER OF THE PLAN SPONSOR WHO HANDLED THE DAY-TO-DAY OPERATIONS OF THE BENEFIT PLAN AND IS THE MAIN CONTACT FOR THE INFORMATION NECESSARY TO FILE THE 5500 FOR THE BENEFIT PLAN, EXPERIENCED SIGNIFICANT HEALTH ISSUES THAT REQUIRED RETIREMENT. THE NEW CONTROLLER WORKED DILIGENTLY TO GATHER THE INFORMATION NECESSARY TO FILE THE 5500 BUT WAS UNABLE TO DO SO BY THE EXTENDED DUE DATE. THE DELAY WAS DUE TO REASONABLE CAUSE, HEALTH ISSUES EXPERIENCED BY THE CONTROLLER, AND WAS NOT A WILLFULLY NEGLIGENT OMISSION. THE NEW CONTROLLER TOOK IMMEDIATE ACTION TO CORRECT THE FILING ISSUE AND HAS INSTITUTED A PROCEDURE TO PREVENT THIS ISSUE IN THE FUTURE.

PLAN SPONSOR HAS ALWAYS FILED REQUIRED INCOME TAX AND INFORMATION FILINGS IN A TIMELY MANNER. THE PLAN SPONSOR OTHERWISE HAS A GOOD COMPLIANCE HISTORY EVIDENCED BY NOT RECEIVING ANY PENALTIES DURING THE PRIOR THREE YEARS, FILING ALL REQUIRED RETURNS, AND DOES NOT HAVE AN OUTSTANDING REQUEST FOR A RETURN FROM THE IRS.
