Management has obtained certifications from Transamerica Trust Company as of December 31, 2024 and for the period from July 1, 2024 to December 31, 2024, and Reliance Trust Company as of December 31, 2023 and for the period January 1, 2024 to June 30, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Notes to the Financial Statements

1. Description of the Plan

The following description of the Sila Solutions Group 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), which was established on May 15, 2004, by Sila Solutions Group (the Company). The Plan covers all employees of the Company and its affiliates who are 21 years of age and who meet certain eligibility requirements.

The Company is the plan administrator and, as such, carries out the duties imposed by ERISA. The Company has delegated certain responsibilities for the operation and administration of the Plan. Transamerica Retirement Solutions, LLC (Transamerica) is the recordkeeper. Reliance Trust Company (RTC) was the custodian through June 30, 2024, after which time Transamerica Trust Company (TTC) became the custodian of the Plan's investments.

Contributions

Participants may elect to contribute up to the maximum allowable amount under the Internal Revenue Code (IRC) of their annual compensation. Participants may elect to contribute either pre-tax or post-tax dollars to the Plan. Participants who are at least 50 may make additional "catch-up" contributions as defined under the IRC. The Company may also make contributions to the Plan out of the Company's profits, determined at the discretion of the Company.

Rollover Contributions

The Plan accepts rollover contributions from retirement funds held by participants outside of this Plan, subject to plan provisions.

Investment Options

The Plan provides for participant-directed investment programs whereby the Plan determines which investment options are available and the participants may choose among the available options. Participants may have their accounts invested in any or a combination of registered investment companies accounts and a stable value fund option. Participants may change their investment options at any time by reallocating contributions among different investment alternatives. Participants may also transfer contributions into and out of investments provided under the Plan, subject to possible restrictions.

Participant Accounts

Each participant's account is self-directed and credited with the participant's contributions (including elective deferrals, catch up contributions, after-tax contributions, and/or rollover contributions), the Company's contributions, share of any investment earnings, and increases in the value of investments. Participant accounts are also debited with any withdrawals or distributions, investment losses, decreases in values of investments, and share of fees and expenses, as applicable. Allocations are based on participant earnings or account balances, as defined pursuant to the Plan's provisions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Payment of Benefits

Benefits may be paid from participant accounts at age 65, or upon disability, termination of employment, death, or upon the Plan's termination. Participants who are age and over are required by the IRS to make certain required minimum distributions. If a participant's account is valued at \$1,000 or less upon termination of employment, the Plan may liquidate the value of the account and distribute the funds to the former participant.

The taxable portion of a withdrawal is subject to federal and state income taxes and an additional tax if the participant has not reached retirement age, unless the amount is rolled over into another eligible plan or an Individual Retirement Account.

Eligible participants may request an in-service hardship distribution, subject to the Plan's provisions.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000, less the highest outstanding loan balance in the prior twelve-month period. Participants are permitted to have only one outstanding loan at any time, and the loan must be repaid within a five-year period, unless the loan is for the acquisition of a primary residence. All loans shall be considered investments of the trust and shall be evidenced by a promissory note signed by the participant. Loans are secured by the balance in the participant's account, and bear interest at a rate commensurate with local prevailing rates as determined by the plan administrator. The interest rate shall remain fixed throughout the duration of the loan. Principal and interest payments are made through payroll deductions. During the year ended December 31, 2024, the interest rates on loans outstanding were between 4.25% and 8.50%.

Vesting

Participants are immediately fully vested in their contributions, plus earnings on those contributions. Matching contributions and profit-sharing contributions made by the Company, if any, are subject to a vesting schedule based on years of continuous service. A participant is 25 percent vested after one year of service is completed and vests an additional 25 percent per year until full vesting after four years.

Administrative Expenses

Administrative expenses include transaction and loan fees that are paid out of the related participant accounts, recordkeeping and investment fees paid by the Plan and allocated to participants. Expenses paid by the Company on behalf of the Plan are not included in the financial statements.

The Plan has an expense benefit account that holds credits earned under an expense benefit agreement (“EBA”) with Transamerica. EBA credits may offset Transamerica plan service fees, with the remainder reported in other income on the Statement of Changes in Net Assets Available for Benefits. The expense benefit account may be used to pay other plan expenses including audit fees and investment advisor fees. During the year ended December 31, 2024, credits earned under the EBA totaled \$63,339 and the Plan used \$51,904 of EBA credits to pay investment advisory fees. As of December 31, 2024 and 2023, \$16,073 and \$4,800, respectively, was in the expense benefit account available to pay future expenses and is held in an interest-bearing cash account.

Forfeitures

Forfeitures may be used to offset or decrease Company contributions and offset administration expenses. During the year ended December 31, 2024, \$44,076 was utilized from the forfeiture account to offset Company contributions. As of December 31, 2024 and 2023, forfeited non-vested accounts available for future use totaled \$15,289 and \$23,216, respectively.

2. Summary of Significant Accounting Policies

Date of Management’s Review

Subsequent events were evaluated through November 12, 2025, which is the date the financial statements were available to be issued.

Basis of Accounting

The Plan presents its financial statements under the accrual basis of accounting in accordance with generally accepted accounting principles in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in conformity with GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results may differ from those estimates.

Contributions

Employee contributions are recorded in the period that the Company makes payroll deductions from the participant's earnings. Contributions from the Company are accrued in the period in which they become obligations under the provisions of the plan agreement.

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the plan document.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Contract value is the relevant measurement attribute for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. Shares of registered investment companies (mutual funds) are valued at quoted market prices which represent the net asset values of shares held by the Plan at year end. The Stable Value fund is an investment in the general account of the custodian and is guaranteed at contract value, which approximates fair value.

Purchases and sales of investments are recorded on a trade-date basis. Interest and dividend income are recorded when earned. Net appreciation and depreciation include the Plan's gains and losses on investments bought and sold as well as those held during the year.

Payment of Benefits

Benefit payments to participants are recorded when paid.

4. Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an estimate that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs to the valuation methodology are unadjusted quoted prices for similar assets in active or inactive markets, and Level 3 inputs are observable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 or Level 2 inputs are not available. The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value as of December 31, 2024 and 2023.

Registered investment companies (Mutual Funds): Shares are based on quoted market price values on the last business day of the plan year.

There were no investments considered within Level 2 or Level 3 as of December 31, 2024 and 2023, or at any time during the year ended December 31, 2024.

5. Fully Benefit-Responsive Investment Contract

The Plan participates in a fully benefit-responsive investment contract with Transamerica Life Insurance Company (TLIC) via an investment in a Stable Value Option. This is a non-tradable obligation of TLIC with the investment's contract or proceeds only able to be assigned or sold to another party by TLIC. The repayment of principal and interest credited to participants holding the investment is a financial obligation of TLIC. The terms of TLIC's Group Annuity Contract require all permitted participant-initiated transactions involving the investment to occur at contract value with no conditions, limits, or restrictions. Permitted participant-initiated transactions are those allowed by the underlying defined contribution plan such as withdrawals for benefits, loans, or transfers to other investment choices within the Plan. Since the Stable Value Option investment choice is an obligation of TLIC, the occurrence of an event that limits the ability of the investment to transact at contract value between TLIC and a participant holding the investment is not probable. The Stable Value Option investment choice allows a participant reasonable access to their assets. As of December 31, 2024 and 2023, the Plan's investments in the Stable Value Option totaled \$621,618 and \$649,742, respectively.

6. Related Party and Party-In-Interest Transactions

The Plan allows for transactions with certain parties who may perform services or have fiduciary responsibilities to the Plan, including Transamerica, the Company, RTC, TTC and TLIC. The Company provides certain accounting and administrative services to the Plan for which no fees

are charged. Fees paid to Transamerica, RTC, and TTC for services rendered by parties-in-interest were based on customary and reasonable rates for such services. Certain plan investments are managed by TLIC. The Plan may also pay audit fees and investment advisory fees. All of these party-in-interest transactions are exempt from the prohibited transaction rules under ERISA.

Notes receivable from participants are also party-in-interest transactions.

7. Income Tax Status

The prototype plan sponsor has obtained its latest opinion letter dated June 30, 2020, in which the Internal Revenue Service (IRS) stated that the Plan, as designed and amended under the 2017 Cumulative List of Amendments, was in compliance with the applicable requirements of the IRC.

Although the Plan has been amended since the last opinion letter, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and ERISA and qualifies as exempt from federal income taxes. GAAP requires the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities, however, there are currently no audits for any tax periods in progress. The Plan's Form 5500 is open for inspection by the taxing authorities, generally for three years after filing. The plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

8. Plan Termination

Although the Company has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination, participants will become fully vested in their accounts.

9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

11. Subsequent Events

During 2025, the Plan's management determined that certain participant contributions for the 2024 plan year were remitted late, based on the timing of historical remittances to the Plan which established the earliest date on which contributions could reasonably be segregated from the Company's general assets. These late remittances constitute prohibited transactions as defined by ERISA. The Company is determining the appropriate steps to correct these transactions, and any corrective contributions will be reflected in the Plan's 2025 financial statements.
