Re: Reasonable Cause Explanation for Late Filing – Form 5500 for Plan Years Ending 2020–2024

McKenzie's Cleaning Inc., EIN 81-0625956

To Whom It May Concern:

I am writing on behalf of McKenzie's Cleaning Inc. to provide a reasonable cause explanation for the late filing of our Form 5500-SF returns for plan years ending 2020, 2021, 2022, 2023, and 2024, and to respectfully request a waiver of penalties and associated fees.

Our filings were delayed due to circumstances beyond my control. During this period, I, Terriann McKenzie, Chief Executive Officer of McKenzie's Cleaning Inc., was involved in a serious accident that resulted in significant disability for over a year. As a consequence, I was unable to actively oversee business operations, including our compliance obligations.

During my recovery, I entrusted the management of all business and administrative responsibilities to staff who, despite their sincere efforts and best intentions, were not fully equipped to manage every compliance requirement. Unfortunately, as a result, certain filings including the Form 5500 submissions fell behind during this unforeseen and challenging period.

McKenzie's Cleaning Inc. has always aimed to maintain full compliance and submit all required filings timely and accurately. The delays were neither intentional nor due to disregard for our obligations, but rather the result of extraordinary medical and operational circumstances.

We have since taken corrective steps to bring all filings up to date and have implemented stronger internal procedures to ensure ongoing compliance. In light of the above, we respectfully request that the Department of Labor grant a waiver of penalties and fees associated with the late filings for plan years 2020 through 2024.
