## INDEPENDENT AUDITORS' REPORT

To the Administrative Committee and Management of  
**Toro Enterprises, Inc. 401(k) Profit Sharing Plan and Trust**

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of Toro Enterprises, Inc. 401(k) Profit Sharing and Trust ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

### Basis for Opinion

### NOTES TO FINANCIAL STATEMENTS

#### ( 1 ) Description of plan

The following description of the Toro Enterprises, Inc. 401(k) Profit Sharing Plan and Trust (the "Plan") provides only general information. Participants should refer to the plan document or summary plan description for a more complete description of the Plan's provisions, which are available from the plan administrator.

**General** – The Plan is a defined contribution plan covering all employees of Toro Enterprises, Inc. and O & C Toro Corporation (the "Employer") who have completed six months of eligible service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Plan is administered by the Employer's Administrative Committee (the "Committee"). The Committee has overall responsibility for the operation and administration of the Plan. The Committee determines the appropriateness of the Plan's investment offerings, and monitors investment performance.

**Contributions** – Each year, participants may contribute up to 75% of annual compensation as pre-tax or Roth contributions, as defined in the Plan. Participants may also make a separate election to contribute up to 100% of designated cash bonuses to the Plan as contributions, provided that the total contributions for the year do not exceed 75% of the participant's total compensation. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Additionally, participants age 50 or older, who are making contributions to the Plan, are allowed to make catch-up contributions as defined by the Plan. Participants direct the investment of all contributions into various investment options offered by the Plan.

The Employer may contribute a discretionary match of the base compensation that a participant contributes to the Plan determined by the Employer on an annual basis. The Employer may elect to make profit sharing contributions allocated to individual accounts of qualifying participants in the ratio that each qualifying participant's compensation for the plan year bears to the total compensation of all qualifying participants for the plan year. No discretionary profit sharing contributions have been made to the Plan for the years ended December 31, 2024 and 2023. No discretionary match contributions have been made to the Plan for the years ended December 31, 2024 and 2023. Contributions are subject to certain Internal Revenue Code ("IRC") limitations.

The Plan also includes provisions for Qualified Matching Contributions ("QMAC") and Qualified Non-elective Contributions ("QNEC"). The Employer may characterize all or a portion of the matching contribution it makes to participant accounts as a QMAC. QMACs are treated as if they were participant contributions to satisfy federal nondiscrimination rules. The Employer may characterize all or a portion of the QNEC it makes to participant accounts as a QNEC. QNECs are treated like participant contributions to satisfy federal nondiscrimination rules. If the Employer determines that the Plan would not meet special IRS non-discrimination tests for the year, the Employer, at their discretion, may make a separate QNEC to the Plan. Participants with the lowest amount of compensation for the year will have separate QNEC made on their behalf until the IRS tests are satisfied. These employer contributions are immediately 100% vested. The plan sponsor may only remit a QNEC or QMAC contribution for a failed compliance test.

**( 1 ) Description of plan (continued)**

**Participant investment account options** – The Plan currently offers various pooled separate accounts and a fixed income account as investment options for participants. Each investment option has its own investment strategy, which can be obtained through the prospectus of the respective fund. Participants may change their investment options at any time.

**Participant accounts** – Each participant's account is credited with the participant's contributions, the Employer's contributions, an allocation of Plan earnings or losses, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting** – Participants' contributions plus actual earnings are 100% vested immediately. If portions of the employer match and profit sharing contributions are deemed to be QMAC or QNEC, those contributions are 100% vested. The Employer's other contributions are subject to the following vesting schedule:

**Notes receivable from participants** – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants are limited to one outstanding loan at a time. Loan terms may not exceed five years unless the loan is used for the purchase of a principal residence. The loans are secured by the balance in the participant's account and bear interest at a fixed rate based on relevant factors including, but not limited to, the current rates charged by other lenders as determined by the plan administrator. Principal and interest are paid through scheduled payroll deductions.

**Payment of benefits** – On termination of service due to death, disability or retirement, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. If the value of a participant's vested interest in his or her account is less than \$1,000, it will be automatically cashed out either as a single sum payment or a direct rollover to an IRA or other eligible retirement plan.

### ( 1 ) Description of plan (continued)

The Plan provides that the mandatory form of benefit under the plan is an annuity ("qualified annuity") unless the participant elects to waive the qualified annuity. If the qualified annuity applies, the plan administrator will use his or her account balance to purchase the qualified annuity from an insurance company. Then the Plan will distribute the qualified annuity contract so he or she will receive payments in accordance with the contract. If the value of a participant's vested account balance does not exceed \$5,000, then the vested account balance will be distributed in a single lump-sum payment in cash and he or she will not receive the qualified annuity.

**Forfeited accounts** – At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$5,010 and \$0, respectively. These accounts will be used to reduce future employer contributions. During the year ended December 31, 2024, no forfeited nonvested accounts were used to reduce employer contributions. During the year ended December 31, 2023, forfeited nonvested accounts totaling \$6,898 were used to reduce employer contributions related to the year ended December 31, 2022.

### ( 2 ) Summary of significant accounting policies

**Basis of accounting** – The financial statements of the Plan are prepared under the accrual method of accounting.

**Use of estimates** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**Investment valuation and income recognition** – Investments are reported at fair value except for the fully benefit-responsive investment contract which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Committee determines the Plan's valuation policies utilizing the information provided by the investment custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**( 2 ) Summary of significant accounting policies (continued)**

**Contributions** – Contributions from plan participants are recorded in the year in which the employee contributions are withheld from compensation. Profit-sharing contributions from the Employer are made at the discretion of the Employer and recorded in the year in which they are earned.

**Notes receivable from participants** – Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

**Payments of benefits** – Benefits are recorded when paid.

**Administrative expenses** – Certain expenses of the Plan are paid by the Employer and are not included in the statements of changes in net assets available for benefits. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Recordkeeping services are allocated to participants' accounts and are also included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

**( 3 ) Information prepared and certified by the custodian**

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Annuity Insurance Company of America, as attorney-in-fact, on behalf of Talcott, the custodian of the Plan, has certified that the following data included in the accompanying financial statements and supplemental schedules are complete and accurate with respect to investments:

- Investments at net asset value ("NAV")
- Fully benefit responsive investment at contract value
- Notes receivable from participants
- Net appreciation in fair value of investments
- Interest and dividends
- Interest income on notes receivable from participants
- Schedule of assets (held at end of year)

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

#### ( 4 ) Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASU”) Topic 820 are described below:

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts: Valued at the NAV of units of the separate account. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the separate account, the investment advisor reserves the right to temporarily delay withdrawal from the account in order to ensure that securities liquidations will be carried out in an orderly business manner.

The following summarizes the investment strategies by major categories for these investments.

Target retirement – This category includes investments in pooled separate accounts that invests in J.P. Morgan Funds (underlying funds), and is generally intended for investors expecting to retire around a specific year (target retirement date). It is designed to provide exposure to a variety of asset classes through investments in underlying funds, and over time the fund’s asset allocation strategy will change.

Bond – This category includes investments in pooled separate accounts that have high yield, lower-rated debt securities, including government and corporate debt securities, mortgage - and asset-backed securities, floating interest rate corporate loans, and debt securities, and municipal securities.

Growth – This category includes investments in pooled separate accounts that invest at least the majority of its investable assets in equity and equity-related securities of companies with the potential for above-average growth. In deciding which equities to buy, it uses what is known as a growth investment style. The fund's investable assets will be less than its total assets to the extent that it has borrowed money for non-investment purposes, such as to meet anticipated redemptions.

Value – This category includes investments in pooled separate accounts that invest in equity securities of companies with a favorable income-paying history that have prospects for income payments to continue or increase. The portfolio managers also look for equity securities of companies that they believe are undervalued and have the potential for an increase in price.

Foreign – This category includes investments in pooled separate accounts that invest its assets primarily among stocks, bonds and short-term instruments of issuers in markets around the globe, as well as investments in derivative instruments, precious metals and investments with exposure to various foreign currencies. It may invest its assets in any market that the manager believes can offer a high probability of return or, alternatively, can provide a high degree of relative safety in uncertain times.

Blended – This category includes investments in pooled separate accounts that invest, under normal circumstances, the majority of its net assets in equity securities of companies with market capitalizations, at the time of purchase, within the range of companies comprising the Russell MidCap® Index. The fund may invest a portion of its assets in equity securities of foreign companies traded on U.S. exchanges, including American and Global Depositary Receipts (ADRs and GDRs).

Balanced funds – This category includes investments in pooled separate accounts whose investment seek current income and long-term capital appreciation via a combination of funds, primarily made up of fixed income funds, a small allocation to equity, and multi-asset funds as well as a combination of domestic and international equity funds.

Natural resource – This category includes investments in pooled separate accounts that invest, under normal circumstances, the majority of its net assets in equity securities of companies throughout the world that own, explore or develop natural resources and other basic commodities or supply goods and services to such companies.

The preceding methods described may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

In accordance with Subtopic 820-10, certain investments that were measured at net asset value per share (or its equivalent) have not been classified in the fair value hierarchy.

**( 5 ) Guaranteed investment contract with insurance company**

The Plan has a fully benefit-responsive guaranteed investment contract with Empower Annuity Insurance Company of America (“EAIC”). EAIC maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal at a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on an agreed upon formula with the issuer, but may not be less than 3%. Such interest rates are reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date, unless certain circumstances with the Plan occur as determined in the agreement.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by EAIC, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan’s ability to receive amounts due is dependent on the issuer’s ability to meet its financial obligations. The issuer’s ability to meet its contractual obligations may be affected by future economic and regulatory developments.

**( 5 ) Guaranteed investment contract with insurance company (continued)**

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan document (including complete or partial termination or merger with another plan.), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with Plan participants are probable of occurring.

**( 6 ) Related party transactions and party-in-interest transactions**

EIAC is the custodian and Empower Retirement, LLC ("Empower") is the recordkeeper for the Plan. Therefore, these transactions qualify as party-in-interest transactions.

Empower provides certain administrative services to the Plan pursuant to a Services Agreement between the Employer and Empower. Empower receives revenue from mutual fund service providers for services Empower provides to the funds. This revenue is used to offset certain amounts owed to Empower for its administrative services to the Plan.

If the revenue received by Empower from such mutual fund service providers exceeds the amount owed under the Services Agreement, Empower remits the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay plan administrative expenses or allocated to the accounts of participants. During the years ended December 31, 2024 and 2023 there were no excess amounts. The Plan or Plan Sponsor may make payment to Empower for administrative expenses not covered by revenue sharing.

Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investments, as they are paid through revenue sharing, rather than a direct payment. As described in Note 2, the Plan made direct payments to the third party administrator of \$1,550 and \$0 for the years ended December 31, 2024 and 2023, respectively, which was not covered by revenue sharing. The Plan paid certain expenses related to the Plan's operations and investment activity to various service providers. These transactions are party-in-interest transactions. The Plan Sponsor pays directly any other fees related to the Plan's operations.

**( 7 ) Plan termination**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

**( 8 ) Tax status**

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (“IRS”) dated November 14, 2022, stating that the form of the pre-approved plan document was in compliance with applicable requirements of the IRC. Although, the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**( 9 ) Risks and uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

**( 10 ) Subsequent events**

The Plan has evaluated subsequent events through November 14, 2025, which is the date the financial statements were available to be issued.
