Report of Independent Auditors

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audit of the accompanying financial statements of M-TEQ 401(k) Profit Sharing Plan and Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) audit. The financial statements comprise the statement of net assets available for benefits as of December 31, 2021, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of M-TEQ 401(k) Profit Sharing Plan and Trust's financial statements performed in accordance with ERISA section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state of federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2021, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the 2021 Financial Statements section –

- the amounts and disclosures in the 2021 financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the 2021 financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the 2021 Financial Statements section of our report. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.





Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about M-TEQ 401(k) Profit Sharing Plan and Trust's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the 2021 Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Note 1 - Description of Plan

The following description of the M-TEQ 401(K) Profit Sharing Plan and Trust, (the "Plan"), provides only general information. Participants should refer to the Plan agreement or the summary plan description for a more complete description of the Plan's provisions.

General

The Plan, effective January 1, 2009, is a defined contribution plan covering substantially all domestic employees of Manufacturing Techniques, Inc (the "Plan Sponsor") who are 21 years of age and have completed at least three months of service. The plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was last amended January 21, 2020. In December 2019, M-TEQ was acquired by another company, QinetiQ, Inc., but there were no changes to the Plan. The Plan was merged into the QinetiQ North America 401(k) Plan in October 2021 and most assets were transferred by year end.

Contributions

The Plan provides for both pre-tax and ROTH participant contributions up to 96% of compensation. Eligible employees may contribute any whole percentage of annual compensation up to certain limitations in the Internal Revenue Code. Qualified distributions from other qualified retirement plans can also be contributed to the Plan and retained as a rollover contribution. The Plan provides for a Qualified Automatic Contribution Arrangement (QACA) of 3% upon enrollment unless the participant makes a separate election. Under the QACA, deferral rates increase 1% per year up to a maximum of 6%. The Plan provides for an employer safe harbor matching provision. In 2021 and 2020, the Plan Sponsor made matching contributions of 100% of the first 1% and 50% of the remaining contributions, up to 6% of eligible compensation.

Participant accounts

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contribution and, (b) Plan earnings. Earnings are allocated by fund based on the ratio of a participant's account invested in a particular fund to all participants' investments in that fund. The benefit to which a participant is entitled is the benefit that can be provided from the participants' vested account. The Plan Sponsor's contribution is allocated based upon participants' contributions to the Plan.

Investment options

Upon enrollment in the Plan, participants may direct the custodian of the Plan as to the investment of their account balances in accordance with guidelines established by the Plan.

Participant Loans

Participants may borrow no more than the present value of the vested portion of their account. Loans are treated as a transfer between the investment funds and loans to participants. A loan is secured by the balance in the participant's account and bears interest at a rate commensurate with market rates for similar loans, as defined in the Plan. For the years ended December 31, 2021 and 2020 respectively, the interest rate on all loans range from 4.50% to 5.75%. Principal and interest are paid ratably through bi-weekly payroll deductions.

Forfeitures

Forfeitures may be used to reduce future Plan Sponsor contributions, pay administrative expenses or be reallocated to participants. Forfeitures of \$48,420 and \$45,169 were used to pay fees during the years ended December 31, 2021 and 2020, respectively. Forfeitures available at December 31, 2021 and 2020 were \$-0- and \$8,631, respectively.

Vesting

Participants are 100% vested in their own contributions immediately upon entering the Plan. Participants are vested in the Plan Sponsor's QACA safe harbor contribution, QNEC contributions and Employer Profit Sharing contributions plus actual earnings thereon are vested based upon the following continuous years of service:

Payment of benefits

Distribution of the vested portion of a participant's account will occur upon the participant's termination, death, disability or retirement, as defined in the Plan. In-service distributions are allowed for participants attaining age 59 ½. Up to 100% of the participant's vested account balance can be paid in a lump-sum, direct rollover to another qualified plan, or partial withdrawal, with the minimum being \$1,000, to the participant or their beneficiaries. Benefit claims are recorded as deductions when they have been approved for payment and paid by the Plan.

Administrative Expenses

The Plan's administrative expenses, which include primarily custodial, investment management, and professional fees for services provided by parties-in-interest, are generally paid by the Plan Sponsor, as provided in the Plan agreement. The Plan paid \$91,609 and \$70,397 for contract administrator fees for the years ended December 31, 2021 and 2020, respectively.

Note 2 - Summary of Accounting Policies

Basis of accounting

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with generally accepted accounting principles in the United States.

Investment valuation and income recognition

The Plan's investments are stated at fair value. Shares of mutual funds, managed by Mid Atlantic Trust, are based on quoted market prices, which represent the net asset value of shares held by the Plan at year end. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis.

Participant loan receivables

Participant loan receivables are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document. Interest income on participant loan receivables is recognized in the period in which it is earned and is recorded as interest income on the statements of changes in net assets available for benefits.

Payment of benefits

Benefits are recorded when paid.

Use of estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Credit risk

Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the amounts reported in the statements of net assets available for benefit.

Note 3 - Fair Value Measurements

FASB ASC 820 provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2021 and 2020.

Registered investment accounts: Valued at quoted net assets values of the shares actively traded on the market and held by the Plan at year-end.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts. The Plan sponsor elected to merge the Plan effective October 2021. Investments were transferred to the merged company plan beginning in December 2021.

Note 5 – Tax Status

The Plan obtained its latest determination letter on April 10, 2014, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. However, the Plan administrator and the Plan’s tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2021 and 2020, no uncertain positions are taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to December 31, 2018.

Note 6 – Party-In-Interest Transactions

Certain Plan investments are shares of mutual funds managed by the custodian of the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to the custodian for investment management services amounted to approximately \$91,609 and \$70,397 for the years ended December 31, 2021 and 2020, respectively.

Fees paid on behalf of the Plan for other services were paid by the Plan Sponsor, Manufacturing Techniques, Inc. These would include services for Plan administration and audit fees.

Note 7 – Financial Information Certified by the Trustee of the Plan

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2021 and 2020, and net appreciation in fair value of investments, interest and dividends, and participant interest income for the years ended December 31, 2021 and 2020, was obtained by management and agreed to or derived from information certified as complete and accurate by Mid Atlantic Trust Company.

Note 8 – COVID-19 impacts

The Plan's operations may be affected by the ongoing outbreak of the coronavirus disease 2019 (COVID-19) which was declared a pandemic by the World Health Organization in March 2020. COVID-19 has led to increased short-term market volatility and may have adverse long-term effects on U.S. and world economies and markets in general. The ultimate disruption which may be caused by the outbreak is uncertain; however, it may result in a material adverse impact on the Plan's fair value of investments. The Plan and the Plan Sponsor continue to monitor developments, including government requirements and recommendations at the national, state, and local level to evaluate business decisions.

Note 9 – Subsequent events

The Plan has evaluated subsequent events through December 23, 2022, the date the report is available for issuance. No events requiring disclosure have been noted.
