INDEPENDENT AUDITORS' REPORT

To the Plan Administrator and Plan Participants of the
Village Capital 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Village Capital 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Village Capital 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024, and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

Note 1 – Description of the Plan

The following description of the Village Capital 401(k) Plan (the “Plan”) of Village Capital & Investment, LLC (the “Company”, “Employer”, or “Plan Sponsor”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General –The Plan is a defined contribution plan covering all full-time employees of the Company who have completed 1 year of service and are age 18 or older, other than union employees whose employment is governed by a collective bargaining agreement under which retirement benefits were the subject of good faith bargaining, certain non-resident aliens who have no earned income from sources within the United States and leased employees. An eligible employee, who has enrolled, shall become a participant two months after their hire date. Employees must affirmatively elect to participate. The Plan is subject to the provisions of ERISA. Effective January 1, 2016 the Company adopted the Plan. The Plan was most recently amended effective January 1, 2023. The Plan Trustee and Sponsor are responsible for oversight of the Plan. The Plan Trustee also determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

Participant Accounts – Each participant’s account is credited with the participant’s contributions and the Company’s matching contributions, as well as allocations of the Company’s profit-sharing contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Contributions –Participants elect both the amount of salary reduction contributions and the allocation of the salary reduction contributions among the various investment alternatives within the Plan. Annual salary reduction contributions cannot exceed the lesser of 100% of the participant’s eligible compensation or the maximum amount allowable under the IRC, which was \$23,000 during 2024 (\$30,500 for participants age 50 and older).

Employees are eligible for the Company match when they have completed one year of service and 1,000 hours of service, and have enrolled in the Plan. Employees must make contributions to the Plan in order to receive the Company match. During 2024, the Company matched 100% of each eligible participant’s salary reduction contribution up to 3% and matched 50% of each eligible participants salary reduction contributions of between 3% and 5% of compensation.

Each year the Company may make an additional discretionary matching contribution not to exceed 4% of a participant’s total compensation. Discretionary matching contributions are recorded when authorized by the Company’s Board of Directors. An employee is eligible to receive a discretionary matching contribution if he or she makes contributions to the Plan and is employed on the last day of the allocation period. The Company did not make a discretionary matching contribution in 2024.

Participant-Directed Options for Investments Participants direct the investment of their contributions and the Company matching and discretionary contributions into various investments offered by the Plan. Investment options include various mutual funds and a money market account. Participants may change their elections or transfer investments between funds at any time.

Vesting and Payment of Benefits – Participants are immediately vested 100% in their account balances (including employee deferrals and employer Safe Harbor match). Any additional discretionary matching contributions vest 20% each year over five years of service. Benefits are normally paid at retirement, disability, death, or other termination of employment. Benefits distributions may be made in a single lump sum payment or in equal installments over a specified period of time. Participants may withdraw funds from the Plan while actively employed subject to specific restrictions set forth in the Plan document.

Notes Receivable from Participants – Participants can borrow a minimum of \$1,000 up to the lesser of \$50,000 or fifty percent of the amount of their vested account balance. The loans are to be paid off through

payroll deduction over a maximum of five years. Interest rates on new loans bear interest based on US Prime rates plus 2 percent and are fixed over the term of the loan. The interest rates on outstanding loans as of December 31, 2024, were between 5.5% and 10.5% with maturities through 2028. Each loan is made against collateral which may be the participant's entire right, title and interest in the Plan supported by a promissory for the amount of the loan, including interest, payable to the Plan.

Forfeitures – Participants terminating employment with the Company forfeit non-vested Company contributions. Forfeitures by participants are used to reduce the Employer matching contributions. During the year ended December 31, 2024, there were \$39,567 in forfeitures. Unused forfeitures plus associated earnings totaled \$40,260 and \$-0- as of December 31, 2024 and 2023, respectively.

Custodian and Recordkeeper - As of December 31, 2024, Charles Schwab Trust Bank (“Charles Schwab”) and Ascensus, LLC (“Ascensus”) provide the custodial and recordkeeping services for the Plan.

Parties-in-Interest – The Company, participants, Charles Schwab and Ascensus are considered parties-in-interest to the Plan.

Termination of the Plan – Although it has not expressed any intent to do so, the Company may terminate the Plan at any time subject to the provisions of the Plan and ERISA. If the Plan is terminated, the participants have a non-forfeitable interest in their accounts.

NOTE 2 – ACCOUNTING POLICIES

Basis of Accounting – The accompanying financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Risks and Uncertainties – The Plan provides for investments in securities that are exposed to various risks, such as interest rate, currency exchange rate, credit and overall market fluctuation. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of assets available for benefits.

Investment Valuation and Income Recognition – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Trustee determines the Plan's valuation policies utilizing information provided by the investment advisers, fiduciaries and custodians. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Distributions to Participants - Distributions to participants are recorded when paid.

Notes Receivable from Participants – Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. A participant loan will become immediately due and payable upon termination of employment. No allowance for credit loss has been recorded as of December 31, 2024 and 2023.

Excess Contributions Payable – Amounts payable to participants for contributions in excess of amounts provided for by the Plan or allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. Amounts contributed by the employer in excess of Plan provisions are recorded as a liability and are included in the Plan's Money Market account. Excess contributions payable totaled \$112,411 and \$58,213 as of December 31, 2024 and 2023, respectively.

Interest and Dividend Income – Interest income is recorded as earned on the accrual basis. Dividend income is recorded on the ex-dividend date.

Administrative Expenses – Administrative expenses paid directly by the Plan are applied against participant accounts of the Plan. The Plan pays substantially all administrative expenses of the plan, other than some professional fees, which are paid by the Plan Sponsor.

Subsequent Events - The Plan Administrators have evaluated events occurring subsequent to December 31, 2024 through November 11, 2025, the date of issuance of these financial statements.

NOTE 3 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access. The Plan's Level 1 assets consist of mutual funds invested in debt and equity securities and money market accounts valued using unadjusted quoted prices from active markets.

Level 2 – Inputs to the valuation methodology include 1) quoted prices for similar assets or liabilities in active markets; 2) quoted prices for identical or similar assets or liabilities in inactive markets; 3) inputs other than quoted prices that are observable for the asset or liability; 4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission ("SEC"). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. There have been no changes in the methodologies used at December 31, 2024.

NOTE 4 – PARTY-IN-INTEREST TRANSACTIONS

The Notes Receivable from Participants as of December 31, 2024 and 2023 in the amount of \$58,023 and \$90,970, respectively, are considered exempt party-in-interest transactions. The administrative expenses for services from the Plan's record keeper and fiduciary for the year ended December 31, 2024 in the amount of \$58,739 are also considered exempt party-in-interest transactions.

NOTE 5 – TAX STATUS

The IRS has determined by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's fiduciary believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

NOTE 6 – CERTIFIED INVESTMENTS

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Charles Schwab Trust Bank (the trustee of the Plan).
