## **INDEPENDENT AUDITOR'S REPORT**

To the Trustee of the

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audit of the financial statements of Karl Storz Imaging, Inc. Employees' Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of January 9, 2025 and December 31, 2024, and the related statement of changes in net assets available for benefits for the period from January 1, 2025 to January 9, 2025, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of January 9, 2025 and December 31, 2024, and for the period from January 1, 2025 to January 9, 2025 stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). **NOTE 1 - DESCRIPTION OF THE PLAN**

The following description of the Karl Storz Imaging, Inc. Employees' Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**(a) GENERAL**

The Plan is a defined contribution and savings plan for employees of Karl Storz Imaging, Inc. (the Company/Plan Sponsor). The Plan covers substantially all eligible employees, as defined by the Plan Agreement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan initially became effective on January 1, 1989, and was most recently amended effective January 1, 2025, to merge the Plan with the Karl Storz Endoscopy-America, Inc. Employee Savings Plan. All Plan assets and related participant balances were transferred to the receiving Plan on January 9, 2025. As a result of the merger, Karl Storz Imaging, Inc. Employees' Savings Plan ceased to exist as a separate plan subsequent to the transfer.

**(b) CONTRIBUTIONS**

A participant may elect to contribute up to 75% of annual compensation subject to Internal Revenue Services (IRS) regulation limitations. The Company matches participant contributions at a rate of 60% of the first 6.0% of participant compensation, as defined by the Plan agreement. The Company's matching contributions are allocated to participant accounts in accordance with the participant's designated fund allocation. In addition, the Company may elect to make contributions at year-end on a discretionary basis on behalf of all eligible employees. The Company did not make a discretionary contribution to the Plan for the period from January 1, 2025 to January 9, 2025.

**(c) PARTICIPANT ACCOUNTS**

Each participant's account is credited with the participant's contributions, Company matching contributions, an allocation of the Company's additional discretionary contribution and Plan earnings. Allocations are based on participant compensation. The benefit to which a participant is entitled is the participant's vested account balance. Forfeitures of terminated participants' non-vested accounts are used to reduce employer contributions or pay for the Plan's administrative expenses for the Plan year. No forfeited amounts were used to reduce plan expenses during the period from January 1, 2025 to January 9, 2025. The remaining forfeiture balance was transferred to the Karl Storz Endoscopy-America, Inc. Employee Savings Plan in January 2025. There were no available forfeitures at January 9, 2025. Available forfeitures at December 31, 2024 amounted to \$142,771.

**(d) VESTING**

Participants are immediately vested in their voluntary contributions plus earnings thereon. Vesting in the remainder of their account increases by 25% after completion of two years of continuous service. A participant is 100% vested after five years of continuous service.

**(e) NOTES RECEIVABLE FROM PARTICIPANTS**

Participants may borrow up to 50% of their vested accrued benefits subject to a minimum amount of \$1,000 and a maximum amount of \$50,000. Notes receivable from participants bear interest at a rate determined by the Plan committee based on the prevailing interest rates charged by persons in the business of lending money for loans, which would be made under similar circumstances. The notes receivable are secured by the participants' vested interest in the Plan. Notes receivable from participants must be paid back within five years unless the notes are for the purchase of a principal residence. On January 9, 2025, pursuant to the Plan Merger [see Note 1(a)], all participant loan balances were transferred to the Karl Storz Endoscopy-America, Inc. Employee Savings Plan.

**(f) PAYMENT OF BENEFITS**

On termination of service, a participant may elect to receive a single lump-sum payment of the value of his or her account, equal installments or an annuity for a period not exceeding life expectancy. Benefits are recorded when paid. There were no benefit claims for participants separated from service that have not yet been paid as of January 9, 2025.

**(g) ADMINISTRATIVE EXPENSES**

The Company incurs certain expenses in administering the Plan, which are not passed on as expenses of the Plan. Transaction and investment fund expenses are paid by the participants.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**(a) BASIS OF ACCOUNTING**

In 2024 the Plan adopted a policy of preparing its financial statements on the accrual method of accounting under accounting principles generally accepted in the United States of America (GAAP).

**(b) USE OF ESTIMATES**

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan administrator to make estimates and assumptions. Those estimates and assumptions affect the reported amounts of assets and liabilities, and the reported revenues and expenses during the period. Although the Plan administrator believes its estimates are appropriate, changes in assumptions utilized in preparing such estimates could cause these estimates to change sometime in the future.

**(c) RISKS AND UNCERTAINTIES**

The Plan utilizes various investment instruments, including mutual funds and a guaranteed investment contract. Investment instruments, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment instruments, it is reasonably possible that changes in the values of investment instruments will occur in the near term and that such changes could materially affect amounts reported in the financial statements.

**(d) INVESTMENT VALUATION AND INCOME RECOGNITION**

Investments are reported at fair value, except for fully benefit responsive investment contracts, which are reported at contract value. Contract value is the price at which Plan participants would transact in the contract. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Notes 4 and 5, respectively for discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the period/year.

**(e) NOTES RECEIVABLE FROM PARTICIPANTS**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and expensed when they are incurred. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the plan document. No allowance for credit losses has been recorded as of January 9, 2025 and December 31, 2024.

**(f) SUBSEQUENT EVENTS**

The Plan has evaluated events and transactions occurring subsequent to the statement of net assets available for benefits date of January 9, 2025, for items that should potentially be recognized or disclosed in these financial statements. The evaluation was conducted through November 13, 2025, the date these financial statements were available to be issued. No material events or transactions were noted to have occurred except for as disclosed in Note 1a.

**NOTE 3 - INVESTMENTS**

The Plan's funds are maintained by Voya Institutional Trust Company (Voya), the custodian of the Plan. The funds are credited with contributions and actual earnings on the underlying investments and charged for Plan withdrawals. The Plan's funds in the financial statements as of January 9, 2025 and December 31, 2024, are the values as reported to the Plan by Voya.

The following were certified as to being complete and accurate by Voya:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of January 9, 2025 and December 31, 2024.
- Net depreciation in fair value of investments as shown in the statement of changes in net assets available for benefits for the period from January 1, 2025 to January 9, 2025.

The Plan's independent auditors did not perform any auditing procedures with respect to this information, except for comparing such information to the related information included in the statements of net assets available for benefits and changes in net assets available for benefits and the supplementary schedule.

Participants may change their investment options at their discretion.

**NOTE 4 - FAIR VALUE MEASUREMENT**

The Plan adopts a fair value measurement accounting standard (the Standard) for those assets that are re-measured and reported at fair value at each reporting period. This standard establishes a single authoritative definition of fair value, sets out a framework for measuring fair value based on inputs used, and requires additional disclosures about fair value measurements. This standard applies to fair value measurements already required or permitted by existing standards.

The three levels of the fair value hierarchy under the Standard are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value:

- **Mutual Funds:** Valued at the closing price reported on the active market on which the individual securities are traded.
- **Self-Directed Brokerage Accounts:** Accounts include investments in mutual funds, corporate stocks and interest-bearing/non-interest-bearing cash. Mutual funds and common stocks are valued at the closing price reported on the active market on which the individual securities are traded. Cash is valued at the carrying amount which approximates its fair value at period/year end.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There have been no changes in the methodologies used at January 9, 2025, and December 31, 2025.

**NOTE 5 - INVESTMENT CONTRACT WITH INSURANCE COMPANY**

The Plan participated in a fully benefit responsive investment contract with Voya during the period from January 1, 2025 to January 9, 2025 and year ended December 31, 2024. Voya maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

**NOTE 6 - TAX STATUS**

The Plan obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with applicable requirements of the IRC, and therefore, believe that the Plan is qualified, and the related trust is tax-exempt. Therefore, no provision for income tax has been recorded in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 7 - EXEMPT PARTY-IN-INTEREST TRANSACTIONS**

Certain investment instruments are managed by Voya. Voya is a custodian as defined by the Plan; therefore, these transactions qualify as exempt party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund.

**NOTE 8 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon Plan termination, participants become 100% vested in employer contributions. As noted in Note 1(a), the Plan merged with the Karl Storz Endoscopy-America, Inc. Employee Savings Plan effective January 1, 2025, with all Plan assets and related participant balances transferred to the receiving Plan on January 9, 2025.

In the event the Plan is terminated, the assets will be allocated to each participant in the proportion each account balance bears to the total of all account balances.
