## **INDEPENDENT AUDITOR'S REPORT**

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of American HOWA Kentucky Inc. 401(k) Profit Sharing Plan & Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

### NOTE 1: DESCRIPTION OF THE PLAN

The following description of the American HOWA Kentucky Inc. 401(k) Profit Sharing Plan & Trust (the "Plan"), as adopted in 2008 and amended and restated in 2024, is provided for general information purposes only. Refer to Plan documents for a more complete description of Plan provisions.

#### ***General***

The Plan is a defined contribution plan covering all full-time employees of American HOWA Kentucky Inc. (the "Company"). The Plan is subject to the provisions of the Department of Labor's (DOL's) Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA). Plan Management determines the appropriateness of the Plan's investment offerings, and monitors investment performance.

Some administrative functions are performed by employees of the Company. No compensation is remitted to the Company for these services.

Plan assets are held and managed by Mid Atlantic Trust Company, the trustee and the qualified institution for the Plan, which invests contributions and Plan earnings and makes investment transactions as directed by Plan Management. Paychex acts as the third-party administrator and recordkeeper for the Plan, which performs certain plan administration, annual ERISA compliance testing and other recordkeeping services.

#### ***Eligibility***

The Plan covers only employees who are at least 21 years old and have completed at least three months of service. Once employees have met the eligibility requirements they may enter the Plan on the first day of the following month.

*Employee Elective Contributions* – Participants may contribute to the Plan through a pretax salary deferral up to 92% of their annual compensation, as defined in the Plan Agreement, not to exceed \$23,000 in 2024 and non-discrimination tests are met in accordance with the Internal Revenue Code §401(k). The salary deferral percentage can only be changed at the first of each month. Participants who have attained age 50 before the end of the Plan year are eligible to make additional \$7,500 catch-up contributions annually. Participants may also contribute amounts representing distributions from other qualified benefit or defined contribution plans (rollover).

*Employer Matching Contributions* – Matching contributions are the amounts contributed by the Employer to active participants who have made elective contributions during the Plan year. The matching contribution is 50% of participants' salary deferrals up to 10% of compensation.

*Employer Discretionary Profit Sharing Plan Contributions* – The Employer, at their sole discretion, may contribute amounts to the Plan in addition to any matching contributions. A discretionary profit sharing contribution was not made by the Company during the year ended December 31, 2024.

### **NOTE 1: DESCRIPTION OF THE PLAN (CONTINUED)**

#### ***Investment Options***

A participant may direct employer and employee contributions in any of approximately twenty funds available through Mid Atlantic Trust Company, the trustee. All investments are participant-directed.

#### ***Participant Accounts***

Each participant's account is credited with the participant's contributions and Company's matching contributions, as well as allocations of the Company's profit sharing contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### ***Vesting***

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in Company contributions plus actual earnings thereon is based on years of continuous service and hours of service. A year of credited service is working more than 1,000 hours during a calendar year. Participants become vested 100% in their accounts after three years of credited service.

#### ***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balances. The notes are secured by the balance in the participant's account and bear interest at the prime rate in effect at the origination of the note plus one percentage point or other rate as is prescribed by the Employer. The interest rate is fixed for the term of the note. Principal and interest is paid ratably through biweekly payroll deductions over terms ranging from 1 to 5 years, unless the note proceeds are used for the purchase of a primary residence.

#### ***Payments of Benefits***

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

### NOTE 1: DESCRIPTION OF THE PLAN (CONTINUED)

#### *Forfeitures*

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$0 and \$15, respectively. Forfeitures are used to reduce administrative expenses of the Plan, reduce future employer contributions, and/or allocated among eligible participants as additional contributions. During 2024, the company used \$3,038 to reduce administrative expenses of the Plan and allocated \$3,018 to eligible participants.

#### *Hardship Withdrawals*

As permitted by the Internal Revenue Code (IRC) and in accordance with the plan agreement, a participant may request a financial hardship withdrawal if they experience a severe financial hardship. The financial hardship withdrawal may not exceed the amount of the financial hardship or the value of the vested portion of the participant's balance, whichever is less.

### NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### *Basis of Accounting*

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP). The Financial Accounting Standards Board (FASB) provides authoritative guidance regarding U.S. GAAP through the Accounting Standards Codification (ASC) and related Accounting Standards Updates (ASUs).

#### *Use of Estimates*

The preparation of U.S. GAAP financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### *Investment Valuation and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Plan Management determines the Plan's valuation policies utilizing information provided by the investment advisers, third party administrator and trustee.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is reported on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation in investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

##### ***Notes Receivable from Participants***

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan agreement.

##### ***Payment of Benefits***

Distributions to participants are recorded when paid.

##### ***Administrative Expenses***

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation/depreciation of fair value of investments. During the year ended December 31, 2024, expenses of \$21,284 were paid by the Plan and allocated to participant accounts.

##### ***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in value of investment securities will occur in the near term and that these changes could materially affect amounts reported in the Plan's financial statements.

##### ***Subsequent Events***

Management has evaluated subsequent events through the date that the financial statements were available to be issued, November 10, 2025 and determined there were no events that occurred that require disclosure. No subsequent events occurring after this date have been evaluated for inclusion in these financial statements.

### NOTE 3: INFORMATION PREPARED AND CERTIFIED BY QUALIFIED INSTITUTION

The Plan Administrator has elected the method of compliance, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. The following financial information included in the Plan's financial statements was obtained by management and agreed to or derived from information certified as complete and accurate by Mid Atlantic Trust Company, the qualified institution:

- a) Total investments, at fair value, included in the statements of net assets available for benefits at December 31, 2024 and 2023.
- b) Net appreciation in fair value of investments and investment income information included in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- c) All amounts included in Note 4, *Fair Value Measurements*.
- d) All information included in the supplemental schedule of assets (held at end of year) as of December 31, 2024.

### NOTE 4: FAIR VALUE MEASUREMENTS

Fair value is the exchange price that would be received for an asset or paid to transfer a liability (exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. There are three levels of inputs that may be used to measure fair values:

*Level 1:* Quoted prices (unadjusted) for identical assets or liabilities in active markets that the entity has the ability to access as of the measurement date.

*Level 2:* Significant other observable inputs other than Level 1 prices, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs, other than quoted prices, that are:
  - observable; or
  - can be corroborated by observable market data.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3:* Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

### NOTE 4: FAIR VALUE MEASUREMENTS (CONTINUED)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Money Market fund:* Valued at fair value on a daily basis by the market value of the underlying investments held by the fund account at year-end.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan Administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in different fair value measurements at the reporting date.

### **Notes to Financial Statements**

#### **NOTE 5: TAX STATUS**

The Plan has adopted a prototype non-standardized profit sharing plan with a cash or deferral arrangement which received a favorable advisory letter from the Internal Revenue Service dated April 10, 2014, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **NOTE 6: RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Mid Atlantic Trust Company, the trustee of the Plan, provides investment and custodial services to the Plan. Edward Jones provides investment guidance to the plan. The Plan paid direct fees of \$7,987 to these vendors during the year ended December 31, 2024 for investment services. The Plan paid direct fees of \$12,100 to Paychex, Inc. during the year ended December 31, 2024. Paychex Inc., provides recordkeeping, and administrative services to the Plan, records interest and dividend income, and makes distributions and loans to participants; therefore, these transactions qualify as party-in-interest transactions.

#### **NOTE 7: PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.
