### Notes to Financial Statements

---

#### Note 1. Plan Description

The following description of the CraftMark Bakery, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan covering substantially all employees of CraftMark Bakery, LLC (the Company), who are age 21 or older and have completed three months of service. The Retirement Plan Committee is responsible for the oversight of the Plan. The Retirement Plan Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions:** Each year, participants may contribute up to 90% of pretax annual compensation, as defined by the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Company contributes a non-elective Safe Harbor contribution equal to 100% of the amount a participant contributes to the first 3% of plan compensation plus 50% of the amount a participant contributes between 3% and 5% of plan compensation. The Company may also make a discretionary contribution to the Plan at the end of the plan year. No discretionary employer contributions were made to the Plan for the year ended December 31, 2021. Contributions are subject to limitations.

**Investment options:** Upon enrollment in the Plan, a participant may direct employee contributions in a variety of investment choices as more fully described in the Plan's literature. Participants may change their investment options at any time.

**Participant accounts:** Each participant's account is credited with the participant's contribution and Company's Safe Harbor matching contribution, and allocations of: (a) the Company's discretionary contribution, if any, (b) plan earnings, (c) forfeitures of terminated participants' non-vested accounts and (d) administrative expenses. Allocations are based on participant earnings or account balances or compensation, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting:** Participants are immediately vested in their contributions and the Company's Traditional Safe Harbor contributions plus earnings thereon. Vesting in the Company's matching contributions other than the Traditional Safe Harbor contributions is based on years of continuous service, as defined. A participant is 100% vested after six years of credited service.

**Payment of benefits:** On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a 10-year period. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

**Mandatory distributions:** The Plan provides mandatory distributions for terminated employee participants with account balances less than \$5,000. Account balances less than \$1,000, may receive a cash distribution, otherwise account balances will be distributed to a participant directed IRA.

**Forfeitures:** Forfeitures are used to reduce future employer contributions or pay Plan expenses. Forfeited nonvested accounts total were not significant at December 31, 2021 and 2020, respectively. No forfeitures were used to reduce employer matching contributions or pay administrative expenses during 2021.

**Note 1. Plan Description (Continued)**

**Notes receivable from participants:** Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range up to five years or over a reasonable period of time for the purchase of a participant's primary residence, as established by the Plan Administrator at the time of the loan. The loans are secured by the vested balance in the participant's account and bear interest commensurate with local prevailing rates as determined by the Plan Administrator. These rates range from 5.25% to 7.50% on loans outstanding at December 31, 2021. Principal and interest are paid ratably through weekly payroll deductions.

**Note 2. Significant Accounting Policies**

**Basis of accounting:** The financial statements of the Plan are prepared under the accrual method of accounting.

**Accounting estimates:** The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

**Investment valuation and income recognition:** Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan determines its valuation policies utilizing information provided by the Plan's investment trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investment securities are exposed to various risks, such as interest rate, market, and credit risk. Due to the level of risks associated with certain investments securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near-term and such changes could materially affect participant account balances and the amount reported in the statements of net assets available for benefit.

**Notes receivable from participants:** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make the schedule repayments and the Plan Administrator deems the participant to be in default, the participant's note receivable is reduced, and a benefit payment is recorded based on the terms of the Plan. As of December 31, 2021, an allowance for credit losses of approximately \$98,400 was recorded. No allowance for credit losses was recorded as of December 31, 2020.

**Excess contributions payable:** Participant contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction in contributions.

**Payment of benefits:** Benefits are recorded when paid.

**Expenses:** Certain expenses of maintaining the Plan are paid directly by the Sponsor and are excluded from these financial statements. Administrative expenses include fees related to the administration of notes receivable that are charged directly to the participant's account and certain recordkeeping fees paid by the Plan. Investment related expenses are included in net appreciation of fair value investments.

**Subsequent events:** The Plan has evaluated subsequent events for potential recognition and/or disclosure through September 18, 2023, the date the financial statements were available to be issued.

**Note 3. Information Certified by Reliance Trust Company**

The following is a summary of the investment information as of December 31, 2021 and 2020, and for the year ended December 31, 2021, included throughout the Plan's financial statements and supplemental ERISA-required schedule obtained by management and agreed to or derived from information certified by Reliance Trust Company (the trustee) of the Plan. The Plan Administrator has obtained certifications from the trustee that information provided to the Plan Administrator by the trustee related to the following investments is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information that appears throughout the financial statements and ERISA-required supplemental schedule related to the following assets:

**Note 4. Fair Value Measurements**

The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under Accounting Standards Codification (ASC) 820 are described below:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

**Registered investment companies (mutual funds):** Valued at the daily closing price as reported by the funds. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Common collective trust stable value fund:** A stable value fund that is composed primarily of fully benefit-responsive investment contracts that is valued at the net asset value of units of the collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchase and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issue reserves the right to require 12 months' notification in order to ensure that securities liquidation will be carried out in an orderly business manner.

#### Note 5. Related Party and Party-in-Interest Transactions

Automatic Data Processing, Inc. (ADP) is the recordkeeper as defined by the Plan and, therefore, transactions with the recordkeeper qualify as party-in-interest transactions. Fees paid by the Plan for the recordkeeping services amount to \$35,017 for the year ended December 31, 2021.

The Sponsor also paid certain administrative expenses of the Plan. These amounts are not material to the financial statements.

#### Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

#### Note 7. Tax Status and Uncertain Tax Positions

Effective August 1, 2016, the Plan adopted a non-standardized form of prototype plan sponsored by ADP. The prototype plan received an opinion letter from the Internal Revenue Service (IRS) as to the prototype plan's qualified status. The prototype plan opinion letter has been relied upon by this Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code. (IRC).

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken any significant uncertain tax positions that more likely than not would not be sustained up examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
