Management is responsible for maintaining a current plan instrument, including all plan amendments. Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audits of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audits* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing audits in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audits.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. - Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

Other Matter — Supplemental Schedule Required by ERISA

The supplemental schedule, Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

1. Plan Description

The following description of the Moderne Glass Company, Inc. 401(k) & Profit Sharing Plan (the “Plan” and “Plan Administrator”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General and Eligibility

The Plan is a defined contribution plan covering all eligible employees of Moderne Glass Company, Inc. (the “Company” and “Plan Sponsor”) who have completed one year of service and are age eighteen or older. The Plan does not cover employees whose employment is governed by a collective bargaining agreement.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

The Plan provides that employees electing to participate may contribute to the Plan, through pretax and post-tax payroll deferrals, a selected percentage of compensation as defined by the Plan. Due to limitations imposed by the Internal Revenue Code (IRC), the aggregate amount of deferrals with respect to any participant cannot exceed \$23,000 for 2024 and \$22,500 for 2023. A participant that has reached the age of 50 by the end of the tax year may contribute an additional \$7,500 for 2024 and 2023 as a catch-up contribution.

The Company contributions are discretionary. Discretionary Company contributions are allocated based on participant compensation to total compensation for all eligible participants. In order to receive a discretionary Company contribution, an employee must have worked 1,000 hours during the plan year and be employed on the last day of the plan year or have separated from employment during the plan year and completed more than 500 hours of service. The Company authorized discretionary profit sharing contributions of \$60,000 for both 2024 and 2023, which were processed on May 23, 2025 and June 4, 2024.

Participant Accounts

Each participant’s account is credited with a) participant’s contributions, b) allocation of the employer discretionary contribution, and c) Plan earnings less applicable expenses. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Investment Options

Participants direct the investment of their contributions into various investment options offered by the Plan.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 100 percent vested after six (6) years of credited service based upon a two to six year graded term in accordance with the Plan document; or immediately if a) employment is terminated due to death or disability, b) retirement upon attaining age 65, or c) Plan termination.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or annual installments. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

Withdrawal of a portion of a participant's account is permitted due to an immediate and heavy financial need.

Forfeited Accounts

Forfeitures of non-vested Company contributions will be used to reduce future employer discretionary contributions. There were no forfeitures applied to the employer profit sharing during 2024 and 2023. The balance remaining in the forfeiture account at December 31, 2024 and 2023 was approximately \$15,018 and \$2,285, respectively.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan have been prepared in accordance with accounting principles generally accepted in the United States of America.

Investment Valuation and Income Recognition

Investments of the Plan are stated at fair value (see Note 5), except for the fully benefit-responsive investment contract, which is reported at contract value (see Note 6). The fair value of the financial instrument is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchase and sales of investments within the Plan are reflected on a trade date basis.

Dividend income is recorded on the ex-dividend date. Interest income is recorded using the effective interest method.

The net appreciation/(depreciation) in fair value of investments is the difference between the quoted market value of the Plan's investments at the end of the year compared to the quoted market value of such investments at the beginning of the year.

Use of Estimates

The preparation of financial statements in accordance with generally accounting principles requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, the actual amounts could materially differ from those estimates. Any adjustments applied to the estimated amounts are recognized in the year in which such adjustments are determined. Significant estimates include fair value measurements of Plan investments.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

Related Party Transactions/Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of the Plan are charged directly to the participants' accounts and are included in administrative expenses. Investment-related expenses are included in net (depreciation)/appreciation in fair value of investments.

The Company entered into an Administrative Services Agreement (the Agreement) with TransAmerica Financial Life Insurance Company (Transamerica). Transamerica Retirement Solutions (TARS), an affiliate of TransAmerica, is the third party administrator. This agreement includes a revenue-sharing arrangement whereby TransAmerica shares revenue generated by the Plan in excess of their fee. Deposits relating to the revenue-sharing arrangement are invested in the guaranteed income fund, and are used to pay other Plan expenses with any remaining amounts reallocated to participants. On October 1, 2024, the Company entered into an Agreement with Principal Life Insurance Company (PLIC). PLIC, a member of the Principal Financial Group, is the third party administrator. There is no revenue-sharing arrangement with PLIC.

Activity related to income, revenue sharing, and expenses for the years ended December 31, 2024 and 2023 include revenue sharing transfers in of \$0 and \$46,781, and transfers out to pay direct fees of \$24,581 and \$30,307, respectively.

Plan Expenses

Plan expenses consisted of \$24,581 and \$30,307 in administrative service fees, and \$16,000 and \$14,500 in accounting and professional fees for the years ended December 31, 2024 and 2023, respectively.

Payment of Benefits

Benefit payments are recorded when paid.

4. Tax Status

The Plan document, which was amended and restated effective April 22, 2022, which previously received a favorable opinion letter from the Internal Revenue Service dated June 30, 2020. It is the opinion of the Plan Administrator that the Plan and its underlying trust have operated within the terms of the Plan and are qualified under the applicable provisions of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or the Department of Labor (DOL). Management has evaluated the Plan's design and operation and has concluded that the Plan is designed and has been operated in compliance with the applicable requirements of the IRC. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

5. Fair Value Measurements

The Plan reports its assets at fair value based on a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under the Financial Accounting Standards Board's ("FASB") Accounting Standards Codification ("ASC") 820 are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in an active market that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include; a) quoted prices for similar assets or liabilities in active markets; b) quoted prices for identical or similar assets or liabilities in inactive markets; c) inputs other than quoted prices that are observable for the asset or liability; d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Investments Trusts

The Principal Lifetime Hybrid Funds ("Collective Investments Trusts") are collective investments trusts that seeks capital growth and current income by investing mainly in common stocks of midsize and large U.S. companies with a focus on value stocks that offer the potential for capital growth, current income or both. The fund may use derivatives such as futures, options, warrants and swap contracts, although they do not represent a primary focus of the fund.

The Plan uses the net asset value ("NAV") per share of the Stable Value Fund and Collective Investments Trusts provided by the trustee as a practical expedient to estimate fair value. The practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the funds, the trustee reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner. The funds' units are issued and redeemed daily at the constant NAV of \$1 per unit. The funds' investment objective is stability of principal and high current income.

The valuation methods described above may provide a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. While the Plan believes its valuation methods are appropriate and consistent with other market participants, it is possible that different fair value measurements may arise due to the use of different methodologies or assumptions in determining the fair value measurement at the reporting date.

6. Pooled Separate Account, Group Annuity Contract and Stable Value Fund

Principal's Pooled Separate Account is a fully benefit-responsive investment, and is reportable at contract value in the defined contribution plan's financial statements.

The Pooled Separate Account can be described as:

1. A Pooled Separate Account Balance will be established for each Participant for each type of Contribution directed to each Pooled Separate Account.
2. Retirement funds may be directed to the Pooled Separate Account Balances in any proportion. Changes in investment direction to these Balances can be made at any time as allowed by the Plan or trust.
3. Investment results on retirement funds invested in the Pooled Separate Account is net after Operating expenses and Management Fees. The Pooled Separate Account contains no guarantee of investment performance.

Principal's Group Annuity Contract is a fully benefit-responsive investment, and is reportable at contract value in the defined contribution plan's financial statements.

The Group Annuity Contract can be described as:

1. Contract value represents contribution made under the contract, plus earnings, less participant withdrawals and administrative expenses.
2. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.
3. The group annuity contract is presented on the face of the statement of net assets available for benefits at contract value.
4. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Transamerica's Stable Value Account is a fully benefit-responsive investment, and is reportable at contract value in the defined contribution plan's financial statements.

6. Pooled Separate Account, Group Annuity Contract and Stable Value Fund (cont.)

The Transamerica Stable Value Account can be described as:

1. The Stable Value Account investment choice is a non-tradable obligation of Transamerica. The investment's contract or proceeds cannot nor will not be assigned or sold to another party without the consent of Transamerica.
2. The repayment of principal and interest credited to participants holding the investment is a financial obligation of Transamerica. However, if an event should ever occur such that realization of full contract value for a particular investment contract is no longer probable.
3. The terms of Transamerica's Group Annuity Contract require all permitted participant-initiated transactions involving the investment to occur at contract value with no conditions, limits or restrictions. Permitted participant-initiated transactions are those allowed by the underlying defined contribution plan such as withdrawals for benefits, loans or transfers to other investment choices within the plan.
4. Since the Stable Value Account investment choice is an obligation of Transamerica, the occurrence of an event that limits the ability of the investment to transact at contract value between Transamerica and a participant holding the investment is not probable.
5. The Stable Value Account investment choice allows a participant reasonable access to their assets.

7. Information Certified by the Plan's Custodian

Certain information related to investments are disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments from mutual funds, was obtained by management and agreed to or derived from information certified as complete and accurate by Transamerica Retirement Solutions and Principal Life Insurance Company (qualified institutions and trustees of the Plan). The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

8. Transactions with Parties-in-Interest

Certain Plan investments were managed by TARS. These transactions qualify as party-in-interest transactions. Fees paid by the Plan for custodial and recordkeeping services were \$24,581 and \$30,307 for the years ended December 31, 2024 and 2023, respectively. Effective October 1, 2024, all Plan investments were transferred to PLIC and there are no parties-in-interest transactions.
