Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Defined Contribution Plan of Mid-South Transportation Management, Inc. (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Defined Contribution Plan of Mid-South Transportation Management, Inc.'s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Notes to the Financial Statements

For the Years Ended December 31, 2024 and 2023

1. DESCRIPTION OF PLAN:

The following brief description of the Defined Contribution Plan of Mid-South Transportation Management, Inc. (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established effective July 1, 2015. The Plan covers all employees of Mid-South Transportation Management, Inc. who are age 18 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The MATA Retirement Board is responsible for oversight of the Plan.

Eligibility

Eligible employees for the Plan are those employees hired after July 1, 2008 who were participants in Plan B of the Organization's defined benefit plan (i.e. all employees hired on or after July 1, 2008) and all new hires from July 1, 2015. Eligible employees are eligible to participate as of date of employment and participation in the Plan is mandatory as a condition of employment.

Contributions

Each year, participants may contribute a percentage of pretax annual compensation, as defined in the plan document, up to the maximum limits of the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participants are required to make a mandatory contribution of 8% of the employee's compensation. Compensation is defined in the same manner as in the Organization's defined benefit plan, that is W-2 wages excluding overtime, paid sick leave hours, paid bonuses or commissions, and any other form of incentive or contingent compensation. Additionally, the Plan has a 401(k) feature where an employee can elect voluntarily to contribute an amount above the mandatory 8% of compensation, subject to the ERISA 401(k) contribution limit.

The Organization's non-elective contributions to the Plan are a non-discretionary 8% of the employee's compensation. The Organization will not make an additional contribution to the 401(k) feature in the Plan.

Employee and employer contributions are recorded in the period during which the Organization makes payroll deductions from Participants' compensation.

Participant accounts

Each participant's account is credited with the participant's contributions and an allocation of the Plan's earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Administrative Costs

The Plan pays certain administrative expenses of the Plan out of the assets of the Plan to the extent not paid by the employer. Administrative expenses include contract administrator, plan audit, recordkeeper, legal, and trustee.

Vesting

Participants are immediately 100% vested in their contributions plus actual earnings thereon. Vesting in the Organization's contributions portion of their accounts is based on years of service for purposes of vesting when they are credited with 1,000 hours of service during a Plan year. A participant is 100% vested after 3 years of vesting service.

Notes receivable from participants

Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$N/A or 75% percent of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate, determined monthly, is set at the Prime rate, as defined. Principal and interest are paid ratably through payroll deductions. Terms range up to 10 years or greater for the purchase of a primary residence.

Participants may borrow up to the lesser of \$50,000 or 50% of their vested account balance. The minimum amount that can be borrowed is \$1,000. The loans are secured by the balance in the participant's account and bear interest at 0% + prime interest rate. Principal and interest is repaid ratably through payroll deductions.

Forfeitures

The non-vested portion of account balances are forfeited upon distribution of the vested portion. Forfeitures are used to offset Plan administrative expenses or may be used to reduce the employer contributions. At December 31, 2024 and 2023, investments include forfeitures with a value of \$66,311 and \$62,516, respectively. During the years ended December 31, 2024 and 2023, forfeitures of \$106,519 and \$30,000 were used to reduce employer contributions and offset Plan administrative expenses, respectively.

Payment of benefits

On termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account.

At normal retirement age, the participants are fully vested in their aggregate contribution accounts. Normal retirement age is when the participant reaches the age 65 and completion of the fifth anniversary of their participation in the Plan. Participants who terminate employment as a result of being permanently disabled while an employee, will receive a percentage of their account balance based on the Plan's vesting schedule.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America and the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company, as applicable. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan's investments in mutual funds and collective investment trust funds are stated at their fair value. The mutual funds and collective investment trust funds are valued at the net asset value (NAV) of shares held by the Plan at year end. Investment earnings are based on the changes in the NAV.

The Plan's investments in pooled special accounts are established and maintained by Principal Trust Company, the custodian of the Plan. The pooled special accounts are valued at the net asset value (NAV) of shares held by the Plan at year end. Investment earnings are based on the changes in the NAV.

Investment expenses charged to the Plan for investments are charged directly against the assets of the Plan and are not separately reflected. Consequently, investment expenses are reflected as a reduction of investment return for such investments.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred.

Investment Risk

The Plan offers participants a variety of investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the amounts reported in the statements of net assets available for plan benefits.

Payment of Benefits

Benefits are recorded when paid.

Termination Withdrawals Due To Participants

As of December 31, 2024, there were \$- in participant balances that are payable to participants who had elected to withdraw from the Plan. These funds to be repaid after this year end.

New Accounting Standards

No new accounting standards were adopted during the year ended December 31, 2024.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Organization. Expenses that are paid by the Organization are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

Date of Management's Review

Subsequent events were evaluated through November 17, 2025, the date the financial statements were available to be issued.

3. FAIR VALUE MEASUREMENTS:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820, *Fair Value Measurement*, are described as follows:

Level 1 - Inputs to the valuation technique are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation technique include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common stocks: Valued at the closing price reported on the active market on which the individual securities are traded.

Pooled separate accounts: Valued based upon the unit values of such pooled accounts held by the Plan at year end. Unit values are based on the fair value of the underlying assets of the fund derived from inputs principally from or corroborated by observable market data by correlation or other means, although are not based upon quoted market prices in an active market. The underlying investments of the pooled separate accounts consist of mutual funds, each of which follows a separate investment strategy. Due to the nature of these pooled accounts, there are no unfunded commitments or redemption restrictions.

4. INFORMATION CERTIFIED BY TRUSTEE:

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, Principal Financial Group, the Trustee of the Plan, has certified to the completeness and accuracy of all investments reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the supplemental Schedule H, Part IV, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity reported in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.

5. RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS:

Certain Plan investments are managed by the Trustee, and therefore, these transactions qualify as party-in-interest transactions.

Additionally, the Plan issues loans to participants, which are secured by the participant's account balances. These transactions qualify as party-in-interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the Organization. No such officer or employee receives compensation from the Plan.

Principal Trust Company is the custodian as defined by the Plan and, therefore, Plan transactions through Principal qualify as party-in-interest transactions. These transactions are exempt from the prohibited transaction rules of ERISA.

6. PLAN TERMINATION:

Although it has not expressed any intent to do so, the Organization has the right under the Plan to terminate the Plan subject to the provisions of ERISA.

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA and subject to any applicable provisions of any collective bargaining agreement between the Organization and its union. In the event of Plan termination, all participants would become 100% vested in their employer contributions.

7. TAX STATUS:

The Plan adopted a prototype plan offered by Mid-South Transportation Management, Inc. The prototype plan received an IRS Determination Letter dated August 4, 2017, that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the IRS Determination Letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore believes that the Plan is qualified, and the related trust is tax exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

The Plan is intended to be qualified under applicable sections of the Internal Revenue Code ("IRC") and, therefore, exempt from federal income taxes. The Plan obtained its latest determination letter on August 4, 2017, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has not been amended since receiving the determination letter.

Accounting principles generally accepted in the United States of America require plan management to evaluate the tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is not subject to routine audits by taxing jurisdictions for the fiscal year beginning before 2021.


