### ***Opinion***

Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Barbizon Lighting Company, Inc. Employee Stock Ownership Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Barbizon Lighting Company, Inc. Employee Stock Ownership Plan's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audits.

Our audits were conducted for the purpose of forming an opinion on the financial statements as a whole. The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, including its form and content, is presented in conformity with the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying supplemental schedule is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content are presented in conformity with the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

**Note 1 Description of the Plan**

The following description of the Barbizon Lighting Company, Inc. Employee Stock Ownership Plan (“Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

**General**

ZGS, Inc. (“Company” or “Sponsor”) d/b/a Barbizon Lighting Company, Inc., established the Barbizon Lighting Company, Inc. Employee Stock Ownership Plan effective as of February 1, 1999. The Plan covers employees of Barbizon Delta Corporation, Barbizon Charlotte, Inc., Barbizon Light of New England, Inc., Barbizon Electric Co., Inc., Barbizon Light of the Rockies, Inc. and Barbizon Capitol, Inc. These companies are all related parties under common ownership (“affiliates”). The Plan operates, in relevant part, as a non-leveraged employee stock ownership plan (ESOP), and is designed to comply with Section 4975(e)(7) and the regulations of the Internal Revenue Code (“IRC”) and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan is administered by an Employee Benefits Administrative Committee appointed by the Board of Directors of the Company.

**Employer Contributions**

Contributions are made at the discretion of the Board of Directors and are received in cash and/or the Company’s common stock, issued in amounts sufficient to satisfy the liability at the date of the contribution. Contributions are allocated to individual employee participant balances based on each employee’s annual compensation as a percentage of total covered employee compensation in accordance with applicable regulations under the code.

For the year ended December 31, 2024, the Sponsor made a cash contribution of \$969,440 to the Plan. There were additional contributions of \$9,941 and \$28,638 that were recorded as other employer contributions for the year ended December 31, 2024.

**Eligibility**

Employees of the Company, and its participating affiliates, are generally eligible to participate in the Plan on January 1<sup>st</sup> or July 1<sup>st</sup> following the later of completing six months of service and attaining age twenty and one-half. Participants who do not have at least 1,000 hours of service during such plan year, or are not employed on the last working day of a plan year, are generally not eligible for an allocation of Company contributions for such year. Employees covered under a collective bargaining agreement or leased employees are not eligible to participate in the Plan.

**Payment of Benefits**

No distributions from the Plan will be made until a participant retires, dies (in which case, payment will be made to his or her beneficiary or, if none, his or her legal representatives), becomes permanently disabled while still an employee or otherwise terminates employment with the Company and its participating subsidiaries. Distributions are made in cash.

**Note 1 Description of the Plan (continued)**

**Voting Rights**

The Employee Benefits Administrative Committee has the voting rights of all of the stock held by the Plan on all matters, other than those which require the voting of such shares with respect to the approval or disapproval of any corporate merger or consolidation, re-capitalization, reclassification, liquidation, dissolution or sale of substantially all assets of the Company. If an action does require the voting of such shares, the Employee Benefits Administrative Committee will be entitled to exercise the voting rights of the Company stock allocated to participants' accounts.

**Participant Accounts**

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited as of the last day of each Plan year with an allocation of shares of the Company's common stock released by the Trustee from the unallocated account and forfeitures of terminated participants' non-vested accounts. Only those participants who are eligible employees of the Company as of the last date of the Plan year will receive an allocation. Allocations are based on a participant's eligible compensation, relative to total eligible compensation. Plan earnings are allocated to each participant's account based on the ratio of the Participant's account balance.

**Vesting**

On or after January 1, 2007, a participant becomes vested at a rate of 20% coincident with the completion of the second year of service and an additional 20% each year thereafter until becoming 100% vested after 6 years of service. Participants who commenced employment prior to February 1, 1999 will be credited for years of service for vesting purposes as follows: 20 or more, 4 years; 15 to 20, 3 years; 10 to 15, 2 years; 5 to 10, 1 year; 0 to 5, 0 years. Those participants become vested at a rate of 20% coincident with the completion of the third year of service and an additional 20% each year thereafter until becoming 100% vested after 7 years of service. In addition, upon retirement, permanent disability, or death before retirement, the participant will be fully vested, regardless of years of service. Effective January 1, 2007, a participant who dies while performing "quality military service" is considered to have died while employed by the Company and therefore, is fully vested.

**Put Option**

Under Federal income tax regulations, the employer stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is valued at the fair market value as of the most recent valuation to date of the receipt of the notice of exercise of the option. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

**Note 1 Description of the Plan (continued)**

**Diversification**

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company stock into investments which are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first 5 years, a participant may diversify up to 25% of the number of shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50%. Participants who elect to diversify receive a cash distribution.

**Forfeitures**

Plan forfeitures are allocated to each participant's account based upon the relation of the participant's eligible compensation to total eligible compensation for the Plan year. Forfeitures allocated to participants during December 31, 2024 and 2023, totaled \$89,221 and \$6,658, respectively. Forfeited non-vested accounts to be allocated to participants in future years as of December 31, 2024 and 2023, were \$0, respectively.

**Note 2 Summary of Significant Accounting Policies**

**Basis of Presentation**

The financial statements of the Plan are prepared in conformity with accounting principles generally accepted in the United States of America ("GAAP") and, accordingly, are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with GAAP requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates. The investment in the shares of the Sponsor is a significant estimate made by Plan management.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurement.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

The Plan pays costs of services rendered on behalf of the Plan. Expenses that are paid by the Company are excluded from these financial statements.

**Note 3 Fair Value Measurement**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value:

*Sponsor company common stock*

The fair value of the Sponsor company common stock is based on an annual independent appraisal. This appraisal was based on a combination of the market and income valuation approaches consistent with prior years. The appraiser took into account historical and projected cash flow and net income, return on assets, return on equity, weighted average cost of capital, market comparables, and estimated fair value of company assets and liabilities. The appraisal also considers the lack of marketability of the Sponsor company common stock in determining its fair value.

There have been no changes in methodologies used at December 31, 2024 and 2023.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 4 Tax Status**

The Internal Revenue Service (“IRS”) has determined and informed the Company by a letter dated March 17, 2017, that the Plan is qualified and the trust established under the Plan is tax-exempt, under the appropriate sections of the IRC. The Plan has been amended since receiving the determination letter. However, the Plan Administrator and the Plan’s tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan Administrator and the Plan’s tax counsel believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions, there are currently no audits for any tax periods in progress.

**Note 5 ERISA Fidelity Bond**

ERISA, Title I, Section 412 requires the Plan to carry ERISA Fidelity Bond coverage in the amount of the lesser of 10% of the total assets at the beginning of the plan year or \$1,000,000. At January 1, 2023, the Plan did not have adequate coverage. Subsequently by September 2024, the Plan secured adequate coverage.

**Note 6 Plan Termination**

The Company reserves the right to terminate the Plan at any time, subject to Plan provisions. Upon such termination of the Plan, the interest of each participant in the trust fund will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan terms and the IRC. In the event of Plan termination, all participants will become 100% vested in their accounts.

As a result of a reduction of the Plan Sponsor’s workforce, due to the COVID-19 pandemic, the Plan experienced a partial plan termination in 2020, as defined by ERISA. All affected participants were fully vested in their accounts.

**Note 7 Risks and Uncertainties**

The Plan invests in the Sponsor company’s common stock, which is exposed to various risks such as interest rate, market, and credit risks as well as valuation assumptions based on earnings, cash flows and/or other such techniques. Due to the level of risk associated with the investment in the Sponsor company’s stock and to uncertainties inherent in estimates and assumptions, it is at least reasonably possible that changes in the value of the Sponsor’s company stock will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

**Note 8 Related Party Transactions and Party-In-Interest Transactions**

The Plan invests in the Company's shares of common stock. This is a related party and a party-in-interest transaction. The Plan has a number of service providers paid from the Plan. Such providers are also considered parties-in-interest under ERISA. In addition, pursuant to ERISA Sections 3(14)(A), (C) and (H), the Company, as Sponsor of the Plan, the owner of the corporate stock of the Company and the Trustee of the Plan are considered to be parties-in-interest of the Plan.

The Plan acquired 100 shares of ZGS, Inc. for \$842,841 based upon an appraisal at date of acquisition, February 1, 1999.

On August 8, 2018, the Plan entered into an Employee Stock Ownership Trust Contribution Agreement with the Company. The agreement provides that the Plan Sponsor shall set aside 372.673469 treasury shares of the Company for the sole purpose of contributing to the Plan to the maximum extent legally permitted under applicable laws. The number of shares to be contributed is the lesser of the following:

- a. The maximum annual amount the Company is permitted to deduct as an expense on its federal income tax return,
- b. The maximum amount that may be credited during a calendar year in accordance with the maximum annual additions limitations set forth in Section 415 of the Internal Revenue Code of 1986, as amended, or
- c. The maximum amount that can be contributed to the Plan without triggering taxation under Code Section 409(p).

On August 14, 2018, the Plan Sponsor transferred 229 shares of common stock of the Company with a value of \$3,068,600 in accordance with the above agreement.

On January 1, 2019, the Plan Sponsor transferred 144 shares of common stock of the Company with a value of \$2,273,700 in accordance with the above agreement.

On October 21, 2019, 89 shares of common stock of the Company were redeemed from a shareholder, then on October 22, 2019 these same shares were contributed to the Plan with a value of \$1,429,587.
