## **Independent Auditor's Report**

To the Administrative Committee of the

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audit of the accompanying financial statements of LMC Enterprises Money Purchase Pension Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the Statements of Net Assets Available for Benefits as of February 20, 2025, and December 31, 2024, the related Statement of Changes in Net Assets Available for Benefits for the period from January 1 to February 20, 2025, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of February 20, 2025, and December 31, 2024, and for the period from January 1 to February 20, 2025, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1. Description of Plan

The following description of the LMC Enterprises Money Purchase Pension Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a frozen defined contribution money purchase pension plan that covered all eligible employees of LMC Enterprises (the Employer) who had completed one year of service and were at least 21 years of age. Effective December 31, 2024, the Plan was restated and consequently, the Plan was frozen, and no new enrollees or contributions were permitted in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). Empower Trust Company, LLC, and Empower Annuity Insurance Company of America are the Plan's Trustee and Insurer, respectively.

Effective February 20, 2025, the Employer resolved to merge the Plan into the LMC Enterprises 401(k) Plan, also sponsored by the Employer. As a result of the merger, all participant accounts and related assets of the Plan merged into the LMC Enterprises 401(k) Plan. On February 20, 2025, \$22,740,919 of plan assets were transferred out of the Plan and into the LMC Enterprises 401(k) Plan, and consequently, the Plan ceased to exist.

**Contributions**

Effective December 31, 2024, the Plan was frozen and contributions to the Plan are no longer permitted. Prior to December 31, 2024, participants were not permitted to voluntarily contribute into the Plan, however, they may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover contributions). The Plan's funding policy was to allocate employer contributions into participant accounts based on participant classifications and eligible compensation as defined in the Plan and subject to certain Internal Revenue Service (IRS) limitations. Participants directed the investment of their contributions into various investment options offered by the Plan. Pursuant to the Plan being frozen, there were no contributions to the Plan for the period from January 1 to February 20, 2025.

**Participant Accounts**

Each participant's account is credited with allocations of the Employer's contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Vesting in the Employer's contribution portion of their accounts is based on years of continuous service. A participant vests 20 percent after completion of two years of credited service and vests an additional 20 percent each year thereafter until they are 100 percent vested after six years of credited service.

### **Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account. There were no outstanding loans as of February 20, 2025. Principal and interest is paid ratably through payroll deductions.

### **Payment of Benefits**

Upon retirement, death, disability, attainment of age 59 ½ or termination of employment, a participant may elect to receive the vested balance in the participant's account in a lump sum, an annuity, a partial distribution, or it may be rolled into a different individual retirement account. Certain income tax penalties may apply to withdrawals or distributions prior to age 59 ½. The Employer is permitted to involuntarily cash-out and rollover terminated participant account balances from the Plan and into an individual retirement account if they are \$5,000 or less. There were no payments of benefits to participants or their beneficiaries for the period from January 1 to February 20, 2025.

### **Forfeited and Unallocated Accounts**

These accounts were used to reduce employer contributions prior to the Plan being frozen or are used to pay plan expenses. At February 20, 2025, there were no forfeited nonvested or unallocated accounts. At December 31, 2024, forfeited nonvested and unallocated accounts totaled \$48,953, respectively.

## 2. Summary of Significant Accounting Policies

### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

### **Investment Valuation and Income Recognition**

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). The Plan Sponsor determines the Plan's valuation policies utilizing information provided by the Trustee and Insurer. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded for the plan year ended.

### **Payment of Benefits**

Benefits are recorded when paid.

### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Investment-related expenses are included in the net appreciation in fair value of investments.

### **Subsequent Events**

The Plan has evaluated subsequent events through November 11, 2025, the date the financial statements were available to be issued.

### **3. Fair Value Measurement**

5. Certified Information

Certain information related to investments and notes receivable from participants presented in the financial statements, accompanying notes to the financial statements, and supplemental Schedule H, Line 4i – Schedule of Assets (Held at End of Year) was certified as complete and accurate by Empower Trust Company, LLC, and Empower Annuity Insurance Company of America, the Trustee and Insurer of the Plan, respectively. As permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA, the plan administrator has instructed the Plan’s independent auditors not to perform auditing procedures with respect to the certified information, except for comparing such information included in the financial statements and supplemental schedule.

The information certified by the Trustee and Insurer includes the balances of investments held and notes receivable from participants as of February 20, 2025, and December 31, 2024, and related investment earnings and interest income on notes receivable from participants for the period from January 1 to February 20, 2025.

6. Group Annuity Contract with Insurance Company

The Plan entered into a traditional fully benefit-responsive guaranteed investment contract with the Insurer that totaled \$1,160,474 as of December 31, 2024. The Insurer maintained the contributions in a general account. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer and is reviewed on a quarterly basis for resetting.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by the Insurer, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan’s ability to receive amounts due is dependent on the issuer’s ability to meet its financial obligations. The issuer’s ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan’s prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) the premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

7. Tax Status

The IRS has determined and informed the Employer by a letter dated November 14, 2022, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Party-in-Interest Transactions

Certain Plan investments are managed by the Trustee and Insurer of the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions.

5. Certified Information

Certain information related to investments and notes receivable from participants presented in the financial statements, accompanying notes to the financial statements, and supplemental Schedule H, Line 4i – Schedule of Assets (Held at End of Year) was certified as complete and accurate by Empower Trust Company, LLC, and Empower Annuity Insurance Company of America, the Trustee and Insurer of the Plan, respectively. As permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA, the plan administrator has instructed the Plan’s independent auditors not to perform auditing procedures with respect to the certified information, except for comparing such information included in the financial statements and supplemental schedule.

The information certified by the Trustee and Insurer includes the balances of investments held and notes receivable from participants as of February 20, 2025, and December 31, 2024, and related investment earnings and interest income on notes receivable from participants for the period from January 1 to February 20, 2025.

6. Group Annuity Contract with Insurance Company

The Plan entered into a traditional fully benefit-responsive guaranteed investment contract with the Insurer that totaled \$1,160,474 as of December 31, 2024. The Insurer maintained the contributions in a general account. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer and is reviewed on a quarterly basis for resetting.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by the Insurer, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan’s ability to receive amounts due is dependent on the issuer’s ability to meet its financial obligations. The issuer’s ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan’s prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) the premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

7. Tax Status

The IRS has determined and informed the Employer by a letter dated November 14, 2022, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Party-in-Interest Transactions

Certain Plan investments are managed by the Trustee and Insurer of the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions.

## **Independent Auditor's Report**

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

Management has obtained a certification from a qualified institution as of February 20, 2025, and December 31, 2024, and for the period from January 1 to February 20, 2025, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

1. Description of Plan

The following description of the LMC Enterprises Money Purchase Pension Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a frozen defined contribution money purchase pension plan that covered all eligible employees of LMC Enterprises (the Employer) who had completed one year of service and were at least 21 years of age. Effective December 31, 2024, the Plan was restated and consequently, the Plan was frozen, and no new enrollees or contributions were permitted in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). Empower Trust Company, LLC, and Empower Annuity Insurance Company of America are the Plan's Trustee and Insurer, respectively.

Effective February 20, 2025, the Employer resolved to merge the Plan into the LMC Enterprises 401(k) Plan, also sponsored by the Employer. As a result of the merger, all participant accounts and related assets of the Plan merged into the LMC Enterprises 401(k) Plan. On February 20, 2025, \$22,740,919 of plan assets were transferred out of the Plan and into the LMC Enterprises 401(k) Plan, and consequently, the Plan ceased to exist.

**Contributions**

Effective December 31, 2024, the Plan was frozen and contributions to the Plan are no longer permitted. Prior to December 31, 2024, participants were not permitted to voluntarily contribute into the Plan, however, they may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover contributions). The Plan's funding policy was to allocate employer contributions into participant accounts based on participant classifications and eligible compensation as defined in the Plan and subject to certain Internal Revenue Service (IRS) limitations. Participants directed the investment of their contributions into various investment options offered by the Plan. Pursuant to the Plan being frozen, there were no contributions to the Plan for the period from January 1 to February 20, 2025.

**Participant Accounts**

Each participant's account is credited with allocations of the Employer's contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Vesting in the Employer's contribution portion of their accounts is based on years of continuous service. A participant vests 20 percent after completion of two years of credited service and vests an additional 20 percent each year thereafter until they are 100 percent vested after six years of credited service.

### **Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account. There were no outstanding loans as of February 20, 2025. Principal and interest is paid ratably through payroll deductions.

### **Payment of Benefits**

Upon retirement, death, disability, attainment of age 59 ½ or termination of employment, a participant may elect to receive the vested balance in the participant's account in a lump sum, an annuity, a partial distribution, or it may be rolled into a different individual retirement account. Certain income tax penalties may apply to withdrawals or distributions prior to age 59 ½. The Employer is permitted to involuntarily cash-out and rollover terminated participant account balances from the Plan and into an individual retirement account if they are \$5,000 or less. ### **Forfeited and Unallocated Accounts**

These accounts were used to reduce employer contributions prior to the Plan being frozen or are used to pay plan expenses. At February 20, 2025, there were no forfeited nonvested or unallocated accounts. At December 31, 2024, forfeited nonvested and unallocated accounts totaled \$48,953, respectively.

## 2. Summary of Significant Accounting Policies

### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

### **Investment Valuation and Income Recognition**

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Sponsor determines the Plan's valuation policies utilizing information provided by the Trustee and Insurer. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. ### **Payment of Benefits**

Benefits are recorded when paid.

### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Investment-related expenses are included in the net appreciation in fair value of investments.

### **Subsequent Events**

The Plan has evaluated subsequent events through November 11, 2025, the date the financial statements were available to be issued.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan’s ability to receive amounts due is dependent on the issuer’s ability to meet its financial obligations. The issuer’s ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan’s prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) the premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

7. Tax Status

The IRS has determined and informed the Employer by a letter dated November 14, 2022, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Party-in-Interest Transactions

Certain Plan investments are managed by the Trustee and Insurer of the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions.
