As a result, **PAL-Tech, Inc. 401(k) Retirement Plan** changed its basis of accounting from the going-concern basis of accounting to the liquidation basis of accounting for the year ended December 31, 2024 and the period ended March 5, 2025. Our opinion is not modified with respect to these matters.

1. Description of plan

PAL-Tech, Inc. 401(k) Retirement Plan (the Plan) was a defined contribution, profit sharing plan covering substantially all employees of the plan sponsor, PAL-Tech, Inc. (the Company). It was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Plan management was responsible for oversight of the Plan, determined the appropriateness of the Plan's investment offerings, and monitored investment performance.

The following description of the Plan provides only general information. The Plan agreement and summary plan description should be referred to for a more complete description of the Plan's provisions.

The Board of Directors of PAL-Tech, Inc. approved a resolution on November 13, 2024 to transfer the Plan's assets into a successor retirement plan and effectively liquidate and terminate PAL-Tech, Inc. 401(k) Retirement Plan upon the transfer of all Plan assets. In accordance with the resolution for liquidation, all Plan assets were transferred by March 5, 2025 and the Plan was effectively liquidated and terminated.

Contributions and funding

Following the liquidation resolution on November 13, 2024 described above, contributions and funding to the Plan concluded by November 30, 2024 and remittances into the successor retirement plan began effective December 1, 2024.

Participant accounts

Each participant's account was credited with the (a) participant's contribution, (b) allocations of the Company's contribution and (c) investment earnings, net of administrative expenses. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

Vesting

Participants were vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's employer matching and profit-sharing contributions was 100 percent vested automatically upon contributing.

Payment of benefits

Upon death, termination due to disability, retirement, or termination of employment, a participant or participant's beneficiary could elect to receive his/her vested account balance in one of the following methods: (1) lump sum, (2) direct rollover into an individual retirement account (IRA) or other qualified plan, or (3) a combination of non-rollover and direct rollover. Vested account balances of \$5,000 or less would be distributed in a lump sum payment and vested account balances greater than \$1,000 will be rolled over to an IRA upon distributable event, unless directed otherwise by the participant or participant's beneficiary. Pre-retirement withdrawals were allowed for participants who had attained age 59½, or who had a qualifying hardship subject to the plan agreement.

Notes receivable from participants

Participants could borrow from their fund accounts up to a maximum equal to the lesser of 50% of the participant's vested account balance or \$50,000. The loans were secured by the balance in the participant's account and bear interest at rates which were commensurate with local prevailing rates as determined by the plan administrator. Payments were due at least quarterly and were allocated to principal and interest.

Forfeited accounts

These funds were available to reduce employer contributions and to pay Plan administrative expenses. At March 5, 2025 and December 31, 2024, there were no forfeited non-vested accounts.

2. Summary of accounting policies

Basis of accounting

As described in Note 1, the Board of Directors of PAL-Tech, Inc. approved a resolution on November 13, 2024 to transfer the Plan's assets into a successor retirement plan, and the Plan began liquidation shortly thereafter. As a result, PAL-Tech, Inc. 401(k) Retirement Plan changed its basis of accounting for periods ended after November 13, 2024, from the going concern basis to the liquidation basis in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP). The change to the liquidation basis of accounting did not result in any modification to the carrying values of plan assets or the recognition of plan liabilities.

Use of estimates

The preparation of financial statements in conformity with U.S. GAAP required management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates and assumptions.

Investment valuation and income recognition

The Plan's investments were stated at fair value in the financial statements. Fair value of the financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities were recognized principally on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation or depreciation included the Plan's gains and losses on investments bought and sold as well as held during the period.

Notes receivable from participants

Notes receivable from participants were measured at the unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and were expensed when they were incurred.

Contributions receivable and allowance for credit loss

Contributions receivable from participants and employer would be recognized in the period related to the participant's service or compensation. There were no contributions receivable as of March 5, 2025 or December 31, 2024.

Payment of benefits

Benefits were recorded when paid.

Administrative expenses

Certain expenses of maintaining the Plan were paid directly by the Company and were excluded from these financial statements. Fees related to the administration of notes receivable from participants were charged directly to the participant's account and were included in administrative expenses. Investment-related expenses were included in the net appreciation of fair value of investments.

3. Information certified by the trustee

The Plan administrator elected the alternative method of compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA). Accordingly, as permitted under such election, the investment information certified by Fidelity Management Trust Company (Fidelity) was not audited by the independent auditors except for comparing such information to the related information included in the accompanying financial statements and supplemental schedule.

The Plan's financial information that was certified by Fidelity is summarized as follows:

- a) Plan investments as of March 5, 2025 and December 31, 2024 of \$0 and \$10,778,061, respectively;
- b) Notes receivable from participants as of March 5, 2025 and December 31, 2024 of \$0 and \$48,864, respectively; and
- c) Net investment income of \$287,670 for the period ended March 5, 2025.

4. Investments at fair value

The Plan classified its investments into Level 1, which refers to securities valued using quoted prices from active markets for identical assets; Level 2, which refers to securities not traded on an active market but for which observable market inputs are readily available; and Level 3, which refers to securities valued based on significant unobservable inputs. Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement.

Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs. The following section describes the valuation methodologies the Plan used to measure its assets at fair value.

Investments in money market and mutual funds were valued at the daily closing price as reported by the fund. Money market and mutual funds held by the Plan were open-ended mutual funds that were registered with the Securities and Exchange Commission. These funds were required to publish their daily net assets value (NAV) and to transact at that price.

Investments in registered investment companies (mutual funds) were valued at the daily closing price as reported by the fund. Mutual funds held by the Plan were open-end mutual funds that were registered with the Securities and Exchange Commission. These funds were required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan were deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while plan management believed its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There were no Plan assets held as of March 5, 2025.

5. Plan termination

The Company had the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan termination, participants would become 100% vested in their employer contributions. See Note 1 for further information on the Plan's termination.

6. Party-in-interest transactions

The Plan invested in shares of registered investment companies managed by Fidelity. A portion of the income, or loss, of the Plan was derived from these investments. Fees paid by the Plan to the trustee for certain investment management fees were deducted from the net asset values of the registered investment companies held by the Plan. Fidelity is the trustee and recordkeeping for the Plan and, therefore, the transactions qualify as party-in-interest transactions.

7. Tax status

The IRS determined and informed the plan sponsor by a letter dated June 30, 2020, that the Plan was designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan had been amended since receiving the advisory opinion, the Plan administrator believed that the Plan was designed, and operated, in compliance with the applicable requirements of the IRC and, therefore, believed that the Plan was qualified, and the related trust was exempt.

In accordance with authoritative guidance issued by the FASB, the plan administrator was required to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan had taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The plan administrator analyzed the tax positions taken by the Plan, and concluded that as of March 5, 2025 there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan remains subject to routine audits by taxing jurisdictions. However, there are currently no audits for any tax periods in progress. The Plan is subject to income tax examinations for years ended December 31, 2022 through the period ended March 5, 2025.

8. Risks and uncertainties

The Plan invested in various investment securities. Investment securities were exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it was at least reasonably possible that changes in the values of investment securities would occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits as of December 31, 2024.
