Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of First Carolina Management, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year then ended December 31, 2024, and the related notes to the financial statements.

Notes to the Financial Statements

Note 1 - Description of Plan and Summary of Significant Accounting Policies

General - First Carolina Management, Inc. 401(k) Plan (the "Plan") became effective as of January 1, 1994. . First Carolina Management, Inc. is the Plan's sponsor. The Plan is a defined contribution plan covering all employees of First Carolina Management, Inc. who have at least one year of service with First Carolina Management, Inc. and are at least age 21. In addition, part-time employees who meet the age requirements and perform at least 500 hours of service for three consecutive years are also eligible to contribute to the plan; however, part-time employees are not eligible for employer contributions. Entry dates for the Plan are January 1 and July 1. The Plan is subject to the provisions of the Employees Retirement Income Security Act of 1974 ("ERISA"). Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

Basis of Accounting - The financial statements of the Plan are prepared using the accrual method of accounting.

Use of Estimates - The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Participant Accounts - Each participant's account is credited with the participant's contribution and an allocation of (a) the Company's contribution and (b) Plan earnings.

Contributions - The Plan allows employees to voluntarily contribute through payroll deduction. Employees can contribute up to 100% of compensation as defined in the Plan. However, the total amount contributed may not exceed a limit set annually by law (\$23,000 for 2024). Participants who are age 50 or older may contribute an additional \$7,500 "catch-up" contribution. Rollovers from other pension plans are also allowed.

The Company may elect to make a matching contribution to the Plan. During 2024, the Company elected to contribute ten percent of the first six percent of compensation that a participant contributes to the Plan. Company matching contributions are deposited annually. Participants direct investment of all contributions into various investment options offered by the Plan.

Vesting - Participants are immediately vested in their contributions plus actual earnings thereon. Participants eligible to participate in the Plan on July 1, 2005 are 100% vested in the Company's matching contribution plus actual earnings thereon. Participants eligible after July 1, 2005 are vested based on years of continuous service.

Vesting is determined as follows:

Less than 2 years	0%
2 years but less than 3	20%
3 years but less than 4	40%
4 years but less than 5	60%
5 years but less than 6	80%

Note 1 - Description of Plan (Continued)

Forfeited Accounts - Forfeited amounts attributable to employer matching contributions are reallocated first to the restoration of rehired participant's forfeitures, secondly to reduce employer matching contributions and thirdly to offset Plan expenses. During the year ended December 31, 2024 the Plan sponsor used \$2,593 of forfeited nonvested accounts toward trustee fees. During the year ended December 31, 2023 no amounts were used towards trustee fees. At December 31, 2024 and 2023 there was \$-0- and \$1,410, respectively, in forfeited nonvested accounts.

Investment Valuation and Income Recognition- Investments held at December 31, 2024 and 2023 are shown at fair market values as certified by the Plan's trustees, American Trust Company and Mid Atlantic Trust Company.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income are recorded when received. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investment Options - Upon enrollment in the Plan, a participant may direct employee contributions in any whole percentage in any of the investment options provided by the Plan. Participants may change their investment options at any time. Participants should refer to the enrollment package for more information on the above investment options.

Payment of Benefits - Benefits are recorded when paid.

Notes Receivable from Participants - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Additional security will be required for loan requests in excess of the maximum. The loans are secured by the balance in the participant's account and bear interest at a rate that would be expected to be charged by a bank or other professional lender in a similar circumstance. Loan terms range from 1-5 years with possible additional time granted for the purchase of a primary residence. Principal and interest are paid ratably through payroll deduction not less frequently than quarterly. The loans are valued at amortized cost.

Date of Management's Review – Subsequent events were evaluated through November 12, 2025, which is the date the financial statements were available to be issued.

Note 2 - Investments

A schedule of investments is presented on page 12 of these financial statements. During the year ended December 31, 2024, the Plan's investments (including investments bought, sold, and held during the year) appreciated in value by \$197,133 as follows:

Note 3 - Information Prepared and Certified by the Trustee

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, reportable transactions and net appreciation in fair value of investments, dividends and money market and participant loan interest for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by the Plan's trustee, American Trust Company, as well as the Plan's form trustee, Mid Atlantic Trust Company.

Note 4 - Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. FASB ASC 820 Fair Value Measurements and Disclosures establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has ability to access.

Level 2

Inputs to the valuation methodology include:

- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Note 4 - Fair Value Measurements (Continued)

Following is a description of the valuation methodologies used for assets measured at fair value.

Money market, Mutual funds: Valued at the daily closing prices reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believed its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 - Tax Status

The Plan is adopted from a prototype document prepared by AT Retirement Services, LLC. The prototype document has received a favorable tax determination letter dated June 30, 2020 from the Internal Revenue Service. However, the Plan sponsor has not applied for a separate determination letter specifically for the adopted Plan, but believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code. The Plan utilized the IRS Employee Plans Compliance Resolution System's Self-Correction Program to correct this error and the Plan administrator believes this issue has been properly addressed. Accordingly, no taxes have been provided for in the accompanying statements.

Note 5 - Tax Status (Continued)

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the U.S. federal or state taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are no audits for tax periods in progress.

Note 6 - Administrative Expenses

Administrative expenses of the Plan are paid by both the Plan and the Plan's sponsor. Administrative expenses paid by the Plan, primarily recordkeeping fees and distribution fees, totaled \$8,705 for the year ended December 31, 2024. These fees are recorded as administrative expenses in the statement of net assets available for benefits. The Plan sponsor paid certain other Plan expenses, including additional recordkeeping fees and audit fees.

Note 7 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan at any time subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

Note 8 – Related Party Transactions

The Plan Sponsor provides certain accounting, administrative, and investment management services to the Plan for which no fees are charged.

Note 9 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 10 – Subsequent Events

The Plan sponsor did not make its matching contribution for the year ended December 31, 2024 until October 28, 2025, which is after the due date, including extensions, of the tax return. The audit was subsequently completed and the Form 5500 was amended to include the audited financial statements.
