NOTES TO THE FINANCIAL STATEMENTS

1. DESCRIPTION OF THE PLAN

The following description of Dick Anderson Construction, Inc. Health & Welfare Benefit Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

General The Plan provides health and other benefits to eligible employees of Dick Anderson Construction, Inc. and its subsidiaries (collectively, the Company) who are regularly scheduled to work a minimum of 30 hours per week or 130 hours per month and covered dependents as elected. Hourly employees receive credit into an hour bank for continuation of coverage in the event of a temporary layoff or termination. Terminated employees, or their qualified beneficiaries, may elect to continue this coverage under the Consolidated Omnibus Budget Reconciliation Act of 1965 (COBRA) by paying required timely premiums. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974 (ERISA)*.

Benefits The Plan provides medical, prescription drug, dental, and vision benefits to Plan participants. Additional benefits provided to participants of the Plan are administered outside of the trust and are fully insured. They include:

Life, Accidental Death and Disability, Long-Term, and Short-Term Disability Benefits: These benefits are provided by Mutual of Omaha. The Company contributes 100% of the premiums for core coverage under these benefits. Participants may also elect additional coverage, which is employee-paid.

Health Savings Account (HSA): The Plan provides for HSA accounts that are tax-advantaged, member-owned accounts allowing participants to save pre-tax dollars for qualified medical expenses. The Company contributes a discretionary amount determined annually. Contributions are limited to maximums established annually by the Internal Revenue Service (IRS).

Flexible Spending Account (FSA): The Plan provides for FSA accounts that are tax-advantaged allowing participants to save pre-tax dollars for qualified medical expenses or dependent care expenses. Contributions are limited to maximums established annually by the IRS.

Contributions The Company makes contributions to the Plan as needed to fund claims. Contributions are determined based on expected experience ratings as determined by the third-party claims processor. Any deficiency of the Plan's net assets over benefit obligations is funded by the Company on a pay-as-you-go basis.

Payment of Benefits The third-party claims processor disburses claim payments that are determined to be due to the person or assignee entitled thereto in accordance with provisions of the Plan. The Plan pays the third-party claims processor an administrative fee for these services.

Plan Termination The Company may amend or terminate the Plan at any time subject to the provisions of the Plan and ERISA. No amendment or termination may discontinue or curtail the benefits that have accrued to any participant or beneficiary prior to the adoption of such amendment or termination. Upon termination of the Plan, all funds of the Plan shall be used to pay all benefits accrued under the Plan and to pay additional benefits for participants as determined by the Plan administrator. No assets of the Plan may revert to the Company or be used for purposes other than for the exclusive benefit of the Plan's participants.

Stop-Loss Coverage The Plan has entered into a stop-loss insurance agreement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as aggregate exposure for all claims).

2. SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting The Plan uses the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates The preparation of financial statements in conformity with GAAP requires the Plan administrator to make estimates and assumptions that affect certain reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Credit Risk Deposits with financial institutions that potentially subject the Plan to concentrations of credit risk consist of cash deposits. The Plan's bank account is insured by the Federal Deposit Insurance Corporation up to \$250,000. At December 31, 2024 and 2023, the bank balances exceeded their insured limits by \$1,889,410 and \$1,999,966, respectively.

Fair Value Measurements The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Interest-Bearing Cash: Interest-bearing cash consists of deposits held in a checking account. The balance is valued at face value, which approximates fair value due to the liquid nature and immediate availability of the funds. The carrying amount of interest-bearing cash represents the amount the Plan would receive upon demand as of the reporting date.

Investment in Captive Insurance: The Plan holds a minority investment in Foundation Health Insurance Ltd., a privately held captive insurance company. The investment does not have a readily determinable fair value due to the absence of an active market for the shares and transfer restrictions imposed by the agreement. The fair value of the investment is measured using the cost method, as management believes cost approximates fair value in the absence of observable market transactions.

Payment of Benefits Premiums paid by either the Company or the trust are recorded as premium payments on the accompanying statements of changes in net assets available for benefits. Claims payments are recorded when paid by the third-party claims processor. Amounts due to claims processors that have not been reimbursed by the Plan are recorded as payable to claim administrators on the accompanying statements of net assets available for benefits.

Expenses The Plan pays administrative expenses that consist primarily of fees paid to third-party claims administrators and other professional services. These expenses are reported on the statements of changes in net assets available for benefits as administrative expenses and consulting and other fees. All other administrative expenses are paid by the Company on behalf of the Plan and are excluded from these financial statements.

Stop-Loss Coverage Premiums for stop-loss insurance are included in reinsurance premiums expense on the accompanying statements of changes in net assets available for benefits. Stop-loss refunds totaling \$1,034,770 and \$1,771,595 have been netted with claims paid on the accompanying statements of changes in net assets for the years ended December 31, 2024 and 2023, respectively.

Rebates Rebates are recorded as received by the Plan. They are presented with claims paid - net on the accompanying statements of changes in net assets available for benefits. Rebates totaling \$282,312 and \$246,355 have been netted with claims paid on the accompanying statements of changes in net assets for the years ended December 31, 2024 and 2023, respectively.

Reclassifications Certain amounts in the December 31, 2023, financial statements have been reclassified for comparative purposes to conform to the presentation in the December 31, 2024, financial statements.

Evaluation of Subsequent Events The Plan has evaluated subsequent events through November 14, 2025, the date the financial statements were available to be issued.

There were purchases of level 3 investments totaling \$20,000 and \$-0-, for the years ended December 31, 2024 and 2023, respectively.

4. BENEFIT OBLIGATIONS

Plan benefit obligations for health claims incurred but not reported are estimated by Alliant Employee Benefits at present value, calculated by multiplying actual claims reported by factors provided by their actuary.

The Plan's benefit obligations consist of amounts currently payable for health claims incurred but not reported for both active employees and separated employees who are participating through COBRA. The obligations will be funded by Company contributions and stop-loss reimbursements.

5. RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan has several arrangements with service providers which are considered party-in-interest transactions under ERISA.

6. TAX STATUS

The trust funding certain benefits of the Plan received an exemption letter from the IRS dated November 16, 2021, stating that the Plan was tax exempt under the provisions of Section 501(c)9 of the *Internal Revenue Code* (IRC). However, as a result of the Plan's funding policy, from time to time, the trust may be subject to income taxes. No federal or state income taxes have been recorded in 2024 and 2023 for unrelated business taxable income.

In addition, the Plan and the trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the trust. The Plan administrator believes that the Plan is operating in compliance with the applicable requirements of the IRC. Therefore, they believe that the related trust is tax exempt.

7. RISKS AND UNCERTAINTIES

The present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

9. PLAN AMENDMENTS

Effective January 1, 2024, the Plan has been amended to include Chanen Construction as a participating employer. All employees of Chanen Construction who met the eligibility requirements as defined by the Plan document were eligible to participate immediately.

Effective January 1, 2024, the Plan was further amended to expand its schedule of benefits to include coverage for certain services related to naturopathy, holistic and homeopathic medicine, and massage therapy.

10. SUBSEQUENT EVENT

Effective February 4, 2025, the Plan entered into an agreement with Foundation Health Insurance, Ltd., a captive insurance stop-loss provider, to replace its previous stop-loss coverage with Blue Cross Blue Shield of Montana.
