Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Jupiter Aluminum Corporation 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate to the best of their knowledge and belief.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

Notes to Financial Statements

Note 1. Plan Description

The following description of Jupiter Aluminum Corporation 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan for the benefit of eligible employees of Jupiter Aluminum Corporation, Jupiter Coil Coating Division and Jupiter Oxygen Corporation (collectively, the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Investment Committee is responsible for oversight of the Plan.

Eligibility: Employees who have attained 21 years of age and have completed one year of service (defined as 1,000 hours worked within a 12-month period) are eligible to participate in the Plan. Eligible participants may enter the Plan on the first day of the month coinciding with or the next following date that eligibility requirements are met. Those who defer compensation to contribute to the Plan are eligible to receive Company matching contributions immediately.

Contributions: Eligible participants are automatically enrolled in the Plan upon meeting the eligibility requirements if a formal election not to participate is not made by the employee. An automatic deferral of 2% is deferred from eligible compensation of all new employees that become eligible and do not provide a formal election to the Plan. The deferral percentage automatically increases by 1% each year until it reaches the maximum of 12% of eligible compensation or the Internal Revenue Code (IRC) limit in accordance with Plan provisions, unless the participant elects to opt out of the automatic increase. A participant may elect to make before-tax contributions or Roth after-tax contributions up to 90% of eligible compensation, subject to limitations by the IRC limit. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants are allowed rollover contributions from other qualified defined benefit or contribution plans.

The Company makes safe-harbor matching contributions equal to 100% of the participant's contribution up to 5% of the participant's eligible compensation. This contribution is calculated and remitted on a pay-period basis and a true-up contribution calculated at year-end, if any. The Company may also make separate discretionary matching and profit sharing contributions. Company discretionary matching contributions are calculated based on the ratio of participant contributions to compensation for the plan year. There were no Company discretionary matching and profit sharing contributions during the plan year 2024. Contributions are subject to certain limitations.

Participant accounts: Each participant's account is credited with the participant's contributions, Company safe-harbor matching contribution, Company discretionary matching contribution, if any, as well as allocations of the Company profit sharing contribution, if any, and plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings (losses), account balances, or specific transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting: Participants are immediately fully vested in participant and Company safe-harbor matching contributions, plus actual earnings thereon. Participants vest in the Company's discretionary matching and profit sharing contributions and earnings thereon based on years of continuous service. A participant vests 20% after one year of credited service and vests an additional 20% each year thereafter until the participant is fully vested after five years of credited service. In the event of death, disability or retirement at designated ages, participants become fully vested.

Note 1. Plan Description (Continued)

Forfeited accounts: At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$3,805 and \$3,699, respectively. These accounts may be used to pay plan expenses or reduce any Company contribution. For the year ended December 31, 2024, there was no usage of the forfeited nonvested accounts.

Investment options: Upon enrollment in the Plan, a participant may direct contributions in a variety of investment choices as more fully described in the Plan's literature. Participants may change their investment options at any time.

Other income: The Plan has a revenue agreement with ADP Retirement Services (ADP), whereby the Plan receives revenue-sharing payments from ADP to pay administrative expenses that the Plan incurs. For the year ended December 31, 2024, the Plan earned \$43,597 from this revenue sharing agreement, all of which were used to pay administrative expenses. As of December 31, 2024 and 2023, the balance in the Plan Administrator account which holds these revenue-sharing payments totaled \$36 and \$32, respectively.

Payment of benefits: Benefits under the Plan are payable to participants or their beneficiaries upon death, retirement, disability, or termination of employment. A participant's vested accrued benefit shall be paid in the form of a lump sum or installment payments. In-service withdrawals are permitted by the Plan upon attainment of age 59½ or by determination that a financial hardship, as defined, has been incurred. The Plan provides that vested account balances less than \$5,000 are automatically distributed as a lump-sum payment without participant consent.

Notes receivable from participants: Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000, reduced by the greatest note balance outstanding during the prior 12 months, or 50% of their vested account balances. A participant may only have one note outstanding at any given time. The loan repayment period is not to exceed five years except for the purchase of a principal residence which can be for 30 years. The loans are collateralized by the balance in the participant's account and bear an interest rate of 1% over the prime rate published in *The Wall Street Journal* on the first business day of the month before the loan is originated. Principal and interest are paid through payroll deductions.

Note 2. Summary of Significant Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Accounting estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Contributions: Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Delinquent loans are treated as distributions based upon the terms of the plan document.

Note 2. Summary of Significant Accounting Policies (Continued)

Investment valuation and income recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Payment of benefits: Benefits are recorded when paid.

Expenses: Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of a receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation or depreciation in fair value of investments.

Subsequent events: The Plan has evaluated subsequent events for potential recognition and/or disclosure through November 14, 2025, the date the financial statements were available to be issued.

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include the following:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Shares of registered investment companies: Valued at the daily closing price as reported by the fund. Shares of registered investment companies held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The shares of registered investment companies held by the Plan are deemed to be actively traded.

Units of common/collective trusts: Valued based on the NAV of units of the common/collective trusts. The NAV, as provided by the trustee, is used as a practical expedient to estimating fair value. The NAV is based upon the fair value of the underlying investments comprising the trust less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Changes in fair value levels: To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another.

Plan management evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no transfers in or out of Level 3.

Note 5. Related-Party and Party-in-Interest Transactions

The Plan's investments are held by and invested by Reliance Trust Company, the trustee, as defined by the Plan. ADP Retirement Services is the recordkeeper. UBS Financial Services Inc. is the investment advisor. These transactions qualify as party-in-interest transactions. Total administrative expenses paid by the Plan to service providers totaled \$117,243 for the year ended December 31, 2024.

Certain administrative expenses are paid by the Company. Certain employees of the Company provide administrative services to the Plan. These employees are not paid by the Plan.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their Company contribution.

Note 7. Tax Status

The Plan has adopted a preapproved plan document that has received an opinion letter from the Internal Revenue Service dated October 6, 2020, stating that the form of the preapproved plan document was in compliance with applicable requirements of the IRC. The Plan has been amended since adopting the preapproved plan document; however, the Plan Administrator believes the Plan is designed, and is being operated, in compliance with the applicable requirements of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9. Nonexempt Transactions

During 2024, the Company inadvertently failed to deposit approximately \$1,600 of participant contributions within the required time frame as stated by the United States Department of Labor (DOL) regulations. The Company intends to deposit lost interest to correct this failure in 2025. The Company intends to file Form 5330 and intends to pay the applicable excise tax to the IRS. The correction and excise taxes will be made from the Company's assets and not from assets of the Plan.
