INDEPENDENT AUDITOR'S REPORT

To the Members of the
Administrative Committee of the
Invacare Retirement Savings Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Invacare Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note D to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Invacare Retirement Savings Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Invacare Retirement Savings Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Supplemental Schedule Required by ERISA

The supplemental schedule of assets (held at end of year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

December 31, 2024 and 2023

A. Description of the Plan

The Plan is a defined contribution plan, which was established in recognition of the contribution made to Invacare Corporation's (the "Company") successful operation by its employees. The purpose of the Plan is to provide benefits to the participants in this Plan upon their retirement, termination of employment, or the happening of certain contingencies, as defined.

All employees of the Company and employees of participating employers, as defined, are eligible to participate in the Plan on the enrollment date coinciding with or following the date of hire. Those employees covered by a collective bargaining agreement, nonresident aliens, temporary employees, and independent contractors are not eligible to participate in the Plan.

Participants may direct up to 50% of their future compensation not be paid to them but instead to be contributed to the Plan on a pre-tax basis, subject to IRS limitations. The Company may, at its discretion, match 100% on the first percent of elected 401(k) deferrals, and 50% on each of the next two additional percentages of elected 401(k) deferrals for participants who have completed six months of service ("matching contributions"). In addition, for each calendar year quarter, the Company may, at its discretion, make an employer contribution to the Plan on behalf of each participant who has completed six months of service and is eligible for this quarterly discretionary contribution ("IQC") as defined by the Plan. A participant is deemed to have completed six months of service if the participant is in the employment of a participating employer at any time six months after the date of hire. The amount of the Company's IQC, if any, is equal to 1% of each participant's eligible compensation paid during the calendar quarter. No IQC contribution was made in 2024 or 2023.

Participants direct the investment of their account, together with their share of the Company's matching contributions and IQC, into various investment options offered by the Plan. Participants are able to transfer funds among all investment options, subject to certain limitations on the timing of such transfers as may be imposed by the respective investment option.

All participant contributions and related earnings are immediately 100% vested. Participants become 20% vested in Company matching and quarterly contributions and related earnings each year of service until the fifth year of service, at which point a participant's account is 100% vested.

If a participant's employment is terminated before completing five years of vesting services, all or part of the amount credited to the employer contribution account under the Plan may be forfeited. At the sole discretion of the Company, forfeitures may be used to pay any expense incurred in connection with the administration of the Plan or to reduce future employer contributions to the Plan. At December 31, 2024 and 2023, unused forfeited non-vested accounts totaled \$132,143 and \$127,574, respectively. During 2024 and 2023, \$86,953 and \$51,749 of non-vested forfeited amounts were used to reduce employer contributions and pay administrative expenses, respectively.

A. Description of the Plan - Continued

In the event of the death or disability of a participant, such participant shall become fully vested to the extent of the amount credited to the participant's account. Participants who retire on or after their normal retirement date, as defined, will be eligible to receive the amounts credited to their accounts. In addition, upon attaining age 55 and completing 10 years of vesting service, participants may retire early and be eligible to receive the amount credited to their accounts. Subject to the Plan rules, participants may elect to defer payment until they reach age 70-1/2.

A participant who terminates employment with a vested account balance of \$7,000 or less and does not consent to a distribution will receive an Involuntary Cash-Out Distribution.

Participants may borrow against the vested balances in their 401(k) contribution, rollover, employer match, and profit sharing accounts up to \$50,000 or 50% of the current value of their vested account balances. The loans bear interest at a rate equal to 1% over the prime rate at the time of issuance. In the event of financial hardship, participants may apply to receive a distribution of certain amounts subject to meeting IRS mandated rules for hardship withdrawals. Benefits may be distributed to a participant or his beneficiary in the form of installment payments or in a single lump sum payment.

If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent note receivable from participant is recorded as a benefit payment based on the terms of the Plan document.

There were no amounts allocated to accounts of persons who have elected to withdraw from the Plan, but have not been paid at December 31, 2024.

The Company intends to continue the Plan indefinitely for the benefit of its employees but reserves the right to terminate the Plan at any time by resolution of the Company's Board of Directors. Upon the termination of the Plan or upon complete discontinuance of Company contributions, the rights of all affected participants in the Plan and the amounts credited to their individual accounts will become 100% vested.

Administrative expenses, principally professional fees and certain service provider administration fees are paid by the Plan. Other administration costs are paid by the Plan sponsor.

The foregoing description of the Plan provides only general information. Participants should refer to the Plan description summary, *Invacare Retirement Savings Plan*, for a more complete description of the Plan's provisions. Copies of this summary are available from the Plan administrator.

B. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Invacare Retirement Savings Plan (the “Plan”) are presented on the accrual basis of accounting.

Investments and Investment Valuation

The Plan’s investments are reported at fair value using methodologies described in Note C. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Participant investment options generally consist of separate investment funds which are valued at fair value on a daily basis. Fair value for most investments is determined by the most recent sales or bid price, or by independent pricing services. Investment prices are subject to normal market fluctuations. All dividends and capital gains are reinvested in the respective funds.

Notes Receivable from Participants

Notes receivable from participants are recorded at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are written off when deemed uncollectible. Loan transactions are treated as transfers between the investment funds and the Participant Loan fund.

Income Recognition

Interest income and realized and unrealized gains and losses are recorded daily. Realized gains and losses from security transactions are determined and accounted for based on average cost. Dividend income is recorded at declared value. Capital gain distributions are included in dividend income. Security transactions are recorded on the trade date. Net realized and unrealized gains and losses from the sale or holding of investments are reflected in the statement of changes in net assets available for benefits.

Purchases and sales of investments, including gains or losses, are recorded on a trade-date basis. Interest income is recorded when earned, and dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Subsequent Events

In preparing these financial statements, Plan management has evaluated events and transactions for potential recognition or disclosure through November 14, 2025, the date the financial statements were available to be issued.

C. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 – inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – inputs to the valuation methodology include:

- a) Quoted prices for similar assets or liabilities in active markets;
- b) Quoted prices for identical or similar assets or liabilities in inactive markets;
- c) Inputs other than quoted prices that are observable for the asset or liability;
- d) Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

C. Fair Value Measurements – Continued

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

1. Self-directed brokerage accounts: Accounts primarily consist of mutual funds and common stocks that are valued on the basis of readily determinable market prices.
2. Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
3. Investment measured at net asset value: The Fidelity Managed Income Portfolio II, a stable value collective trust fund composed primarily of fully benefit-responsive investment contracts, is valued at the net asset value of units of the collective trust held by the Plan at year end. The net asset value, provided by the trustee, is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner. The Plan has no unfunded commitments for this type of investment.

The following table sets forth, by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

E. Related Party Affiliation

The Plan's trustee, Fidelity Management Trust Company, is also the custodian of the Plan's assets. Fidelity Investments Institutional Operations Company, Inc., and its affiliated entities are affiliates of the trustee, and provide transfer agent, recordkeeping and other administrative services to the Plan as agent for the trustee. Certain Plan investments are shares of common stock of Invacare Corporation, the Plan sponsor, and investment funds managed by entities affiliated with the trustee of the Plan, or its affiliates, and therefore qualify as party-in-interest transactions.

The Plan issues loans to participants which are secured by the balances in the participants accounts. These transactions qualify as party-in-interest transactions.

F. Income Tax Status

The Plan obtained its latest determination letter on January 30, 2017, in which the Internal Revenue Service stated that the Plan, as designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

G. Plan Termination

The Plan's sponsor experienced a reduction in workforce during 2023. The workforce reduction exceeded 20% which triggered a partial Plan termination resulting in all affected participants becoming 100% vested in their account balances at that time, even if they had not yet satisfied the vesting schedule under the Plan. The remaining participants' vesting continues to be determined according to Plan provisions.

Although it has not expressed any intent to do so, the Company reserves the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA; however each participant would have a nonforfeitable right to his or her total account balance as of the date of termination.

I. Risks and Uncertainties

The participants direct the Plan to invest in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and such changes could materially affect the amounts reported in the statements of net assets available for benefits.

J. Prohibited Transaction

As discussed in Note G, the Plan experienced a partial plan termination in 2023 resulting in affected participants becoming 100% vested in their account balance at that time, even if they had not yet satisfied the vesting schedule. As a result of the partial plan termination, some individuals who requested distributions did not receive their total allowable benefit. The corrective action for this requires the Plan Sponsor to make distributions to the participant totaling the forfeited amount. Corrective action was completed in November 2024.
