NOTES TO FINANCIAL STATEMENTS

Note 1 – Description of Plan

The following description of the Williams, Kastner & Gibbs PLLC Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan was adopted effective January 1, 1978, and most recently restated effective January 1, 2022. Williams Kastner (the Company) is the sponsor of the Plan. The Plan covers all eligible staff and equity members, except non-resident alien employees, leased employees, temporary employees and those covered by collective bargaining agreements. The Plan is subject to the applicable provisions of the Internal Revenue Code (IRC) and the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Custodian and Administrator of the Plan

The custodian and recordkeeper of the Plan is Charles Schwab Trust Bank (Charles Schwab). The administrator of the Plan is the Company. Charles Scwhab holds all assets of the Plan in accordance with the service provider contract with the Company.

Eligibility

Employees are immediately eligible to participate in the Plan on the first day of the month coinciding with or immediately following their date of hire. Participants must complete at least one year of service, defined as 1,000 hours during the Plan year, and be employed as of the last day of the Plan year, to be eligible to receive employer matching contributions. Participants must complete at least two years of service and be employed as of the last day of the Plan year, to be eligible to receive employer profit sharing contributions.

Contributions

Participant Contributions – Eligible participants may elect to contribute up to 75% of their annual compensation, as defined in the Plan document. Contributions can be made on both a pre-tax and/or Roth basis through payroll deductions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. When eligible to participate in the Plan, if an employee does not make an election otherwise, he or she will be automatically enrolled in the Plan at an initial pre-tax salary deferral amount of 4%.

Employer Contributions – The Plan Sponsor contributes a non-safe harbor matching contribution equal to 25 percent of participant salary deferrals, up to 4 percent of eligible compensation. For the year ended December 31, 2024, the Plan Sponsor made a matching contribution of \$71,019.

The Plan Sponsor may make a discretionary profit sharing contribution to the Plan. For the year ended December 31, 2024, the Plan Sponsor contributed \$961,188, which was calculated based on a percent of a participant's eligible compensation. The Plan Sponsor may also make an additional contribution to meet IRS non-discrimination requirements. For the year ended December 31, 2024, the Plan Sponsor made a top heavy contribution of \$37,606.

Contributions are subject to certain other limitations in accordance with the IRC.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's contributions, and an allocation of net Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan, as applicable. Allocations are based on participant earnings, participant contributions, or account balances, as defined. The benefit to which a participant is entitled is the vested portion of their accounts.

Notes Receivable from Participants

Participants are permitted to borrow a minimum of \$1,000 of their vested benefits under the Plan up to maximum of \$100,000 or 50% of their vested account balance, whichever is less. The notes are secured by the participants' accounts and bear a reasonable rate of interest (5.25% – 10.50% for notes outstanding at December 31, 2024). Loans must be repaid in five years (a longer term is allowed if used to acquire a principal residence), and payments are required to be made through payroll deductions. Due dates range from December 2025 to December 2029. These loans are subject to certain restrictions as defined by the Plan Document and applicable restrictions under the IRC.

Vesting

Participants are 100 percent vested in all salary deferral contributions, rollovers, employer contributions and the related earnings at all times, as such, there is no forfeiture balance at December 31, 2024 or 2023.

Payment of Benefits

Upon termination of service, disability, death or retirement, a participant whose vested account exceeds \$5,000 may elect to receive either a lump-sum amount equal to the value of his or her account or a substantially equal installments over a period of time not exceeding the life expectancy of the participant or the designated beneficiary. Terminated participants with a vested account balance between \$1,000 and \$5,000 will receive an automatic direct rollover to an individual retirement account, and participants with balances of \$1,000 or less will receive an automatic lump-sum cash payment. In-service distributions are allowed in accordance with the terms of the Plan.

Plan Transfers

Participants may transfer his or her entire account in another qualified defined contribution plan maintained by the Plan Sponsor into the Plan upon satisfying eligibility requirements. Participant may also transfer his or her entire account to another qualified defined contribution plan maintained by the Plan Sponsor upon entering an ineligible class of Employees as defined by the Plan.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Investments Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company determines the Plan's valuation policies utilizing information provided by the custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefits paid to participants are recorded when paid.

Administrative Expenses

The Plan's expenses are paid either by the Plan or Plan Sponsor, as determined by the trustees, plan document, or service provider agreements. Expenses that are paid directly by the Plan Sponsor are excluded from these financial statements and are not intended to be reimbursed by the Plan. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation or depreciation of fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

Subsequent Events

The Plan has evaluated subsequent events through the date these financial statements were available to be issued, which was September 30, 2025.

Note 3 – Information Prepared and Certified by Third-Party Service Providers

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Charles Schwab Trust Bank, a qualified institution, has certified that the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investment information included in the schedule of assets (held at end of year) as of December 31, 2024, as shown on the ERISA-required supplemental schedule.

At the request of the Plan administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4 – Fair Value Measurements

Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted market prices for similar assets or liabilities in active markets.
- quoted prices for identical or similar assets or liabilities in inactive markets.
- inputs other than quoted prices that are observable for the asset or liability.
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes to methodologies used as of December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-Directed Brokerage Accounts: Accounts primarily consist of mutual funds, unit investment trusts and common stocks that are valued on the basis of readily determinable market prices.

Stable Value Collective Investment Trust: This fund is a Collective Investment Trust valued at net asset value per unit as calculated by the Fund. This net asset value per unit is determined mostly by the Fund's various underlying investments' value at the close of the New York Stock Exchange each day. While the resulting net asset per unit value is not the same underlying investments' value, the financial trend should be the same.

The preceding methods described may produce a fair value calculation which may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 – Party-in-Interest Transactions

Participant loan and certain distribution processing fees are paid to the recordkeeper by participants. The Plan paid for third party administrator fees which qualify as party-in-interest transactions. The Plan also issues loans to participants which are secured by the vested balance of the participants' accounts. Certain management fees in the form of an expense ratio charged to each investment option are paid by the Plan and deducted from earnings on investments. The Plan's investment options are held in participant directed and self-directed accounts at Charles Schwab Trust Bank, the Custodian of the Plan; therefore, any transaction executed with Charles Schwab Trust Bank qualifies as a party-in-interest transaction. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

Note 6 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provision of ERISA and its related regulations. In the event of Plan termination, participants would remain 100% vested in their accounts.

Note 7 – Income Tax Status

The Plan Sponsor adopted a non-standardized pre-approved profit sharing/money purchase/cash or deferred arrangement (CODA) plan, sponsored by Schwab Retirement Plan Services, which received a favorable opinion letter from the Internal Revenue Service dated September 21, 2020. Although the opinion letter is not specific to the Plan, the Plan administrator believes that the Plan is currently designed and is currently being operated in compliance with applicable requirements of the Internal Revenue Code; therefore, they believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Management evaluated the Plan's tax positions and concluded that the Plan has maintained its tax exempt status and has taken no material uncertain tax positions that require adjustment to the financial statements; therefore, no provision or liability for income taxes has been included in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
