I am writing to respectfully request a waiver on the penalty for missing the filing deadline on our Form 5500. We understand the importance of timely filings and apologize; however, there were extenuating circumstances that may justify this request.

In 2024, Label Mark-It Inc. was acquired by a new owner. There was confusion on who was responsible for filing the 5500 forms due to transfer of ownership midyear. Including the involvement of two different payroll companies.
