Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Turnbridge 401(k) Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). 1. Description of the Plan

The following description of Turnbridge 401(k) Retirement Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan provisions.

General

The Plan is a defined contribution plan covering eligible employees of CT Clinical Services, Inc. d/b/a/ Turnbridge (the “Company” or “Plan Sponsor”) who have reached the age of eighteen and completed 60 days of service. The Plan has an automatic enrollment feature whereby eligible participants are automatically enrolled in the Plan at a pre-tax contribution rate of 3% of eligible compensation upon meeting the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

In August of 2022, Empower changed the names of its U.S. companies with a legacy “Great West” name to “Empower”. As a result, Great-West Life & Annuity Insurance Company is now Empower Annuity Insurance Company of America and Great-West Trust Company, LLC is now Empower Trust Company, LLC. The change was in name only and did not have an impact on the assets or participant accounts of the Plan.

Contributions

Each year, participants may contribute up to 100% of eligible compensation, as defined in the Plan document, up to the maximum allowed by the Internal Revenue Code (“IRC”), and may designate such contributions as pre-tax or after-tax (Roth) contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollovers). Certain Plan participants may elect to make “catch-up contributions” as defined under the IRC. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan is required to return excess contributions received during the Plan year in excess of IRC limits.

The Company may make a discretionary matching contribution to the Plan. Participants who made elective deferrals to the Plan, and have 1,000 hours of service and employed as of the last day of the plan year are eligible to receive this matching contribution. There were no discretionary matching contributions made during the year ended December 31, 2024.

Vesting

Participants are immediately vested in their contributions, including rollovers, plus earnings thereon. Vesting in the Company’s contributions are based on years of continuing service as follows:

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contributions and (b) Plan earnings (losses) and (c) administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Forfeited Accounts

Forfeitures of the non-vested portion of terminated participants' accounts are maintained in a separate account and may be used to pay administrative expenses or to reduce future employer contributions. As of December 31, 2024 and 2023, there were no forfeited non-vested accounts. During 2024, no forfeitures were used to reduce employer contributions or administrative expenses.

Notes Receivable from Participants

Participant loans are not permitted under the provisions of the Plan.

Due to Plan Sponsor

Due to Plan sponsor represents contributions related to the 2025 plan year that were remitted to the Plan during 2024.

Payment of Benefits

Participants' vested account balances are eligible for payment upon reaching age 59½. Upon termination of service due to death, disability or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest or installment payments either monthly, quarterly, semi-annually, or annually. Participants whose account balances are \$5,000 or less may receive a lump sum payment or have their account balance rolled over to an Individual Retirement Account. Participants may withdraw funds from their accounts who have demonstrated hardship (as defined under Internal Revenue Service Regulations).

Plan Expenses

Administrative expenses of the Plan are paid by the Plan as provided in the Plan document. Expenses relating to specific participant transactions (i.e. distributions) are charged directly against the appropriate participant's account. Certain other costs for administering the Plan (i.e. recordkeeping, third-party administration, and audit services) are paid by the Company and are excluded from these financial statements.

Basis of Accounting and Use of Estimates

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Fair Value Measurements

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

Pursuant to U.S. GAAP guidance, alternative investments where fair value is measured using the Net Asset Value ("NAV") per share as a practical expedient is not categorized within the fair value hierarchy.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value, except for the fully-benefit responsive group annuity contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Mutual funds held by the Plan are valued at fair value based on the daily closing price as reported by the funds. All of the mutual funds are open-ended and are registered with the Securities and Exchange Commission and are deemed to be actively traded. These mutual funds are required to publish their daily net asset value and to transact at that price. The common/collective trusts are valued at the NAV, as provided by the custodian, which is used as a practical expedient for fair value based on the fund's underlying investments. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. The group annuity contract is reported at contract value, which represent contributions made under the contracts, plus earnings, less participant withdrawals and administrative expenses.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

5. Common/Collective Trust

Participants may elect to invest in the Putnam Retirement Advantage Trusts (the “Trusts”), which are collective investment trusts established and maintained by Putnam Fiduciary Trust Company, LLC, as trustee and investment manager. The Plan also offers investments in other collective investment funds, including the BlackRock Russell 2000 Index Fund, International Growth Fund II, Large Cap Value Fund II, and Small Cap Growth Fund II.

The Putnam Retirement Advantage Trusts are target-date funds designed to provide investment returns consistent with the risk and return characteristics appropriate for participants planning to retire on or about the target year identified in each fund’s name. Each target-date fund invests in a diversified mix of underlying funds that include both equity and fixed-income securities, with the allocation becoming more conservative as the target date approaches.

Fund units may be redeemed on a daily basis to meet benefit payments and other participant-initiated withdrawals permitted by retirement plans invested in the Fund. There are no unfunded commitments as of December 31, 2024 and 2023 for the Fund.

6. Group Annuity Contract

The Empower Investments Fixed Account – Series Class IV is a general account product offered through a group annuity contract issued by Empower Annuity Insurance Company of America (EAIC). Participant principal and credited interest are fully guaranteed by the general account assets of EAIC. The contract is fully benefit-responsive for participant-initiated transactions.

Each quarter, an interest crediting rate is established for all money, regardless of when it was deposited. The crediting rate is determined based on the earnings of the underlying medium-to long-term new-money portfolio, compared to the minimum guaranteed rate and prevailing market conditions. The crediting rate may remain the same or change each quarter.

Participants may transfer their account balances to other investment options under the Plan without restrictions or penalties. No events are probable of occurring that might limit the ability of the Plan to transact with participants at contract value. However, employer-initiated events such as plan termination, merger, or significant layoffs could limit the ability of the Plan to access contract value.

The investment contract is reported at contract value, which represents contributions plus credited interest, less withdrawals and administrative charges. Contract value is the amount participants would receive if they were to initiate permitted transactions under the Plan.

7. Tax Status

The prototype plan document preparer received an IRS Opinion Letter dated June 30, 2020. The Internal Revenue Service has determined and informed the prototype document that the Plan is designed in accordance with applicable sections of the Code. The Plan has been amended since the letter was issued by the IRS, however, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code.

7. Tax Status (continued)

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

8. Plan Termination

Although it has not expressed any intent to do so, the Company may at any time terminate the Plan and discontinue all contributions, subject to the applicable provisions of ERISA. In the event the Plan is terminated, all participants shall become fully vested in their account balances.

9. Parties-in-Interest Transactions

The group annuity contract was issued by Empower Annuity Insurance Company of America, a trustee of the Plan. Therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

11. Prohibited Transactions

During 2024 plan year, the Employer failed to remit to the Plan certain participants' contributions amounting to \$810 within the period described by the Department of Labor ("DOL") regulations. Delays in remitting the contributions to the Plan were due to administrative oversight. The Employer is in the process of making the necessary corrections.

12. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investments securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
