We have performed audits of the accompanying financial statements of New York College of Podiatric Medicine 403(b) DC Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 (liquidation basis) and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 (liquidation basis), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (a qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. Emphasis of Matter – Plan Liquidation and Liquidation Basis of Accounting for 2024

As discussed in Note 2 to the financial statements, on November 30, 2024, the Plan Sponsor terminated the Plan in connection with the transaction agreement executed on April 20, 2021 between the Plan Sponsor, the Foot Clinics of New York and Touro College. As a result, the Plan has changed its basis of accounting to the liquidation basis used in presenting 2024 financial statements. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1. Description of Plan

The following description of the New York College of Podiatric Medicine 403(b) DC Retirement Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established for the benefit of the employees of the New York College of Podiatric Medicine (the "Plan Sponsor"). The Plan is intended to meet the requirements of Section 403(b) of the Internal Revenue Code of 1986 ("IRC"), as amended effective January 1, 2009. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

There is no age requirement to begin receiving employer contributions, and employees are eligible to begin receiving employer contributions after one year of service.

In connection with the transaction agreement executed on April 20, 2021 between the Plan Sponsor, the Foot Clinics of New York and Touro College, the Plan is terminated effective November 30, 2024. Upon termination of the Plan, all participants became fully vested in their account balances. No additional contributions were made after the termination date.

Contributions

All contributions to the Plan are made by the Employer. The percentage of employer contributions is based on years of service. Employees begin receiving employer contributions after one year of service as follows:

1-10	3%
10-15	6%
15 or More	10%

Vesting

A participant is 100% vested in employer contributions including allocated earnings thereon at all times.

Participant Accounts

Each participant's account is credited with an allocation of the employer's contribution and Plan earnings, and charged with an allocation of administrative expenses, if any. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. All investments are participant directed.

Payment of Benefits

Upon termination of service due to death, disability, retirement or other reason, a participant is entitled to receive a distribution in the amount equal to the value of the participant's vested interest in his or her account.

Revenue Sharing Agreement

The Plan and Teachers Insurance and Annuity Association of America and College Retirement Equities Fund ("TIAA-CREF"), the trustee of the Plan, have entered into a revenue sharing arrangement whereby a portion of revenue earned by the custodian from certain funds is passed through to the Plan for payments of permitted expenses. In order for the Plan to receive credits as a result of this arrangement, the Plan created an asset holding account. The asset holding account is an account within the Plan, similar in design to a forfeiture account, and is used to record keep these funds. The asset holding account balance was \$35,798 and \$29,821 at December 31, 2024 and 2023.

2. Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

As a result of the Plan Termination (see Note 1), the Plan changed its basis of accounting for 2024 plan year to liquidation basis. During the year ended December 31, 2024, the Plan was required to accrue and separately present activity for future period related to (1) any contributions by the employer, (2) any cost that it expects to incur, (3) any interest and dividends it expects to earn during liquidation, and (4) any adjustments to the investments during the liquidation period. The 2023 financial statements are prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP") which requires management to make estimates and assumptions that affects assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Fair Value Measurements

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

Pursuant to U.S. GAAP guidance, alternative investments where fair value is measured using the Net Asset Value ("NAV") per share as a practical expedient are not categorized within the fair value hierarchy.

Investment Valuation and Income Recognition

The TIAA Traditional Annuity Account is an unallocated contract. The fully benefit responsive contracts are carried at contract value and the non-benefit responsive contracts are carried at fair value. Contract value equals the accumulated cash contributions, interest credited to the Plan's contracts, and transfers in (if any), less any withdrawals and transfers out (if any). Fair value approximates contract value for non-benefit responsive categories of the account. Fair value is derived from a discounted cash flow analysis and other factors. See Note 4 for the valuation method. Investments in Registered Investment Companies are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the plan are deemed to be actively traded. The pooled separate account is valued at the NAV of units held by the Plan. The NAV, as provided by TIAA, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Investment related expenses are included in net appreciation in value of investments.

Subsequent Events Evaluation by Management

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through November 18, 2025, the date that the financial statements were available for issue.

TIAA Traditional Annuity Account

The TIAA Traditional Annuity Account is comprised of six types of contracts. The fully benefit responsive contracts are: the Group Supplemental Retirement Annuity (“GSRA”), the Supplemental Retirement Annuity, (“SRA”) and the Retirement Choice Plus (“RCP”) contracts. The non-benefit responsive contracts are: the Group Retirement Annuity, Retirement Annuity (“RA”) and Retirement Choice contracts. The Plan utilizes the GSRA, SRA, and RCP contracts, which are reported at contract value, and the RA contract, which is reported at fair value. Unobservable inputs include the risk-adjusted discount rate applied and the range of significant input values are as follows: GSRA – 4.75%-4.50%; SRA – 4.75%-4.50%; RCP – 5.50%-4.75%; and RA – 6.00%-5.00%.

Under the RCP contract, lump-sum withdrawals and transfers are allowed at any time. Any transfers out of the TIAA Traditional Annuity and back in within 120 days, the amount up to the original transfer, will be credited with the same interest rates that would have applied had the transfer not taken place. Under RA contracts, lump-sum withdrawals are not allowed and transfers must be spread out over ten annual installments.

The contracts use the vintage method to credit interest to the TIAA Traditional Annuity Account. Vintages are time periods that represent when money was initially invested in the TIAA Traditional Annuity Account and corresponding interest rate during that distinct time period. The Vintage method recognizes the fact that the level of prevailing interest rates available on new long-term investments will vary over time and that as the long-term investments in a specific vintage mature, they will be reinvested at different rates. When funds flow into the TIAA Traditional Annuity Account, they are immediately invested at the prevailing pay-in-rate for new money. The funds earn interest at the prevailing vintage rates. The vintage will always consist of two parts: the guaranteed portion and the discretionary portion. The guaranteed portion represents the minimum amount of interest that will be credited to an account, regardless of the economic environment. The discretionary portion represents interest earned over and above the guaranteed rate. The guaranteed annual interest rate on the RA contract is 3.00% for all premiums remitted plus additional amounts established by TIAA on a year-to-year basis. The RCP contract has a minimum guaranteed rate of 1.00% and is specified in the contract.

The TIAA Traditional Annuity Account represents approximately 33% and 35% of the Plan’s net assets available for benefits as of December 31, 2024 and 2023, and represents an obligation from TIAA to repay as amounts come due.

The credit risk of the issuer was evaluated by nationally recognized statistical rating agencies as follows: Moody’s Investors Service (Aa1 as of October 2024), Standard and Poor’s (AA+ as of May 2024), A.M. Best (A++ as of July 2024), and Fitch (AAA as of August 2024). The plan administrator does not believe that any events would limit the Plan’s ability to transact at contract value.

TIAA Real Estate Account

The TIAA Real Estate Account generally invests in real estate properties and real estate related investments. The TIAA Real Estate Account's value is principally derived from the market value of the underlying real estate holdings or other real estate-related investments. Real estate holdings are valued principally using external appraisals, which are estimates of property values based on a professional's opinion. The TIAA Real Estate Account sometimes holds securities as well. These are generally priced using values obtained from independent pricing sources. While redemptions from the TIAA Real Estate Account may occur daily, transfers out are limited to one per calendar quarter.

The TIAA Real Estate Account is valued at the NAV of units held by the Plan. The NAV, as provided by TIAA-CREF, is used as a practical expedient to estimate fair value. The NAV based on the fair value of the underlying investments held by the fund less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

5. Tax Status

The Plan is based on a Volume Submitter 403(b) Plan for TIAA, which received an opinion letter from the Internal Revenue Service ("IRS") dated August 7, 2017 stating that the Volume Submitter 403(b) Plan was designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan Sponsor believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

6. Party-in-Interest Transactions

Certain Plan investments are managed by TIAA-CREF. TIAA-CREF is the Plan's trustee and record-keeper as defined by the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.
