INDEPENDENT AUDITORS' REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Life Management Center of Northwest Florida, Inc. Money Accumulation Pension Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). - Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matters – Supplemental Schedules Required by ERISA

The supplemental schedule of assets (held at end of year) as of December 31, 2024, is presented for the purpose of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

(1) **Description of Plan:**

The following description of the Life Management Center of Northwest Florida, Inc. Money Accumulation Pension Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

(a) **General**—The Plan is a defined contribution pension plan that covers substantially all employees of the Life Management Center of Northwest Florida, Inc. (the Organization) who have completed 1,000 hours of service in either the Plan year or their first 12 months of employment, as defined in the Plan agreement. The Plan is subject to the provisions of Employee Retirement Income Security Act of 1974 (ERISA), as amended.

(b) **Contributions**—Under the provisions of the Plan, the Organization is required to contribute an amount equal to a specified percentage of each eligible participant's compensation, as defined in the Plan documents. Participants are not allowed to contribute to the Plan. The Plan requires the Organization to contribute a fixed percentage of each eligible employee's compensation each year, currently set at 4%. During the year ended December 31, 2024, the Organization met the minimum required funding at 4% of eligible compensation. Contributions made by the Organization shall be applied or invested in accordance with the Plan documents.

(c) **Participant accounts**—Each participant's account is credited with allocations of (a) the Organization's contribution and (b) Plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan. The Organization currently offers a collective trust fund and 27 mutual funds as investment options for participants. Participants may change their investment options on a daily basis. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. The Plan is intended to meet the requirements of Section 404(c) of ERISA, with the result that participants, and no other fiduciaries, are responsible for the investment of their participant accounts.

(d) **Vesting**—Vesting of a participant's account balance is based on years of service. A participant becomes vested 20% after two years of credited service, 40% after three years of credited service, 60% after four years of credited service, 80% after five years of credited service and is 100% vested after six years of credited service or upon death, disability, or attainment of 65 years of age.

(e) **Payment of benefits**—Upon termination of service due to death, disability, or retirement, the participant or beneficiary will receive the vested value of his or her account in either a lump-sum payment or installments over a period not to exceed the participant's life expectancy. The method of payout is determined by the Plan provisions, dependent on the reason for the distribution. The participant may take an in-service withdrawal from all accounts at age 59 1/2 or later. Absent the participant's election to roll distributions into another qualified plan or receive a lump sum payment, vested balances that are \$5,000 or less for terminated participants are rolled over to an individual retirement plan designated by the Plan Administrator.

(1) **Description of Plan:** (Continued)

(f) **Notes receivable from participants**—Participants may borrow from their fund a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested balance. The loans are secured by the balance in the participant's account and bear interest at prime plus 1% (current rates on loans range from 4.25% – 9.50%). Principal and interest is paid ratably at least as frequently as quarterly over a reasonable amount of time not to exceed five years (fifteen years for personal residence).

(g) **Administrative plan expenses and participant fees**—The Plan permits payment of administrative expenses to be made from the Plan's assets and for them to be allocated either proportionately based on the value of account balances or as an equal dollar amount based on the number of participants in the Plan. However, certain operating expenses of the Plan, such as audit fees, are paid by the Plan Sponsor. Plan administration and investment management fees reduce participant account balances. Expenses relating to specific participant transactions (i.e., loan setup, distribution request, etc.) are charged directly against the appropriate participant's account.

(h) **Forfeited accounts**—At December 31, 2024 and 2023, the forfeited non-vested account balance was \$0 and \$24, respectively. These accounts may be used to reduce future employer contributions or pay plan expenses. During 2024, forfeitures totaling \$45,390 were used to reduce employer contributions.

(2) **Summary of Significant Accounting Policies:**

(a) **Basis of presentation**—The accompanying financial statements of the Plan are presented on the accrual basis of accounting.

(b) **Investment valuation and income recognition**—The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements. Interest and dividend income are recorded when paid. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

(c) **Payment of benefits**—Benefits are recorded when paid.

(d) **Use of estimates**—The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

(e) **Subsequent events**—The Plan has evaluated events and transactions for potential recognition or disclosure in the financial statements through November 5, 2025, the date the financial statements were available to be issued. No other subsequent events requiring recognition or disclosure have been identified.

(3) **Information Certified by the Trustee:**

All investment information disclosed in the accompanying financial statements and ERISA-required schedule, including investments held and participant loans at December 31, 2024 and 2023, and the net appreciation in fair value of investments, interest and dividends, and interest income for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Alerus Financial, N.A. (Alerus), the trustee of the Plan.

(4) **Investments and Fair Value Measurements:**

The fair value measurement accounting literature provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include: (1) quoted market prices for similar assets or liabilities in active markets, (2) quoted prices for identical or similar assets or liabilities in inactive markets, (3) inputs other than quoted prices that are observable for the asset or liability, and (4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual Funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Trust funds – Valued at fair value based on the quoted market prices at year end for the underlying mutual funds and NAV of units of a bank collective trust. The NAV, as provided by the trustee, is based on the fair value of underlying investments held by the fund less liabilities. Participant transactions (purchases and sales) may occur daily.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies

For the years ended December 31, 2024 and 2023, respectively, there were no purchases, issues, or transfers in or out of Level 3.

Investment earnings for amounts held in mutual funds and collective trust funds reflect a combination of interest income, dividend income, realized gains and losses, and unrealized gains and losses depending on the composition of the underlying investments. Contributions made by the Organization shall be applied or invested in accordance with participant directed allocations.

(5) **Non-Interest Bearing Cash and Broker Settlement Liabilities:**

The financial statements include non-interest bearing cash held at year end and a related liability, due to brokers. This represents funds held by the Trustee and due back to brokers, which settled subsequent to year end.

(6) **Plan Termination:**

Although it has not expressed any intent to do so, the Organization has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

(7) **Income Tax Status:**

The Plan adopted a preapproved plan that obtained a favorable determination letter from the Internal Revenue Service dated June 30, 2020. A favorable determination letter qualifies the Plan under Section 401(a) of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. The Plan is subject to routine audits by taxing jurisdictions for the most recent three years; however, there are currently no audits for any tax periods in progress.

(8) **Parties-in-Interest:**

During the year ended December 31, 2024 and 2023, Plan investments were managed by Alerus. Alerus provided administrative services to the Plan and served as Trustee to the Plan, and therefore qualifies as a party-in-interest to the Plan. Fees paid to Alerus are included in administrative expenses.

(9) **Risks and Uncertainties:**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
