INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of

Opinion

We have audited the financial statements of GEICO Corporation Consolidated Welfare Benefits Program (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of benefit obligations and net assets available for plan benefits as of December 31, 2024, and the related statements of changes in benefit obligations and net assets available for plan benefits for the year ended December 31, 2024 and the related notes to the financial statements.

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. - Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE A: DESCRIPTION OF THE PLAN

The GEICO Corporation Consolidated Welfare Benefits Program (the Plan) provides the following coverages: medical and dental benefits, long term care insurance, life insurance, long term disability insurance, flexible spending accounts, severance benefits, travel accident insurance, group accident insurance, supplemental health benefits, and vision insurance. The GEICO Corporation Consolidated Welfare Benefits Program Trust (the Trust) was maintained to serve as the funding vehicle for the self-insured medical and dental benefits. Effective November 15, 2024, the Trust was wound down and closed. As a result of the Trust termination, Government Employees Insurance Company (GEICO), the sponsoring entity, is now directly paying for the self-insured medical and dental benefits.

The Plan covers the eligible employees of GEICO Corporation and certain of its subsidiaries (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Information about the Plan is available in the Plan document and the Benefits Handbook (Summary Plan Description).

The Plan provides both fully-insured and self-insured medical and dental benefits for active employees, retirees until the age of 65 and eligible family members. Total contributions for the self-insured portion of the Plan are determined based on actual claims experience, which is reviewed annually by the claims administrator, the Company and Aon Hewitt as the Plan's actuarial consultant. Employee contributions for the fully-insured and self-insured portions are determined annually based on a ratio whereby the participating active employees provide approximately 25% and 30% of the total cost of their medical and dental coverage, respectively, and retirees pay the entire premium. The Company contributes amounts necessary to cover all medical and dental costs exceeding the employee contributions and the investment income of the Plan.

The Plan provides long term care benefits (conventional nursing home coverage, in-home care services, services at other care facilities) for eligible employees and certain of their family members. The Plan receives contributions from eligible employees who have elected the long-term care coverage. The long-term care benefits provided by the Plan are fully underwritten by the insurer that has issued the underlying long-term care insurance policy. No additional associates can elect this coverage since it has been frozen.

The Plan provides basic life insurance coverage equal to 1/2 of an eligible employee's annual earnings and optional life insurance coverage in increments of 1/2 of an eligible employee's annual earnings, subject to a maximum level of coverage (basic and additional) equal to five times annual earnings (or \$500,000, if less). The Plan receives contributions from the Company to pay the premiums for the basic life insurance coverage and from eligible employees to pay for the optional life insurance coverage elected by such employees. The benefits provided by the Plan are fully underwritten by the insurer that has issued the underlying group term life insurance policy.

For eligible employees with less than 3 years of service, the Plan provides optional long-term disability coverage equal to 50% of the disabled employee's base monthly salary. For eligible employees with 3 or

more years of service, the Plan provides basic long-term disability coverage equal to 50% of the disabled employee's base monthly salary and buy-up long-term disability coverage equal to 10% of the disabled employee's base monthly salary for a total long-term disability benefit equal to 60% of base month salary. The Plan receives contributions from the Company to pay the premiums for the basic long-term disability insurance coverage and from eligible employees to pay for the optional long-term disability insurance coverage and buy-up long-term disability insurance coverage elected by such employees. The Plan allows eligible employees additional coverage in the form of voluntary individual disability insurance. The coverage provides income replacement up to a monthly maximum of \$17,500. The level of coverage is based on three options and is available without medical underwriting. The benefits provided by the Plan are fully underwritten by the insurer that has issued the underlying long-term disability insurance policy. As a result, no postemployment obligation was recorded in the financial statements associated with this benefit.

The Plan allows eligible employees to establish health care and dependent care flexible spending accounts, which enable the participating employees to pay for health care and dependent care expenses that are not otherwise reimbursed with pre-tax employee contributions (subject to dollar limits imposed by the Internal Revenue Code).

The Plan provides travel accident coverage for eligible employees for accidental injury or loss of life while on business travel. The Plan receives contributions from the Company to pay the premiums for all eligible employees. The benefits provided by the Plan are fully underwritten by the insurer that has issued the underlying travel accident insurance policy.

The Plan provides group accident coverage for all employees and their family members for death or specific bodily injury caused by a covered accident. The Plan receives contributions from eligible employees who have elected group accident coverage. The benefits provided by the Plan are fully underwritten by the insurer that has issued the underlying group accident insurance policy.

The Plan provides vision coverage for all employees and their family members for eye exams, contact lenses and glasses. The Plan receives contributions from eligible employees who have elected vision coverage. The benefits provided by the Plan are fully underwritten by the insurer that has issued the underlying vision insurance policy.

On September 28, 2022, The GEICO Severance Pay Plan (the GSPP) was adopted as self-insured plan under the Plan. The GSPP provides a severance payment amount, in the event of elimination of a position, sale or closing of all or part of a business unit, and relocation of the Company location where the employees' position is based. The payment amounts are based on current salary and years of service at the Company. Associates eligible for the GSPP must execute a severance agreement form releasing the Company from any claims arising out of termination. Displaced associates may also elect to receive outplacement and career coaching services provided by Lee Hecht Harrison.

On January 1, 2023, Cigna Health and Life Insurance Company (Cigna) became The Plan's health plan administrator, replacing UnitedHealthcare. In addition to Preferred Provider Organization (PPO) medical plans, associates have an additional Cigna High Deductible Health Plan (HDHP) option. A Health Savings Account managed by HealthEquity became available for associates that select the HDHP.

As of January 1, 2023, The Plan provides Supplemental Benefits Plans for covered out of pocket expenses. The supplemental health benefits provided by the Plan are fully underwritten by the insurer that has issued the underlying accidental injury, critical illness, and hospital care insurance policies. The Plan receives contributions from eligible employees who have elected the supplemental health coverages.

As of January 1, 2024, ReliaStar Life Insurance Company (Voya) became the Plan's group life insurance vendor, replacing Securian Life Insurance Company.

As of January 1, 2024, Cigna Health became the Plan's dental health administrator, replacing Delta Dental.

NOTE B: SUMMARY OF ACCOUNTING POLICIES

Method of Accounting: The accounting records of the Plan are maintained on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States.

Use of Estimates: Preparation of financial statements in accordance with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations, and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Obligations for Claims: The liabilities for active participants' unpaid health medical and dental claims include amounts currently payable for reported claims and estimates of incurred but not reported claims. The Company believes the reserve for claims incurred but not reported at year-end represents the estimated ultimate cost to the Plan of settling claims; however, the reserve is necessarily based upon estimates and the ultimate cost may vary from such estimates. The methods for making such estimates and for establishing the resulting liability are continually reviewed and any adjustments are reflected in the change in net assets available for plan benefits currently. The amount is estimated using actuarial methods that use historical trend information developed through studies of medical and dental claim lag patterns incurred in the prior years. These amounts are paid by the Plan only if claims are submitted and approved for payment.

Postretirement Benefits Obligation: The postretirement benefits obligation represents the actuarial present value of estimated future medical and dental benefits and life insurance benefits that are attributed to employee service rendered to December 31, reduced by the actuarial present value of contributions expected to be received in the future from current Plan participants. Postretirement benefits include future benefits expected to be paid to or for (1) eligible retired employees and their beneficiaries and dependents and (2) active employees and their beneficiaries and dependents after retirement from service with the Company. Prior to an active employee's full eligibility date, the postretirement benefits obligation is the portion of the

expected postretirement benefits obligation that is attributed to that employee's service rendered to the valuation date. The Plan's postretirement benefits are not required to be funded.

Refunds Receivable: Refunds due from the Plan's pharmacy and healthcare benefits administrators are recorded when earned. Refunds due as of the financial statement date are presented as a receivable and netted with benefits paid to medical and dental providers in the accompanying Statements of changes in benefit obligations and net assets available for plan benefits for the year ended December 31, 2024.

Contributions Receivable: Amounts due from the Company and participants for unpaid invoices due to the Plan's benefit providers at the end of the plan year. Employer contributions receivable represents the Company's share of cost of the benefits pursuant to an established funding policy for amounts payable to the Plan's benefits provider at year end. Employee contributions receivable represent amount withheld by the Company for participants' share of cost of benefits at year end but not remitted to the benefit providers. The unpaid invoices due to the Plan's benefits providers at year end is reported as amounts currently payable within the benefit obligations in the statements of benefits obligations and net assets available for plan benefits.

Deposit with Health Care Provider: A deposit is maintained with the Plan's claims service provider that is applied against future losses.

Payment of benefits: Payments of claims, premiums, and other benefits are recorded when paid by the Plan to the benefit providers. Benefits amounts submitted by the benefit providers but not yet reimbursed by the Plan as of year end are recorded as amounts currently payable within the benefit obligations in the statements of benefits obligations and net assets available for plan benefits. Rebates in the amount of \$57,946,653 have been netted with benefits paid to medical and dental providers in the statements of changes in benefit obligations and net assets available for benefits for the year ended December 31, 2024.

Administrative Fees: The Plan pays administrative expenses that consist primarily of administrative fees paid to third-party claims administrators. Medical and dental claims administration services were provided by Cigna in 2024. Prescription drug claims administration services were provided by CVS/Caremark. The costs of these services were determined on a per person basis in 2024 and paid by the Plan. All other administrative expenses, such as professional fees, are paid by the Company on behalf of the Plan. Additionally, The Company provides administrative services to the Plan for which no fees are charged.

Plan Termination: Although the Company has not expressed any intention to do so, it has the right under the Plan agreement to terminate the Plan. In the event the Plan terminates, The Company will contribute the necessary amounts to fund all obligations of the Plan, which includes claims incurred but not reported prior to the termination of the Plan.

NOTE C: INVESTMENTS

A three-level hierarchy exists that prioritizes the inputs to valuation techniques used to measure fair value. The fair value hierarchy gives the highest priority to quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). If the inputs used to measure the assets or liabilities fall within different levels of the hierarchy, the classification is based on the lowest input that is significant to the fair value measurement of the asset or liability. Classification of assets and liabilities within the hierarchy considers the markets in which the assets and liabilities are traded and the reliability and transparency of the assumptions used to determine fair value.

The hierarchy requires the use of observable market data when available. The levels of the hierarchy and those investments included in each are as follows:

Level 1 – Inputs to the valuation methodology are quoted prices (unadjusted) for identical assets or liabilities traded in active markets. The fair values of money market funds are based on quoted market prices.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in markets that are not active, inputs other than quoted prices that are observable for the asset or liability and market-corroborated inputs.

Level 3 – Inputs to the valuation methodology are unobservable for the asset or liability and are significant to the fair value measurement.

These valuation techniques involve some level of management estimation and judgment. Where appropriate, adjustments are included to reflect the risk inherent in a particular methodology, model or input used and are reflective of the assumptions that market participants would use in valuing assets or liabilities.

As of December 31, 2023, the Plan's investment in the Fidelity Institutional Money Market Government Portfolio Fund was classified as a Level 1 investment.

NOTE D: TAX EXEMPT STATUS

The Trust was established in connection with the Plan and was exempt from taxation in accordance with the provision of Section 501(c)(9) of the Internal Revenue Code (IRC). The Trust obtained its latest determination letter on November 4, 1987, in which the Internal Revenue Service stated that the Trust, as then designed, was in compliance with applicable requirements of the IRC. The Trust had been amended since receiving the determination letter. The Company, however, believed that the Trust was designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The accumulated postretirement benefits obligations at December 31, 2024 and 2023 were determined using assumed discount rates of 5.4% and 4.7%, respectively. The mortality assumption was updated during 2021 to incorporate the Private Retirement Plans Mortality Tables (Pri-2012) healthy and disabled tables for males and females, separate for employees, healthy annuitants and contingent survivors, with a base year of 2012, with generational mortality improvements projected forward from 2012 using the sex distinct Mortality Improvement Scale (MP-2021). There were no updates to the mortality tables in 2024.

The assumed health care cost trend rate at December 31, 2024 was 6.50% in 2024 and decreasing to 5.0% in 2031. An increase of 1% in the assumed health care cost trend rate would increase the 2024 accumulated postretirement benefits obligation by approximately \$ 7,785,641. An increase of 1% in the assumed health care cost trend rate would increase the 2023 accumulated postretirement benefits obligation by approximately \$10,817,022 and would increase the 2023 net periodic postretirement benefits cost by approximately \$719,107. The foregoing assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the postretirement benefits obligation.

NOTE G: RISKS AND UNCERTAINTIES

The actuarial present value of postretirement benefit obligations are reported based on certain assumptions pertaining to interest rates, health care inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

NOTE H: RELATED PARTY AND EXEMPT PARTY-IN-INTEREST TRANSACTIONS

From December 31, 2023 through the termination of the Trust in 2024, the Plan's investments were held in a trust at PNC Financial Services Group, Inc. and, therefore, PNC Financial Services Group, Inc. qualifies as an exempt party in interest. Fees paid during the year for administrative services rendered by parties-in-interest were based on customary and reasonable rates for such services and are paid by the Company.

Personnel and facilities of the Company has been used to perform administrative functions for the Plan at no charge to the Plan.

NOTE I: SUBSEQUENT EVENTS

Management has evaluated events subsequent to December 31, 2024 through November 18, 2025, the date the financial statements are available to be issued and determined there are no events requiring disclosure or adjustments to the financial statements.
