Note 1—Description of the Plan

The following brief description of the Acoustical Sheetmetal Co. 401(k) Plan (the “Plan”) is provided for general information purposes only. Reference should be made to the amended and restated Plan Agreement for a more complete description of the Plan’s provisions.

General – The Plan is a defined contribution plan covering certain employees of Acoustical Sheetmetal Company LLC (the “Company” or “Employer”) who have attained 21 years of age and six-months of service defined as 1,000 hours of service. All employees except for members of a collective bargaining unit and nonresident aliens who do not receive any U.S. source income from the Employer are eligible to participate. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and was established and effective on March 8, 2019, and was most recently restated November 1, 2021.

Administration –The Company is the (“Plan Sponsor” and “Plan Administrator”). The Plan’s assets are maintained and administered by Empower Annuity Insurance Company of America and Empower Trust Company, LLC (“Empower” and “Qualified Institution”). See Note 6 for further information. Certain administrative functions are performed by employees of the Company. These employees do not receive compensation from the Plan.

Participant Contributions – Participants may make pre-tax and/or Roth contributions to the Plan up to the maximum permitted by law subject to certain Internal Revenue Code (“IRC”) limitations. The maximum contribution limit for 2024 was \$23,000. Participants who are 50 years or older during the Plan year may make additional pretax contributions referred to as catch-up contributions. The limit on catch-up contributions for 2024 was \$7,500. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

Employer Contributions – The Company contributes a 100% safe harbor matching contribution up to the first 4% of the amount the participant contributes to the Plan for each payroll period. Participants must attain 21 years of age and complete a six-month period of service to be eligible for safe harbor matching contributions. The matching contribution is invested as directed by the participant. The Company may make additional discretionary-matching contributions based on a percentage of participants’ deferrals, which the Company will determine each year. There were no discretionary-matching contributions made during 2024.

Participant Accounts – Each participant’s account is credited with the participant contributions, Company safe harbor matching contributions and Company discretionary-matching contributions, and an allocation of (a) investment earnings or losses (including net appreciation and depreciation in fair value of investments) and charged with an allocation of administrative expenses not paid by the Company. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Benefits Paid to Participants – On termination of service, a participant (or designated beneficiary) may elect to receive an amount equal to the value of the participant’s vested interest in his or her account. The Plan allows for distributions upon termination of service, death, disability, attainment of age 65, or in certain hardship situations while actively employed. A participant may elect to receive a lump-sum payment or installment payments, rollover the value of their account into another qualified plan, or a combination. If the vested account balance payable to an individual does not exceed \$5,000 upon termination, there will be an automatic cash-out, or required rollover. Hardship withdrawals are subject to IRC restrictions and penalties.

Notes Receivable from Participants – Loans are not permitted in the Plan.

Vesting – Participants have a fully vested and nonforfeitable interest in their voluntary contributions and Company safe harbor matching contributions. Vesting in discretionary-matching contributions is based on years of service. Service years by all employees who were previously employed with a predecessor company as defined by the Plan document are counted toward the current Plan. Each participant’s vesting schedule for the discretionary-matching contributions is as follows:

<u>Years of Service</u>	<u>Vested Percentage</u>
1 year	20%
2 years	40%
3 years	60%
4 years	80%
5 years	100%

Regardless of the vesting schedule, participants are fully vested upon death or disability.

Forfeited Accounts – Forfeited nonvested account balances may be used to pay Plan expenses and reduce future Company contributions. Forfeited nonvested account balances was \$-0- at December 31, 2024 and 2023. During the year ended December 31, 2024, no forfeitures were used to reduce Employer contributions.

Note 2—Summary of significant accounting policies

Basis of Accounting – The financial statements of the Plan are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

Investment Valuation and Income Recognition – Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 7 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividend income is recorded on the ex-dividend date and interest income is recognized when earned. Net appreciation in fair value of investments includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Use of Estimates – The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Such estimates include those regarding fair value. Actual results could differ from those estimates.

Benefits Paid to Participants – Benefits are recorded when paid.

Administrative Expenses – Administrative expenses paid directly by the Company on behalf of the Plan include legal fees and accounting fees and are excluded from these financial statements. Expenses paid by the Plan include third party administration fees and investment fees.

Note 3—Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, each participant becomes fully vested with the amount of credit in their individual account and under no conditions will any part of the account revert to the Company.

Note 4—Tax status

The Plan is a Non-Standardized Prototype Plan (“Prototype Plan”) sponsored by the Trustee and adopted by the Company. The Trustee received an opinion letter from the Internal Revenue Service (“IRS”), dated November 14, 2022, which states the Prototype Plan satisfies the applicable provisions of the IRC. The Plan has not requested its own determination letter from the IRS. The Company and the Plan Administrator believe the Plan is designed and operated in compliance with the applicable requirements of the IRC, the Plan and related trust continue to be tax-exempt, and the Plan has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

Note 5—Party-in-interest transactions

The Plan’s investments are managed by the Trustee of the Plan. Fees incurred by the Plan for investment advisory services are paid directly by the Plan and, therefore, also qualify as parties-in-interest transactions for which a statutory exemption exists. Fees paid by the Plan for investment management and advisory services amounted to \$21,941 for the year ended December 31, 2024.

Note 6—Information certified by the Plan’s Qualified Institution (unaudited)

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower has certified to the completeness and accuracy of the following data included in the accompanying financial statements and supplemental schedule as of December 31, 2024 and 2023, and for the year ended December 31, 2024.

- Investments, at fair value and investments, at contract value shown on the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments and interest and dividends as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule of Assets (Held at End of Year) – Form 5500, Schedule H, Part IV, Line 4i as of December 31, 2024.

The Plan’s independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

Note 7—Fair value measurements

Fair value measurements and disclosures provide the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date;

Level 2 – Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and

Level 3 – Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability, including assumptions regarding risk.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value.

Variable Annuities – Price/unit values are calculated daily by the annuity provider according to the methods described in the annuity contract. The initial pricing input is the quoted price obtained for the underlying mutual fund which is then adjusted to apply the expense factor disclosed in the annuity contract. The formula-calculated unit value is then compared to an accounting-driven unit value the following morning. The accounting unit value is determined in a manner similar to a mutual fund NAV calculation.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 8—Guaranteed investment contract

The Plan holds an investment contract that is considered a traditional investment contract issued by the Trustee. This contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals and administrative expenses. The contract value of the traditional investment contract held by the Plan was \$87,130 and \$411,006 at December 31, 2024 and 2023, respectively.

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer and was 2.80% and 1.65% for the years ended December 31, 2024 and 2023, respectively. The crediting rate is reviewed on a quarterly basis for resetting. The contract cannot be terminated before the scheduled maturity date.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

- a) The Plan's failure to qualify under Section 401(a) of the IRC or the failure of the trust to be tax-exempt under Section 501(a) of the IRC;
- b) Premature termination of the contract;
- c) Plan termination or merger;
- d) Changes to the Plan's prohibition on competing investment options; and
- e) Bankruptcy of the Plan Sponsor or other Plan Sponsor events that significantly affect the Plan's normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include the following:

- a) An uncured violation of the Plan's investment guidelines;
- b) A breach of material obligation under the contract;
- c) A material misrepresentation; and
- d) A material amendment to the agreements without the consent of the issuer.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits.
