NOTES TO THE FINANCIAL STATEMENTS

NOTE 1. DESCRIPTION OF THE PLAN

The following brief description of GTP Savings Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan with salary reduction features as permitted under Section 401(k) of the Internal Revenue Code and is sponsored by Global Tungsten & Powders LLC (the Company). The Plan is funded by participant and employer contributions. Ineligible employees include bargaining class employees, leased employees, independent contractors, and citizens or residents of a foreign country. An employee is eligible to participate in the Plan upon hire date. A temporary, seasonal or part time employee is eligible to participate in the Plan after completing one year of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Benefits and Retirement Plan Committee is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Contributions: Each year, participants may contribute up to 50% of pretax annual compensation, as defined in the Plan. In addition, participants may contribute employee after-tax contributions up to 50% of compensation. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may change their investment allocation on a daily basis. Contributions are subject to certain limitations.

Participants who do not complete a salary deferral agreement are automatically enrolled in the Plan. The Plan automatically withholds 3% of these participant's eligible compensation as a salary deferral. Participants may change their deferral agreement at any time or elect not to participate in the Plan.

The Company makes a matching contribution of 50% of a participant's deferral up to a maximum of 6% of base compensation. The Plan also allows the Company to make an employer retirement contribution based on an eligible participant's years of continuous employment for those employees who are not considered transferred salary or transferred hourly employees that are covered under the GTP Retirement Plan.

Participant Accounts: Each participant's account is credited with the participant's contributions and an allocation of the Company's contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching contribution portion of their accounts is based on years of continuous service. In the event of death or disability, participants will become fully vested in their account. The Plan utilizes a graded vesting scale as follows:

NOTE 1. DESCRIPTION OF THE PLAN (CONTINUED)

Notes Receivable from Participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from 1 to 5 years or up to 10 years for purchase of a principal residence. The loans are secured by the participant's account and bear interest at prevailing commercial rates as determined by the Plan Administrator. Principal and interest are paid ratably through weekly or bi-weekly payroll deductions.

Benefit Payments: Participants (or their beneficiaries) are eligible to receive vested benefits upon retirement, death, permanent disability, upon attainment of age 59½, or when they cease to be an employee of the Company. In addition, a participant can withdraw all or any portion of his or her contributions in the event of financial hardship. The normal form of benefit payments is made in the form of a lump-sum distribution.

Forfeitures: At February 28, 2025 there were \$5 of forfeited nonvested amounts (\$9,504 – February 29, 2024). Amounts forfeited by participants are available to offset the Company's matching contribution or to pay administrative expenses. There were \$85,828 in forfeitures used to offset the employer matching contribution for the year ended February 28, 2025 (\$32,980 – February 29, 2024).

Transfers: Effective April 2, 2024, the Plan was amended to allow transfers from Ceratizit USA Inc's Plan to transfer their balance into the Plan. The initial balance of the participant's account in the Plan is equivalent to the balance in the Ceratizit's Plan account immediately prior to the transfer. Upon transfer, the participant is 100% vested in their transferred account balance. Any loans transferred are subject to the terms and conditions effective under the Ceratizit Plan. Further, the transferred balance of the participant's account is eligible for distributions including disability withdrawals, age 59 1/2 withdrawals, and qualified reservist distributions.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Benefits and Retirement Plan Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation on investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits: Benefits are recorded when paid.

Administrative Expenses: Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment related expenses are included in net appreciation on investments.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Reclassifications: Certain 2024 amounts within the financial statements have been reclassified to conform with the 2025 presentation.

Subsequent Events: These financial statements have not been updated for subsequent events occurring after October 28, 2025, which is the date these financial statements were available to be issued.

NOTE 3. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of fair value hierarchy under ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2: Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at February 28, 2025 and February 29, 2024.

Shares of registered investment companies: Valued at the net asset value (NAV) of shares held by the Plan at year end. The NAV is the closing price reported on the active market on which the securities are traded.

Common / collective trust: Valued based on the NAV per unit of the fund provided by the trust. Unit values are determined by dividing the fund's net assets, which represents the fair value of the underlying investments, by its units outstanding at the valuation date. The Principal Stable Value Fund is a stable value fund. The fund invests principally in guaranteed interest contracts (GICs) issued by insurance companies, investment contracts issued by banks, synthetic investment contracts (SICs) issued by banks, insurance companies and other issuers, and securities supporting such SICs, and other similar instruments which are intended to maintain a constant net asset value.

Self directed brokerage: Accounts primarily consist of common stocks that are actively traded and have readily determinable market prices.

NOTE 5. PARTY-IN-INTEREST TRANSACTIONS

Plan investments include accounts with Principal. Principal is the trustee of the Plan and therefore, these investment transactions qualify as party-in-interest. Fees paid to Principal by the Plan for the administrative services amounted to \$217,048 for the year ended February 28, 2025 (\$194,805 – February 29, 2024).

NOTE 6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their account balances.

NOTE 7. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amount reported in the statements of net assets available for benefits.

NOTE 8. TAX STATUS

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated April 21, 2015, that the plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the letter, the Plan Administrator believes the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax-exempt.

NOTE 8. TAX STATUS (CONTINUED)

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken uncertain tax positions that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by the IRS and recently completed an audit for the February 28, 2019 tax period. In response to the closing agreement received, the Plan properly executed amendments covering the February 28, 2016 through February 28, 2022 and February 28, 2017 through February 28, 2022 periods to clarify eligible employees and identify Plansee Group Functions Americas as a participating employer, respectively.
