NOTE 1 – DESCRIPTION OF THE PLAN:

The following description of the Marin TranSystems Inc 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General:

The Plan is a defined contribution profit sharing plan established on January 1, 2022, covering substantially all employees of Marin TranSystems Inc (the Company or Plan Sponsor) who have completed three months of consecutive service and are age 18 or older. Employees become eligible to participate in the Plan on the date the employee meets the eligibility requirements and become automatically enrolled (see below). Employees covered by a collective bargaining agreement, any leased employees, non-resident aliens and interns are excluded from participating in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan administrator oversees governance of the Plan, determines the appropriateness of the Plan's investments and monitors investment performance.

Participant Contributions and Investment Options:

Participants may contribute up to the maximum deferral allowed by the Internal Revenue Code (the Code), up to 90% of their Plan compensation on a pre-tax basis, as defined. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default deferral rate set at 3% of eligible compensation, increasing by 1% each year up to a maximum of 15%. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan with various objectives and degrees of financial risk. The Plan currently offers various mutual funds as investment options for participants.

Employer Contributions:

The Plan Sponsor makes a safe harbor matching contribution of the participant's elective deferral up to a maximum of 4% of the participant's compensation. Employer contributions for the year ended December 31, 2024 were \$99,590. Additionally, the Company may make a discretionary non-elective contribution to the Plan. Participants must be employed on the last day of the Plan year in order to receive the discretionary non-elective contribution. There were no discretionary non-elective contributions made to the Plan for the year ended December 31, 2024.

Participant Accounts:

Each participant's account is credited with the participant's contribution and Company safe harbor matching contributions, as well as an allocation of the Company's discretionary non-elective contribution, if applicable. Participant accounts are also credited with investment earnings or losses and charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting:

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company's safe harbor matching and discretionary non-elective contributions are based upon when the participant was hired. Participants that were employed before December 31, 2022 will vest based upon hours of service, as defined, and vest based upon a one year cliff schedule. Effective January 1, 2023, those participants that were employed after this date will vest based upon elapsed time, as defined, and are 100% vested based upon an 18 month cliff schedule. A participant vests in the more favorable schedule so long as they were employed while that schedule was active.

Forfeitures:

Any non-vested portion of a participant's account balance shall be forfeited upon a severance from service, as defined. Forfeitures are used to reduce future employer contributions to the Plan or pay any administrative expenses. At December 31, 2024 and 2023, there were no forfeitures available to reduce future Company contributions. For the year ended December 31, 2024, forfeitures of \$16,846 were used to reduce employer contributions.

Notes Receivable from Participants:

A participant may borrow from their account a minimum of \$1,000 up to a maximum of \$50,000, not to exceed 50% of the value of their vested interest in their account. The loans have terms of up to five years, or greater if used for the purchase of a primary residence. The loans are secured by the participant's vested account balance and bear interest at a rate commensurate with current prevailing rates. Principal and interest are paid ratably through payroll deductions. These loans are subject to certain restrictions as defined by the Plan and applicable restrictions under the Code. Each participant may not have more than one loan outstanding at any time.

Payment of Benefits:

Upon termination of service due to death, disability, or retirement, a participant or their beneficiaries may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. A partial withdrawal is permitted upon termination of service due to disability or retirement for participants or their beneficiaries who must receive required minimum distributions, as defined by the Code. Participants with a vested account balance of \$5,000 or less will receive a lump-sum amount equal to the value of the vested portion of their account. The Plan also allows for in-service distributions of the participant's vested accounts upon reaching the age of 59 ½ or due to hardship, as defined by the Plan.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

Basis of Accounting:

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (US GAAP).

Use of Estimates:

The preparation of financial statements in conformity with US GAAP requires management of the Plan to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein at the date of the financial statements and the reported amounts of income and expense during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition:

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by the custodian. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. Delinquent participant loans are treated as distributions based on the terms of the Plan document. Management has evaluated notes receivable from participants for collectability and has determined that no allowance is considered necessary at December 31, 2024 and 2023.

Payment of Benefits:

Benefits are recorded when paid.

Administrative Expenses:

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events:

Management has evaluated subsequent events through November 19, 2025, the date the financial statements were available to be issued.

NOTE 3 – RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 4 – CERTIFIED INVESTMENTS:

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held and notes receivable from participants at December 31, 2024, and net appreciation in fair value of investments, interest income on notes receivable from participants and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Matrix Trust Company (the custodian of the Plan), a qualified institution.

NOTE 5 – FAIR VALUE MEASUREMENTS:

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants, as of the measurement date. Authoritative guidance establishes a hierarchy of valuation techniques based upon whether the inputs to those valuation techniques reflect assumptions other market participants would use based upon market data obtained from independent sources (also referred to as observable inputs).

The following summarizes the fair value hierarchy:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the assets or liabilities;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets' or liabilities' fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Assets valued using the net asset value practical expedient are not required to be reported within the hierarchy.

NOTE 5 – FAIR VALUE MEASUREMENTS (Continued):

The following is a description of the valuation methodologies used for assets measured at fair value.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded, and therefore, Level 1.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair value. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan's investments are all classified as Level 1 as of December 31, 2024 and 2023 and totaled \$487,102 and \$278,539, respectively.

The Plan's policy is to recognize transfers of investments into or out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the year ended December 31, 2024, there were no transfers of investments into or out of Level 3, respectively.

NOTE 6 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS:

The Plan's investments are held and managed by Matrix Trust Company as the custodian, as defined by the Plan, and therefore, these services and transactions qualify as party-in-interest transactions. Notes receivable from participants are also party-in-interest transactions. Human Interest Inc. provides services to the Plan as the record keeper; therefore, these services and transactions qualify as exempt party-in-interest transactions.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 7 – PLAN TERMINATION:

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in all account balances.

NOTE 8 – TAX STATUS:

The Plan is being operated under a prototype, non-standardized pre-approved profit-sharing plan with Cash or Deferred Arrangement (CODA) which received an Internal Revenue Service opinion letter, most recently amended June 30, 2020, stating that the form of the prototype is acceptable under Section 401 of the Code. Although the Plan has been amended since receiving its opinion letter, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

US GAAP requires the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

NOTE 9 – RECONCILIATION TO FORM 5500:

The differences between these financial statements and the Form 5500, if any, are immaterial.
