#### *Opinion*

**NOTE 1 DESCRIPTION OF PLAN**

The following description of the Employee Benefits Corporation Employee Stock Ownership Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

Employee Benefits Corporation, (Company) established the Plan effective January 1, 2002. The Plan was last restated effective January 1, 2015 to conform to recent tax legislation and last amended effective January 1, 2022. The Plan is a defined contribution plan intended to constitute an employee stock ownership plan (ESOP) and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code (IRC). The Plan covers all employees of the Company who have completed the eligibility requirements including the completion of one year of service providing they worked at least 1,000 hours during such Plan year. An eligible employee will begin participation on January 1 or July 1 of the Plan year following the completion of the eligibility requirements. Participants who do not have at least 1,000 hours of service during such Plan year, or are not employed on the last working day of a Plan year, are generally not eligible for an allocation of Company contributions for such year. The Plan is designed to invest in securities issued by the Company. It is subject to the provisions of ERISA, as restated.

Effective January 1, 2021, the Plan was amended to exclude gift cards from eligible compensation.

**Contributions**

The Company may make a discretionary contribution to the Plan on an annual basis. The Company made discretionary contributions approved by the board of directors of \$1,854,714 during the year ended December 31, 2021 consisting of 3,032 shares of contributed Company stock with a fair value of \$2,153,470. The Company made additional contributions in cash of \$13,393 to fund distributions and transfers. The Plan does not permit participant contributions. Contributions are subject to Internal Revenue Service (IRS) limitations.

**Participant Accounts**

Each participant's account is credited with the allocations of (a) the Company's contribution, and (b) Plan earnings or losses. Allocations are based on participant earnings or account balances, as defined. Forfeited balances of terminated participants' nonvested accounts are allocated to remaining participants' accounts in proportion to compensation. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Vesting of participant's accounts is based on years of credited service with the Company. A participant's account becomes fully vested after six years of credited service with the Company, under a graded vesting schedule. A participant is fully vested upon reaching normal retirement age, death, or permanent disability.

If the trustee does not receive voting directions from a participant or beneficiary in a timely manner, the trustee is permitted to vote these shares.

**Put Option**

Under federal income tax regulations, the Company stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the fair market value of the stock. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

**Diversification**

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company common stock into investments which are more diversified. Participants who are at least age 50 and who have completed at least ten years of benefit-service may elect to diversify a portion of their account. Diversification is offered to each eligible participant over an eleven-year period. In each of the first five years, a participant may diversify up to 25% of the number of shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50%. The trustee directs the investment of funds in the diversified balance of their account into various investment options utilized by the Plan.

**Payment of Benefits**

On termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive a distribution amount equal to the value of the participant's vested interest in his or her account. The distribution may be in a single lump sum or installments over a period of not more than the participant's assumed life expectancy. The distribution may be made in cash, Company stock, or both.

**Forfeited Accounts**

Plan forfeitures are allocated to each participant's account based upon the relation of the participant's compensation to total compensation for the Plan year. Forfeitures of terminated nonvested account balances allocated to remaining participants at December 31, 2021 and 2020 were \$136,617 and \$99,481, respectively. There were no balances in forfeited nonvested accounts at December 31, 2021 and 2020.

**NOTE 1 DESCRIPTION OF PLAN (CONTINUED)**

**Transfer of Assets to 401(k) Plan**

The Company also maintains a defined contribution 401(k) plan. Under the terms of the ESOP, effective January 1, 2014, the Company stock in a terminated employee's account is treated as having been distributed from their account and redeemed. Unless the employee elects to receive the redemption proceeds, the redemption proceeds are transferred to the employee's account under the Company's 401(k) Plan. During 2021, there were assets from the Plan transferred to the 401(k) Plan in the amount of \$20,725.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at estimated fair value. Estimated fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation and realized gain includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Administrative Expenses**

Administrative expenses of the Plan are paid by the Company.

**Benefit Payments**

Benefits are recorded when paid.

**Subsequent Events**

The Plan has evaluated subsequent events through October 15, 2022, the date the financial statements were available to be issued.

The Plan's initial investment in Company securities consisted of 100,000 shares and 100% of the issued and outstanding common stock of Employee Benefits Corporation. The shares were acquired on January 1, 2002 for \$885,000, which was the estimated fair market value, as determined by independent appraisal, at that time. The estimated fair market value, as determined by independent appraisal as of December 31, 2021 and 2020 were \$612 and \$525 per share, respectively.

**NOTE 4 FAIR VALUE OF INVESTMENTS**

In determining fair value, the Plan uses various valuation approaches within the fair value measurement framework. Fair value measurements are determined based on the assumptions that market participants would use in pricing an asset or liability.

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2021 and 2020.

*Company common stock*: valued at fair value based on an independent third-party appraisal. This appraisal is based upon a combination of the market and income valuation techniques consistent with prior years. The appraiser took into account historical and projected cash flow and net income, return on assets, return on equity, market comparables, and estimated fair value of Company assets and liabilities. Plan management has concluded that a market participant would also recognize a discount for lack of marketability.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 PLAN TERMINATION**

The Company reserves the right to terminate the Plan at any time, subject to Plan provisions. Upon such termination of the Plan, the interest of each participant in the trust fund will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan terms and the IRC. In the event of Plan termination, participants will become 100% vested in their accounts.

**NOTE 6 PLAN TAX STATUS**

The IRS has determined and informed the Company, by a letter dated December 31, 2015, that the Plan and related trust are designed in accordance with the applicable requirements of the IRC and, therefore, the related trust is exempt from taxation. The Plan has been amended since receiving the determination letter. However, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 7 RISKS AND UNCERTAINTIES**

The Plan investments consist primarily of the Company's common stock, which is exposed to various risks such as interest rate, market, and credit risks, as well as valuation assumptions based on earnings, cash flows and/or other such techniques. Due to the level of risk associated with the investment in the common stock and to uncertainties inherent in the estimations and assumption process, it is at least reasonably possible that changes in the value of common stock will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

**NOTE 8 RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

The Plan is administered by the Company and certain administrative functions are outsourced to a third-party administrator. Certain administrative functions are performed by officers or employees of the Company.

The Plan invests in Company common stock. This is a related party and party-in-interest transaction. As the Company is the Plan Sponsor, transactions involving Company common stock qualify as party-in-interest transactions. At December 31, 2021 and 2020, the Plan held 64,442 and 65,377 shares of Company common stock, respectively.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.
