## INDEPENDENT AUDITOR'S REPORT

To the Trustees of the  
AFL-CIO Health & Welfare Plan

### Opinion

We have audited the accompanying financial statements of the AFL-CIO Health & Welfare Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and of benefit obligations as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits and of changes in benefit obligations for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits and benefit obligations of the AFL-CIO Health & Welfare Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits and changes in its benefit obligations for the years then ended in accordance with accounting principles generally accepted in the United States of America.


### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

### Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.





In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.


Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. ### NOTES TO FINANCIAL STATEMENTS

YEARS ENDED DECEMBER 31, 2024 AND 2023

#### **NOTE 1. DESCRIPTION OF THE PLAN**

The following description of the AFL-CIO Health & Welfare Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions. The Plan was formed in 1956 to provide health benefits to substantially all employees of the AFL-CIO and those affiliated departments, state and local central bodies, and other affiliated entities. In 2007, the AFL-CIO Health & Welfare Trust (the Trust) was established for the purpose of funding the Plan. The Trust, together with the Plan, is intended to constitute a voluntary employees beneficiary association under Section 501(c)(9) of the federal tax code.

Employers contribute to the Trust in accordance with their participation agreement to provide benefits to eligible employees. The Plan provides health benefits including medical, dental, vision, life insurance, accidental death and dismemberment coverage, and prescription drug benefits to eligible participants dependent upon the benefits agreed to in the participation agreements. The Plan was fully insured through December 31, 2016. Effective January 1, 2017, the medical, dental and non-Medicare prescription drug coverage through United Healthcare (UHC) is self-funded. The vision coverage and Medicare prescription drug program remain fully insured with UHC. In addition, the policies with Kaiser Permanente for certain medical and drug coverage remain fully insured.

The Plan's self-funded prescription drug coverage through UHC contains opportunities for the Plan to receive rebates. The claims paid included in the statements of changes in net assets available for benefits is expressed net of those rebates. Total rebates for the years ended December 31, 2024 and 2023 were \$3,694,343 and \$3,000,294, respectively.

The Plan has entered in a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits for individual participant claims over a specific dollar amount. The Plan has arranged insurance coverage to provide specific stop-loss protection above the Plan's self-insurance retention of \$500,000 of individual losses on a per-person basis for the years ended December 31, 2024 and 2023. Total stop-loss refunds during the years ended December 31, 2024 and 2023 were \$532,974 and \$230,649, respectively, which are presented in claims paid in the statements of changes in net assets available for benefits.

The Plan uses UMR as its third-party administrator; UMR is owned by UHC.



## NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Method of Accounting** - The financial statements have been prepared using the accrual method of accounting. Therefore, revenue is recognized when earned and expenses (except for claims paid) are recognized when incurred.

**Postretirement Benefit Obligations** - The postretirement benefit obligation represents the actuarial present value of those estimated future premiums that attribute to employee service rendered to the valuation date. Postretirement benefits include future premiums expected to be paid to or for (1) currently retired employees and their beneficiaries and dependents and (2) active employees and their beneficiaries and dependents after retirement from service with their employer. Prior to an active employee's full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributed to that employee's service rendered to the valuation date.

The Plan's deficiency of net assets over benefit obligations at December 31, 2024 and 2023 relates to the postretirement benefit obligations, the funding of which is not covered by the current contribution rate agreed to between the Plan and participating employers. It is expected that the deficiency will be funded through future contributions.

**Investment Valuation and Income Recognition** - The investments of the Plan are reported at fair value. The fair value of a financial instrument is the amount that would be received to sell that asset (or paid to transfer a liability) in an orderly transaction between market participants at the measurement date (the exit price). Purchases and sales of securities are reported on a trade-date basis. Interest income is recognized on the accrual basis. Dividends are reported on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Interests in the limited partnerships are reported at the unit value or percentage of ownership as disclosed in the partnerships' most recent audited financial statements times the number of shares owned by the Plan.

**Contributions** - Contributions due and unpaid at the end of the year are recognized as contributions receivable; contributions received in advance are recognized as deferred contribution income. Based on management's evaluation of receivables, no allowance for expected credit losses is deemed necessary at December 31, 2024 and 2023.

**Prescription Drug Rebates** - Under the agreement with UHC, the Plan has the opportunity to receive rebates for certain prescription drugs. The rebates are recognized in the period earned.

**Claims paid** - Claims paid are recognized when paid by the Plan, in accordance with U.S. generally accepted accounting principles.



## NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

**Administrative Expenses** - The Plan's administrative expenses are paid for by the Plan, as provided by the Plan document and are included in these financial statements as deductions in the accompanying statements of changes in net assets available for benefits. In addition, certain investment related expenses are included in net investment income (loss) in the accompanying statements of changes in net assets available benefits.

**Use of Estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations, and changes therein, and disclosure of contingent assets and liabilities.

## NOTE 3. PRIORITIES UPON TERMINATION

It is the intent of the Trustees to continue the Plan in full force and effect, however, the Trustees reserve the right to discontinue the Plan. In the event of termination, the Trustees shall first satisfy or make provisions to satisfy the obligations of the Plan. Any remaining plan assets will be distributed in such manner as will, in the opinion of the Trustees, carry out the purpose of the Plan. Termination shall not permit any part of the Plan's assets to be used for or diverted to purposes in contradiction to the Trust Agreement.

## NOTE 4. TAX STATUS

The Internal Revenue Service has advised, in a letter dated February 2, 2010, that the Trust, as then designed, was in accordance with the applicable sections of the Internal Revenue Code (IRC). The assets of the Plan are held in a Trust that, as then designed, satisfied and operated in accordance with the requirements that would permit the Trust to constitute a voluntary employees' beneficiary association, exempt from federal income tax under Section 501(c)(9) of the IRC.

The administrators of and legal counsel for the Plan are unaware of any defect in design or operations of the Plan or its related Trust that would preclude the Trust from being treated as exempt from federal income tax under Section 501(c)(9) of the IRC.

The Plan follows the authoritative guidance relating to accounting for uncertainty in income taxes included in Accounting Standards Codification (ASC) Topic *Income Taxes*. These provisions provide consistent guidance for the accounting for uncertainty in income taxes recognized in an entity's financial statements and prescribe a threshold of "more likely than not" for recognition and derecognition of tax positions taken or expected to be taken in a tax return. The Plan performed an evaluation of uncertain tax positions for the years ended December 31, 2024 and 2023, and determined that there were no matters that would require recognition in the financial statements or that may have an effect on its tax-exempt status. As of December 31, 2024, the statute of

limitations for tax years 2021 through 2023 remains open with the U.S. federal jurisdiction and the various states and local jurisdictions in which the Plan files returns. It is the Plan's policy to recognize interest and/or penalties related to uncertain tax positions, if any, in unrelated business income tax expense.

#### **NOTE 5. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

The Plan pays certain administrative, investment, and professional fees to various service providers, including Amalgamated Bank of Chicago, the investment custodian, for the Plan. These transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

#### **NOTE 6. INSURANCE COMPANY PREMIUMS**

The Plan is insured through Union Labor Life Insurance Company (ULLICO) for life insurance and accidental death and dismemberment benefits and through UHC and Kaiser Permanente for certain medical, dental and vision insurance benefits.

#### **NOTE 7. FAIR VALUE MEASUREMENTS**

Accounting standards provide the framework for measuring fair value which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include other significant observable inputs including:
- Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability; and
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

## NOTE 7. FAIR VALUE MEASUREMENTS (CONTINUED)

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

### Level 1

Mutual funds are traded in active markets on national and international securities exchanges and are valued at closing prices on the last business day of each period.



## NOTE 8. INVESTMENT ENTITIES THAT CALCULATE FAIR VALUE USING NET ASSET VALUE

Authoritative guidance on fair value measurements permits the Plan to measure the fair value of an investment in an investment entity that does not have a readily determinable fair value based upon the NAV per share or its equivalent of the investment. This guidance does not apply if it is probable that the investment will be sold at a value different than NAV.

The Plan's investment in investment entities is subject to the terms of the respective private placement memoranda and governing agreements. Income or loss from investments in these investment entities are net of the Plan's proportionate share of fees and expenses incurred or charged by these investment entities. The fair value of the Plan's investments in these entities are primarily estimated on the fund manager's estimates of fair value, which is based on the Plan's pro-rata share of the fund's capital balance.

The Plan's risk of loss in these entities is limited to its investment. The Plan may increase or decrease its level of investment in these entities at its discretion. The Plan typically has the ability to redeem its investment from these entities on a daily or quarterly basis but longer lockup periods can apply to certain investments.

The Plan's investments in limited partnerships represent ownership in the Boyd Watterson GSA Fund, LP (GSA) of \$2.07 and \$2.20 million as of December 31, 2024 and 2023, respectively, and the Boyd Waterson State Government Fund, LP (SGF) of \$2.16 and \$2.31 million as of December 31, 2024 and 2023, respectively. GSA invests in geographically diverse real-estate assets which are leased by the General Services Administration. Redemption is permitted quarterly with a 60-day notice period and shall only be permitted in increments of \$250,000. SGF invests in geographically diverse real-estate assets which are leased to state, county, and municipal governments agencies. Redemption is permitted quarterly with a 60-day notice period and shall only be permitted in increments of \$250,000.

## NOTE 9. POSTRETIREMENT BENEFIT OBLIGATIONS

The actuarial present value of the expected postretirement benefit obligation is determined by an actuary and is the amount that results from applying actuarial assumptions to historical premiums-cost data to estimate future annual incurred premium costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

## NOTE 9. POSTRETIREMENT BENEFIT OBLIGATIONS (CONTINUED)

If the assumed weighted average health care trend rate increased 1%, it would increase the obligation by \$34,717,574 to \$330,888,384 as of December 31, 2024.

Benefit obligations decreased by \$1,116,892 from the December 31, 2023 valuation to the December 31, 2024 valuation. This was the result of:

- An actuarial experience loss increased obligations by \$9,595,624. This was the net result of gains and losses due to demographic changes, including changes to employers.
- An increase in obligations of \$18,328,618 due to increase in future trends on current per capita health costs.
- A decrease in obligations of \$17,337,442 due to increasing the discount rate. The discount rate is reset each year based on the rates of return on high-quality fixed income investments currently available as of the valuation measurement date whose cash flows match the timing and amount of expected benefit payments.
- A decrease in obligations of \$12,994,578 due to updates to valuation-year per capita health costs.
- An net decrease in obligations of \$7,036,977 due to pension plan assumption changes, including mortality rate adjustments and increases in the salary scale to project future life insurance amounts.

## NOTE 10. INSURANCE PREMIUMS PAYABLE AND CLAIMS INCURRED BUT NOT REPORTED

Benefit obligations include the Plan's liability for insurance premiums and health claims incurred as of December 31, 2024 and 2023 and paid subsequent to year-end, including claims incurred but not reported. The Plan's liabilities for premiums payable and claims incurred but not reported is based on actual premiums paid and claims incurred subsequent to year end.

## NOTE 12. RISKS AND UNCERTAINTIES

Investment Risk: The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that the values of investment securities could be different at the reporting date and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Concentration of Credit Risk: The Plan maintains its cash accounts with banks, which at times exceed the \$250,000 insured by the Federal Deposit Insurance Corporation (FDIC). The Plan has not experienced any losses in such accounts and the Plan believes it is not exposed to any significant credit risk on cash.

Uncertainties: Plan contributions are made, and the actuarial present value of benefit obligations are reported based on certain assumptions pertaining to interest rates, inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near-term would be material to the financial statements.



**NOTE 13.    SUBSEQUENT EVENTS REVIEW**

Subsequent events have been evaluated through October 13, 2025, which is the date the financial statements were available to be issued. This review and evaluation revealed no material event or transaction which would require an adjustment to or disclosure in the accompanying financial statements.
