INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

NOTE 1 – DESCRIPTION OF THE PLAN

The following description of the Hankyu Hanshin Express (USA) 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined-contribution plan qualifying under section 401(k) of the Internal Revenue Code (“IRC”). The Plan covers eligible employees of Hankyu Hanshin Express (USA) Inc. (the “Company”) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan administrator controls and manages the operation and administration of the Plan.

Fidelity Management Trust Company (“FMTC”) provides recordkeeping services for the Plan and is responsible for the custody and management of the Plan’s assets as a trustee.

Eligibility

All employees of the Company at least 21 years of age and have completed at least 3 months of service become eligible to join the Plan on the first day coinciding with or next first day of the following quarter they become eligible.

Participant Contributions

Participants may elect to contribute up to a maximum of 90% of their compensation to be contributed to the Plan as a pre-tax deferral. Employees were generally limited to a maximum contribution of \$23,000 and \$22,500 in 2024 and 2023, respectively, by Code Section 402(g) of the IRC. Eligible employees may also rollover distributions from eligible retirement plans pursuant to the terms of the Plan.

The Plan provides that participants who are age 50 or older may also make catch-up contributions of up to \$7,500 in 2024 and 2023; catch-up contribution limits are indexed annually for inflation.

Employer Contributions

The Company may make matching contributions equal to a discretionary percentage of the participant’s gross compensation. The Plan provides for the Company to match one-half of the employee’s contributions to the Plan up to the first 6% of the employee’s annual salary. The Company chose to make discretionary matching contributions of \$190,666 and \$178,840 for the years ended December 31, 2024 and 2023, respectively. Annually, the Company, at its discretion, may make a profit sharing contribution; no contributions were made for the years ended December 31, 2024 and 2023.

Investment Options

Participants direct the investment of their contributions and any employer contributions into various investment options offered by the Plan. The Plan currently offers registered investment companies (mutual funds) as investment options. Participants may change their investment options daily.

Vesting

Participants in the Plan are fully vested in their contributions plus actual earnings thereon. Participants become vested in the Company's contributions and related Plan earnings/appreciation or depreciation based on years of service. Company contributions and related earnings/appreciation or depreciation shall be vested in accordance with the following schedule:

Forfeitures

Upon termination of employment, the non-vested portion of the participant's account will be forfeited. Forfeitures shall be used to pay for ordinary and necessary administrative plan expenses. Any remaining forfeitures will be used to reduce employer contributions. There were \$3,581 and none of forfeitures used in 2024 and 2023, respectively. As of December 31, 2024 and 2023, forfeited accounts totaled \$16,389 and \$13,131, respectively.

Notes Receivable from Participants

Loans are available in the Plan. The minimum loan amount is \$1,000. The maximum amount is the lesser of one half of the participant's vested account balance or \$50,000, reduced by the highest outstanding loan balance in the account during the prior twelve-month period. The participant may only have one loan outstanding at any time. The rate of interest will be determined by the prevailing rate charged by persons in the business of lending money for loans which would be made under similar circumstances. Loans are secured by the vested portion of the participant's account. Loan payments are made through payroll deductions and must be repaid within a period not exceeding 60 months.

NOTE 1 – DESCRIPTION OF THE PLAN (Continued)

Payment of Benefits

Withdrawals are permissible upon the participant's reaching age 59½, termination of employment, death, disability, retirement or certain financial hardships. The Plan's normal retirement age is 65 and hardship withdrawals are allowed under the Plan if participants meet the requirements defined in the plan document. Generally, upon termination of service or otherwise becoming eligible to receive benefits, a participant may receive the value of the vested interest in his or her own account as a lump-sum distribution or rolled over into another qualified retirement plan or IRA. The Plan allows for the automatic distribution of vested benefits of \$1,000 or less; if vested benefits are between \$1,000 and \$5,000, the funds will be rolled over into an IRA selected by the Plan Administrator.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate, discontinue making contributions to, amend, or modify the Plan at any time. In the event of a termination of the Plan, all participants will become fully vested in their accounts and the Company will arrange for distribution of all participants' accounts to the participants or their designated beneficiaries in accordance with the Plan.

NOTE 2 – SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan's financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Risk and Uncertainties

The Plan's investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amount reported in the Plan's financial statements. Because the values of the Plan's individual investments will continue to fluctuate in response to changing market conditions, the amount of any potential decrease in the Plan's investments that may be reported in subsequent periods cannot be determined as of the date the financial statements were available to be issued.

Valuation of Investments and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract values. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants represent participant loans that are to be recorded at their unpaid principal balance plus any accrued interest. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. In the event of a default, the Plan Administrator will deem the loan balance to be a distribution to the participant based upon the terms of the plan document. Interest rates ranged from 4.25% to 9.50% per annum at December 31, 2024 and 2023; notes receivable mature through 2031.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

The Company generally pays for certain administrative expenses.

Subsequent Events

The Plan has evaluated subsequent events through November 12, 2025, which is the date that the financial statements were available to be issued.

NOTE 3 – INVESTMENT INFORMATION CERTIFIED BY THE TRUSTEE

The Plan Administrator has obtained certifications from the trustee that information provided to the Plan Administrator by the trustee related to the following assets is complete and accurate. The Plan Administrator has elected the method of compliance as permitted. Accordingly, as permitted by 29 CFR 2520.103-8 of the United States Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan’s independent auditors not to perform any auditing procedures with respect to the information which appears throughout the financial statements and supplemental schedule related to the following assets:

The trustee also certified the completeness and accuracy of \$721,504 and \$902,710 of net appreciation in fair value of investments and \$271,536 and \$169,503 of interest and dividend income related to the aforementioned assets for the years ended December 31, 2024 and 2023, respectively.

NOTE 4 – FAIR VALUE MEASUREMENTS

The fair value measurements standard establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value valuation hierarchy under the standard are described below:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

NOTE 4 – FAIR VALUE MEASUREMENTS (Continued)

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

<i>Interest-bearing cash:</i>	Valued at the carrying value, which approximates fair value due to the short-term nature of such investments.
<i>Registered investment companies (mutual funds):</i>	Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
<i>Common collective trust:</i>	Valued based on the NAV of units of the common collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimating fair value. The NAV is based upon the fair value of the underlying investments comprising the trust less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value, or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain investments are presently managed by affiliates of FMTC; in addition, investments are held by FMTC. FMTC is the trustee and, therefore, these transactions qualified as party-in-interest transactions.

NOTE 6 – INCOME TAX STATUS

The Plan had previously adopted a standardized form of a volume submitter profit sharing 401(k) plan. This volume submitter plan had obtained its latest determination letter on March 31, 2014 in which the Internal Revenue Service (“IRS”) stated that the Plan was designed in accordance with applicable sections of the Internal Revenue Code (the “IRC”). In conjunction with the trustee change to FMTC, the Plan adopted a Volume Submitter Defined Contribution Plan (“Volume Submitter Plan”) which received a favorable opinion letter dated March 31, 2014 from the IRS indicating that the form of the Volume Submitter Plan is acceptable under applicable sections of the IRC. Although the Plan had been amended since receiving the opinion letters, the Plan Administrator believed that the Plan continued to qualify and was currently being operated in compliance with the applicable requirements of the IRC.

The IRS has determined and informed the Plan by a letter dated June 30, 2020, that the Plan related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan administrator and the Plan’s tax counsel believe that the Plan is designated, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the IRS. The Plan’s management has not identified any uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
