## INDEPENDENT AUDITORS' REPORT

To the Plan Trustee of  
Ontrak, Inc. 401(k) Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Ontrak, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024 stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

### **Note 1 – Description of Plan and Contributions**

The following description of the Ontrak, Inc. 401(k) Plan (the "Plan") is provided for general information purposes only. Ontrak, Inc. (the "Company") is the Plan Sponsor. The Plan became effective February 13, 2003 and was designed to encourage employees to save for retirement and stay with the Company until their retirement. The Plan was restated in 2015. Effective January 1, 2024, the Plan changed the trustee and recordkeeper from Principal Trust Company to Fidelity Management Trust Company. Participants should refer to the most recent Plan Documents for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan established for the benefit of all employees of the Company. The Plan is intended to satisfy all the requirements for a qualified retirement plan under the appropriate provisions of the Internal Revenue Code ("IRC") and similar state tax laws. Fidelity Management Trust Company serves as the trustee of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as of December 31, 2024, amended ("ERISA").

**Eligibility:** Employees may participate in the Plan, unless they are a nonresident alien with no U.S.-source income, a leased employee, or otherwise excluded under the Plan, after they have reached age 21 and have been hired by the Company.

**Participant Contributions:** Participants may voluntarily contribute to the Plan up to 100% of eligible earnings, subject to Internal Revenue Code limitations, as defined by the Plan agreement. The Plan provides for an automatic deferral rate of 3% of eligible compensation for employees who do not make an affirmative election. This percentage automatically increases by 1% per year until it reaches 15%, unless the participant elects otherwise.

**Employer Contributions:** The Company may contribute discretionary nonelective contributions to the Plan, in amounts determined by the Company for each Plan year. Any employer contributions, if made, are allocated in accordance with the Plan's allocation provisions and invested according to the participant's investment elections. There were no employer contributions for 2024.

**Investment Direction:** Each participant directs the investment of all assets attributable to their account, including any employer contributions, among the Plan's available investment options.

**Vesting:** Participants are immediately vested in their contributions plus actual earnings thereon. Participants are also fully vested in any employer nonelective and qualified nonelective contributions, as well as related earnings, at all times. Notwithstanding the above, any prior match contribution sources are subject to the vesting provisions applicable to that source. Participants are fully vested upon death or permanent disability.

**Forfeitures:** Participants' accounts are forfeited if the employer contribution portion has not fully vested at the date of termination. These amounts will be utilized to pay administrative expenses of the Plan or to reduce employer contributions. The forfeiture balance was \$620 at December 31, 2024.

**Note 1 – Description of Plan and Contributions (Continued)**

**Notes Receivable from Participants:** The Plan allows loans to participants up to 50% of their vested account balance, up to a maximum of \$50,000. The minimum loan amount is \$1,000. A participant may only have one loan outstanding at any time. Loan repayments are made through payroll deductions and must generally be repaid within five years. Loans to acquire a principal residence may be repaid in excess of five years. Loans are collateralized by the vested balance in the participant's account and bear interest at a rate similar to that of other loans from similar commercial lending institutions.

**Note 2 – Summary of Significant Accounting Policies**

A summary of the Ontrak, Inc. 401(k) Plan ("the Plan") significant accounting policies applied in the preparation of the accompanying financial statements is as follows:

**Use of Estimates:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Notes Receivable from Participants:** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan document.

**Payment of Benefits:** Benefit payments to participants are recorded upon distribution.

**Investment Valuation and Income Recognition:** The Plan carries its investments at fair value (except for investment contracts, which are reported at either the net asset value or the contract value). The Plan's custodian provides fair value based on quotations from national exchanges, if available. For investments that have no quoted market price, fair value is determined based on yield equivalents for such securities or for securities of comparable maturity, quality, and types as obtained from market makers. The Plan presents in the statement of changes in net assets available for benefits the net appreciation in its investments that consists of realized gains or losses and unrealized appreciation (depreciation) of those investments.

**Common Collective Trust:** The Plan, through Morley Stable Value Fund, holds investments in common collective trust funds (collectively, the "Trust Funds"). The Trust Funds are valued based on the unit value of the Trust Fund held by the Plan at year end, which is determined using the fair value of the underlying investments. Common collective trust funds are measured at net asset value ("NAV") as a practical expedient and are not classified within the fair value hierarchy.

The Trust Funds seek long-term growth of capital and current income by investing in collective trust funds that the investment advisor considers appropriate based on the investment time horizon.

## **Note 2 – Summary of Significant Accounting Policies (Continued)**

**Common Collective Trust (Continued):** Employer initiated events, if material, may affect the underlying economics of investment contracts. These events include plant closings, layoffs, plan termination, bankruptcy or reorganization, merger, early retirement incentive programs, tax disqualification of a trust or other events. The occurrence of one or more employer initiated events could limit the Trust's ability to transact at contract value with plan unitholders. The plan administrator does not believe that any of the events which could limit the Plan's ability to transact at contract value with participants are probable of occurring.

## **Note 3 – Income Tax Status**

The IRS has determined and informed the Plan sponsor by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

## **Note 4 – Plan Termination**

The Company has the right under the Plan to terminate the Plan subject to the provisions of the Employee Retirement Income Security Act of 1974. Upon termination of the Plan, further contributions to the Plan shall cease and all participants who are affected by such termination would receive distributions of their account balances. Net assets available for benefits would be distributed to the participants based on each participant's interest in the Plan.

## **Note 5 – Information Certified by the Trustee**

The Plan Administrator has elected the method of compliance as permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by the trustee of the Plan, except for comparing such information certified by the trustee to information included in the Plan's financial statements and supplemental schedules.

Information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplementary schedules at December 31, 2024 and net investment income, including dividends, other interest and net appreciation in investments for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Fidelity Management Trust Company. Information related to investments and notes receivable from participants disclosed in the accompanying financial statements at December 31, 2023 was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Principal Trust Company.

## Note 6 – Fair Value Measurements

FASB Accounting Standards Codification Topic No. 820, *Fair Value Measurements and Disclosures* ("ASC 820"), establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

*The following are descriptions of the valuation methodologies used for assets measured at fair value:*

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. The mutual funds held by the Plan are deemed to be actively traded.

*Common collective trust:* This investment is measured using the net asset value per share practical expedient as of December 31, 2024. There are no participant redemption restrictions for these investments; the redemption notice period is applicable only to the Plan.

*Employer securities:* Valued at quoted market prices obtained from an active exchange market.

**Note 7 – Exempt Party-In-Interest and Related Party Transactions**

Certain plan investments are managed by Fidelity Management Trust Company, which is also the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services are included as a reduction of the return earned on each fund. The Plan also issues loans to participants, which are secured by the balance in the participant's account. Such transactions are also considered related party transactions. New loans totaling \$119,679 were issued to participants during the year ended December 31, 2024.

**Note 8 – Notes Receivable from Participants**

Notes receivable from participants bear interest at a range of 5.25% - 10.25% and are receivable in monthly installments over a period of one to five years. Loan balances range from \$362 to \$47,334, and the total participant loan balance is \$124,773 at December 31, 2024.

**Note 9 – Excess Contributions Refundable**

During a Plan year, various participants may over-contribute to the Plan. The participants' excess contributions are returned to the participants. There were no excess contributions during 2024.

**Note 10 – Risk and Uncertainties**

The Plan provides for various investment options in which participants can invest. Investments are exposed to various risks such as interest rate, market and credit. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits and the Statement of Changes in Net Assets Available for Benefits.
