A. DESCRIPTION OF THE PLAN

The following description of the WizeHive, Inc. (the “Company”) 401(k) Plan (the “Plan”) provided only general information. Participants were advised to refer to the Summary Plan Description or Plan document for a more complete description of the Plan’s provisions.

1. General. The Plan was a defined contribution plan covering all eligible employees of the Company. The Plan Administrative Committee of the Company controlled and managed the operation and administration of the Plan. Advisor Trust Company (“Advisor Trust”) served as the custodian of the Plan. PCS Retirement, LLC (“PCS”), served as the Plan’s third-party administrator. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).
2. Contributions. Each year, participants could elect to contribute up to 100% of their pre-tax annual compensation, as defined by the Plan. Participants who had attained age 50 before the end of the plan year were eligible for catch-up contributions. Participants could contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants directed their investments of their contributions and company contributions into various investment options offered by the Plan. The Company had the right to, at its sole discretion, to make matching contributions. For the period ended January 31, 2025, the Company made no matching contributions to the Plan. Contributions were subject to certain limitations.
3. Participant accounts. Each participant’s account was credited with the participant’s contribution and Company contributions, if any, as well as allocations of Plan earnings (losses). Participant accounts were charged with benefit payments and allocations of administrative expenses paid by the Plan. Allocations were based on participant earnings or account balances, as defined. The benefit to which a participant was entitled was the benefit that can be provided from the participant’s vested account.
4. Vesting. Participants were vested immediately in their contributions plus actual earnings thereon. Vesting in the Company’s contribution portion of their accounts plus actual earnings thereon was based on years of continuous service. A participant was 50% vested after one year of credited service, and 100% vested after two years of credited service in employer matching contributions.
5. Notes receivable from participants. Participants could borrow from their fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of the participant’s vested account balance. The loans were secured by the balance in the participant’s account and bore interest rates commensurate with prevailing rates as determined by Plan management. Principal and interest were paid ratably through payroll deductions.

A. DESCRIPTION OF THE PLAN (CONTINUED)

6. Payment of benefits. Upon termination of service due to death, disability, or retirement, a participant whose account exceeded \$1,000 could elect either to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, or substantially equal monthly, quarterly, or annual installment options as provided by the Plan. For termination of service for other reasons, a participant could receive the vested balance as a lump-sum distribution. Participants also could request a hardship distribution from their vested contributions plus actual earnings thereon. The participant had to be currently employed with the Company and qualify for a hardship distribution under the Internal Revenue Service ("IRS") guidelines.
7. Forfeitures. Forfeited nonvested accounts were used to pay Plan administrative expenses and reduce future employer contributions. There were unused forfeited nonvested accounts at January 31, 2025 and December 31, 2024. During the period ended January 31, 2025, forfeitures totaling \$0 were utilized to pay administrative expenses.

B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

1. Basis of accounting. The financial statements of the Plan were prepared under the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP").
2. Estimates. The preparation of financial statements in conformity with U.S. GAAP required management to make estimates and assumptions that affected certain reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Accordingly, actual results could have differed from those estimates and assumptions, and those estimates could have been material.
3. Investment valuation and income recognition. Investments were reported at fair value. Fair value was the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (i.e., the exit price). See Note D for discussion of fair value measurements. The Plan's Investment Committee determined the Plan's valuation policies, utilizing information provided by the investment advisor and PCS.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation included the Plan's gains and losses on investments bought and sold as well as held during the year.

B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

4. Contributions. Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions were withheld from compensation.
5. Notes receivable from participants. Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable was recognized using the interest method. Related fees were recorded as administrative expenses and were expensed when they were incurred. Plan Management does not consider an allowance for credit losses to be necessary based on the nature of the receivables.
6. Benefits. Benefits were recorded when paid.
7. Administrative expenses. The Plan's administrative expenses were paid by either the Plan or the Company. Expenses that were paid by the Company were excluded from these financial statements. Fees related to the administration of notes receivables from participants were charged directly to the participant's account and were included in administrative expenses. Investment related expenses were included in net appreciation of fair value of investments.

C. INFORMATION PREPARED AND CERTIFIED BY ADVISOR TRUST

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements, including investments and notes receivable from participants held at January 31, 2025 and December 31, 2024, and net appreciation in fair value of investments, interest and dividends and interest income on notes receivable from participants for the period ended January 31, 2025 and the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Advisor Trust, the trustee of the Plan.

D. FAIR VALUE OF ASSETS

U.S. GAAP establishes a framework for measuring fair value that includes a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The fair value hierarchy is categorized into three levels based on the inputs as follows:

Level 1 – Inputs to the valuation methodology are quoted, unadjusted prices in active markets for identical assets that the Plan can access at the measurement date.

Level 2 – Inputs other than quoted prices in active markets, which were either directly or indirectly observable as of the reporting date, such as quoted prices for similar assets in active or inactive markets, inputs other than quoted prices that were observable for the asset, or inputs that were derived principally from or corroborated by observable market data by correlation or other means.

D. FAIR VALUE OF ASSETS (CONTINUED)

Level 3 – Pricing inputs were unobservable and include situations where there was little, if any, market activity for the investment. Fair value for these investments was determined using valuation methodologies that consider a range of factors including, but not limited to, the price at which the investment was acquired, the nature of the investment, local market conditions, trading values on public exchanges for comparable securities, current and projected operating performance, and financing transactions subsequent to the acquisition of the investment. The inputs into the determination of fair value require significant management judgment. Due to the inherent uncertainty of these estimates, these values may differ materially from the values that would have been used had a ready market for these investments existed.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that was significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following was a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at January 31, 2025 and December 31, 2024.

Mutual Funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that were registered with the U.S. Securities and Exchange Commission. These funds were required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

F. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments were shares of mutual fund accounts provided through Advisor Trust. G. TAX STATUS

The Plan is relying on the IRS approval of the non-standardized prototype plan that it was utilizing. The IRS has determined and informed the custodian by a letter dated June 30, 2020, that the prototype plan document was designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan Administrator and Plan's tax counsel believe that the Plan was designed and currently operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

H. RISKS AND UNCERTAINTIES

The Plan invested in various investment securities. Investment securities were exposed to various risks, such as interest rate, credit risks, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

I. PLAN MERGER

Effective December 31, 2024, the WizeHive 401(k) Plan merged into the Submittable 401(k) Plan. The merger was executed pursuant to a resolution adopted by the Board of Directors on September 26, 2024. As a result of the merger, all plan assets and participant account balances were transferred to the successor plan. The transfer of assets of \$4,972,643 and \$167,709 occurred on December 31, 2024 and January 10, 2025, respectively, the plan ceased operations as of the final transfer date. Accordingly, no further financial statements will be prepared for the WizeHive 401(k) Plan.

J. SUBSEQUENT EVENTS
