The Plan filed late because the Plan Administrator thought the previous TPA was filing the final return. There was no activity in the plan other than transferring assets to another plan that was opened. The Sponsor switched TPA's and there was miscommunication about who was obligated to file the 5500.

This is a small business and any penalties incurred on this would cause harm to the business and its employees for whom the plan was offered to.
