NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

NOTE 1 - PLAN DESCRIPTION

The following description of The American Kennel Club 401(k) Tax Deferred Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan was originally adopted on February 1, 1997. The Plan is a defined contribution plan covering all employees of The American Kennel Club, Inc. (the Sponsor) and certain affiliates except leased employees, nonresident aliens, and employees covered by a collective bargaining agreement. Employees are eligible to join the Plan on the first day of the month following their date of hire provided that they are age 18 or older. Unless they elect otherwise, employees will be automatically enrolled in the Plan with a pretax contribution rate of 6%, as soon as administratively possible following the date of hire (or rehire) or following the attainment of age 18. Employees may also elect to have this initial 6% contribution rate automatically increased each year by 1% to a maximum of 15%. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). John Hancock Retirement Plan Services (JHRPS) is the Plan's recordkeeper; John Hancock Trust Company LLC is the Trustee.

Contributions

Each year, participants may contribute from 1% to 60% of pretax annual compensation, as defined in the Plan, up to the maximum allowable amount as prescribed by the Internal Revenue Code (IRC) of \$23,000 in 2024. Catch up contributions, which are in accordance with the IRC, are also permitted for participants who expect to reach or are over the age of 50 by the Plan's year end up to a maximum of \$7,500 for 2024, bringing those participants' statutory maximum contribution limitations to \$30,500 in 2024. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Sponsor, at its election, shall make a matching contribution equal to 100% of the first 3% of base compensation that a participant contributes to the Plan and 50% of the next 3% of base compensation. Additional discretionary amounts may be contributed at the option of the Sponsor's board of directors, but no such additional amounts were contributed during 2024.

Each participant's account is credited with the participant's contributions and allocations of (a) the Sponsor's contributions and (b) Plan earnings. Allocations are based on participant earnings on their account balances, as defined. Forfeited balances of terminated participants' nonvested accounts are used to reduce future Sponsor contributions or pay administrative fees. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Loans to Participants

The Plan permits participants to borrow from their vested account balances. The maximum amount is the lesser of 50% of the vested account balance or \$50,000 reduced by the highest outstanding loan balance in the account during the prior 12-month period. Loan terms range from one to five years or for a longer period if the loan is for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Sponsor. Principal and interest are paid ratably through payroll deductions. Participant loans are carried at their outstanding balances plus accrued interest. The minimum loan amount is \$1,000. A participant may only have one loan outstanding at any time. The loans are generally repaid ratably through payroll deductions over a period not extending beyond five years from the date of the loan unless such loan is for the purchase of a primary residence.

If a participant ceases to make loan repayments and the Plan administrator deems the participant's loan to be in default, the participant's loan balance is reduced, and a benefit payment is recorded.

Vesting

Participants are immediately vested in their own contributions plus actual earnings thereon. Vesting in the Sponsor's contribution portion of participants' accounts plus actual earnings thereon is based on years of service. Participants are 100% vested in employer matching contributions after one year of service. Discretionary employer contributions are 100% vested after three years of service. Upon death or disability of the participant, all amounts become fully vested.

As of December 31, 2024 and 2023, the Plan had accumulated forfeitures totaling \$1,076 and \$11,082, respectively. During the year ended December 31, 2024, \$39,934 of forfeitures were used by the Plan, to pay plan expenses or offset employer contributions.

Investment Options

Participants direct the investment of their account balance into various investment options offered by the Plan and may change their investment options at any time, subject to the terms of the funding vehicles. Participants may change their investment options at any time. Currently, the Plan offers various mutual funds and a fixed income guaranteed option, which allows Plan participants the opportunity to invest in a wide array of securities that are traded on active securities exchanges.

Payment of Benefits

Normal retirement age under the Plan is 65. A distribution can be made due to disability, retirement, or termination of employment. A participant may defer receipt of his or her distribution if his or her vested account balance is over \$5,000. If a participant's vested account balance is less than \$1,000, then an automatic lump sum distribution will be made without his or her consent. In the event a participant's vested account balance is greater than \$1,000 but less than \$5,000, if the participant does not elect to have automatic distributions paid directly to an eligible retirement plan, a distribution shall be made in a direct rollover to an Individual Retirement Account offered by JHRPS. Participants with an account balance greater than \$5,000 can receive a distribution in either a lump sum or in installments, roll over their money into another qualified plan, or defer receipt until a later date, however, minimum required distributions for participants also apply per IRS regulations.

Administrative Expenses

Other than investment management related costs and fees described in note 2(c), substantially all administrative expenses of the Plan are paid by the Sponsor. Expenses paid by the sponsor are excluded from these financial statements.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates

The preparation of financial statements in conformity with US GAAP requires management of the Plan to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and the disclosure of contingent assets and liabilities at the date of the financial statements. These estimates and assumptions are based on the plan administrator's best estimate and judgment. The plan administrator evaluates its estimates and assumptions on an ongoing basis using historical experience and other factors, including consideration of the current economic environment. The plan administrator adjusts these estimates when facts and circumstances dictate. As future events cannot be determined with precision, actual results could differ from those estimates and assumptions.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value and contract value as determined by the Plan's custodian. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Contract value represents contributions made under the contract, plus interest at the contract rate, less withdrawals and administrative expenses.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Investment income or loss recorded by the Plan includes current earnings or losses from investments, the net change in the unrealized appreciation or depreciation in investments, and any realized gains and losses on investments sold during the period.

Investment management fees, including brokerage fees and commissions on the purchase and sale of securities and other related portfolio management expenses, are paid from assets of, and applied against the investment performance of the respective investments in the pooled separate accounts or mutual funds.

Loans to Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant's loan to be in default, the participant's loan balance is reduced, and a benefit payment is recorded.

Benefit Payments

Benefits are recorded when paid.

NOTE 3 - INFORMATION CERTIFIED BY THE TRUSTEE

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, John Hancock Trust Company LLC ("JHTC"), the trustee of the Plan, has certified that the following data included in the financial statements and supplemental schedule are complete and accurate:

- Investments and participant loans receivable, as shown in the Statements of net assets available for benefits as of December 31, 2024 and 2023.

NOTE 4 - FAIR VALUE MEASUREMENT OF INVESTMENTS

US GAAP establishes a framework for measuring fair value, which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted or published prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.

Level 2 - Inputs to the valuation methodology include:

- Quoted or published prices for similar assets or liabilities in active markets.
- Quoted or published prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted or published prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

There were no changes in methodologies used at December 31, 2024 or 2023. The following is a description of the valuation methodologies used for assets measured at fair value at December 31, 2024 and 2023:

Mutual Funds: Valued at the quoted market prices held by the Plan at year end (Level 1).

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 - INVESTMENT AT CONTRACT VALUE (NEW YORK LIFE INSURANCE ANCHOR ACCOUNT IV)

The Plan has a fully benefit-responsive investment contract, which maintains the contributions in a pooled separate account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The objective of the contract is to provide a low risk, stable investment offering competitive yields, allowing investors to accumulate current income while preserving principal. The contract is included in the statements of net assets available for benefits at contract value. Participants may ordinarily direct the withdrawal of all or a portion of their investment at contract value. As of December 31, 2024 and 2023, the Plan's investment at contract value totaled \$4,444,024 and \$3,410,815, respectively.

Certain events, such as the premature termination of the contract by the Plan or the termination of the Plan, would limit the Plan's ability to transact at contract value. The Plan administrator believes the occurrence of such events that would also limit the Plan's ability to transact at contract value with Plan participants is not probable.

NOTE 6 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE 7 - RISKS AND UNCERTAINTIES

The Plan invests in various investment funds. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 8 - INCOME TAX STATUS

The Plan has received a determination letter from the Internal Revenue Service dated April 6, 2018, stating that the Plan is qualified under Section 401(a) of the IRC, and therefore, the related trust is exempt from taxation. The Plan has been amended since receiving the determination letter. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Sponsor believes the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax exempt.

US GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or derecognition of an asset) or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 9 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain investments of the Plan are shares of a pooled separate account managed by New York Life Trust Company, an affiliate of JHRPS, and the John Hancock Trust Company LLC is the trustee of the Plan. Therefore, these transactions qualify as party in interest transactions.

The Plan issues loans to participants, which are secured by the vested balances in the participants' accounts.

Certain administrative functions are performed by officers and employees of the Plan Sponsor (who may also be participants in the Plan) at no cost to the Plan.

NOTE 10 - SUBSEQUENT EVENTS

The Plan evaluated events subsequent to December 31, 2024 and through November 21, 2025, the date on which the financial statements were available to be issued. There were no subsequent events requiring adjustment to, or disclosure in, the Plan's financial statements.
