### Opinion

We have audited the financial statements of Alro Steel Corporation Union Employees' 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of May 31, 2025 and 2024, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of the Plan as of May 31, 2025 and 2024, and the related changes in net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). ## NOTES TO FINANCIAL STATEMENTS

AS OF AND FOR THE YEARS ENDED MAY 31, 2025 AND 2024

---

### 1. DESCRIPTION OF THE PLAN

The following description of the Alro Steel Corporation Union Employees' 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**Plan Sponsor**—Alro Steel Corporation (the "Company") has sponsored the Plan since its inception. The Company functions as Plan administrator for various responsibilities of sponsorship (such as accounting, Plan design, and benefits administration) through appropriate Company personnel.

**General**—The Plan is a defined contribution plan for generally all union employees covered under an existing collective bargaining agreement, except for employees covered under the miscellaneous warehouse employees' union Local No. 781. John Hancock Retirement Plan Services ("John Hancock") serves as the investment manager for the Plan. John Hancock is the Plan's recordkeeper. John Hancock Trust Company serves as trustee for the Plan's assets. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974.

**Contributions**—Elective 401(k) salary reduction contributions are permissible under the Plan whereby participants may contribute 1% to 50% of their compensation to the Plan, subject to certain Internal Revenue Code (IRC) limitations. The Company will match the participant's contribution pursuant to the terms of the various collective bargaining agreements between the Company and the participating unions. Participant rollover contributions include contributions from another qualified plan. All contributions are remitted to the trustee, John Hancock Trust Company, and invested in the manner elected by the participant.

**Vesting**—Participants vest in Company contributions and related earnings at the rate of 20% after completion of two years of service and 20% for each year of service thereafter. Participants become fully vested after six years of service.

Participants are immediately and fully vested in employee 401(k) contributions, rollover contributions, Roth 401(k) contributions, and related earnings.

**Forfeitures**—Participants who terminate employment and incur a break in service prior to becoming fully vested forfeit the unvested portion of their account. A break in service is defined as a Plan year in which a participant has 500 or fewer hours of service with the Company. Forfeitures are allocated on a pro rata basis to continuing participant accounts based on a ratio of eligible compensation of an individual participant to the eligible compensation of all participants for such Plan year. There were no unallocated forfeitures at May 31, 2025 and 2024.

**Notes Receivable from Participants**—Participants may secure loans from their accounts in accordance with Plan provisions. Participant loans are limited to the lesser of (1) \$50,000 reduced by the highest outstanding loan balance during the preceding 12-month period or (2) one-half of the participant's account attributable to the participant's elective deferrals. Participant loans must be repaid within five years and carry a market rate of interest determined at the time of the loan. The loans bear interest between 4.75% and 10.0% and mature between 2025 to 2030.

**Payment of Benefits**—Participants may retire at age 65 or elect early retirement as early as age 55 if they have completed 10 years of service. Upon retirement, participants' balances in the Plan become fully vested and can be distributed to them in a lump sum or in installments, including the purchase of an annuity contract.

In the event of death or disability, a participant's interest in the Plan becomes fully vested and can be distributed in a lump sum or in installments, including the purchase of an annuity contract. Designated beneficiaries are maintained on file by the Plan administrator.

If a participant's termination is other than for retirement, disability, or death, the vested balance can be distributed after 15 days in a lump sum or in installments.

There were no amounts allocated to accounts of persons who elected to withdraw from the Plan, but had not yet been paid as of May 31, 2025 and 2024.

**Administrative Expenses**—Recordkeeping fees are primarily paid by the Plan with some miscellaneous recordkeeping fees paid by the Company. Other administrative fees are paid principally by the Company.

**Transfers**—Along with the Plan, the Company also sponsors a 401(k) plan for nonunion employees. If employees change their status during the year, their account balances may be transferred into the corresponding plan. For the years ended May 31, 2025 and 2024, transfers from the Plan were \$(361,730) and \$(2,204,175), respectively.

**Investment Options**—Participants select their investment options among various funds that are held by the Alro Steel Corporation Master Trust (the "Master Trust").

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting**—The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

**Use of Estimates**—The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Risks and Uncertainties**—The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Market volatility includes risks related to pandemics and international conflicts. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

**Investment Valuation and Income Recognition**—The Plan has a divided interest in the Master Trust. The underlying investments of the Master Trust include mutual funds, which are stated at fair value. Shares of mutual funds are valued at quoted market prices in an active market, which represent the net asset value of shares held by the Plan at year-end. The fully benefit-responsive guaranteed investment contract held in the Master Trust is stated at contract value.

The guaranteed investment contracts are valued at contract value. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Contract value represents contributions made to the fund, plus credited earnings, less participant withdrawals. See Note 5 for additional information on the guaranteed investment contract.

Purchases and sales of securities are recorded within the Master Trust on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held at year end.

Management fees and operating expenses charged to the Master Trust for investments in the mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

**Notes Receivable from Participants**—Loans receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest.

**Payment of Benefits**—Benefit payments to participants are recorded upon distribution.

### 3. INVESTMENT IN MASTER TRUST

The Plan is a participant in the Master Trust. The Master Trust was created and established for the purpose of investing, accumulating, and distributing the funds to provide retirement benefits to participants under the provisions of the Plan.

The other plans participating in the Master Trust are the Alro Steel Corporation and Subsidiaries Retirement/401(k) Plan, the Alro Steel Corporation and Subsidiaries Retirement/401(k) Plan (Money Purchase Portion), and the Alro Steel Corporation Union Employees' Money Purchase Pension Plan. Earnings and expenses for the year are allocated by the trustee based primarily upon the Plan's interest in certain investments in the Master Trust.

#### 4. FAIR VALUE MEASUREMENTS

Accounting Standards Codification (ASC) 820 establishes a single authoritative definition of fair value, sets a framework for measuring fair value, and requires additional disclosures about fair value measurements. In accordance with ASC 820, the Plan classifies its investments into Level 1, which refers to securities valued using quoted prices from active markets for identical assets; Level 2, which refers to securities not traded on an active market, but for which observable market inputs are readily available; and Level 3, which refers to securities valued based on significant unobservable inputs. Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement.

**Transfers between Levels**—The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic

conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another.

## **5. INVESTMENT CONTRACTS WITH INSURANCE COMPANY**

Participants can elect to invest their contributions in fully benefit-responsive investment contracts with New York Life Insurance Company (“New York Life”) and John Hancock Life Insurance Company (U.S.A.) (“John Hancock Life”) held in the Guaranteed Fund of the Master Trust. Contributions are maintained in a general account, which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contracts are included in the Master Trust financial statements at contract value as reported to the Master Trust by the insurance companies. GAAP allows fully benefit-responsive contracts, such as the investment contract with New York Life and John Hancock, to be stated at contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. These contracts have certain restrictions that affect the ability to collect the full contract value; for example, the Plan may not withdraw more than 25% of the beginning-of-the-year balance of the contract without incurring a penalty. Plan management believes that the occurrence of events that would cause the Plan to transact at less than contract value is not probable. The insurance companies may not unilaterally terminate the contracts and distribute any amount less than the contract value.

The insurance companies are contractually obligated to pay the principal and specified interest rate that are guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the issuer, but may not be less than 0%. Such interest rates are reviewed on a semi-annual basis for resetting. The crediting rate of the contract will track current market yields on a trailing basis.

**6. PRIORITIES ON PLAN TERMINATION**

While the Company has not expressed any intent to discontinue the Plan, it is free to do so at any time in whole or in part. Upon the complete or partial termination of the Plan, the accounts of all participants become fully vested and nonforfeitable.

**7. EXEMPT PARTY-IN-INTEREST TRANSACTIONS**

The Plan allows for transactions with certain parties who may perform services or have fiduciary responsibilities to the Plan, including the Company. The Plan issues loans to participants, which are secured by the vested balances in the participants' accounts.

**8. TAX STATUS**

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service (IRS). The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of May 31, 2025 and 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

The Plan obtained its latest determination letter dated September 9, 2022, in which the IRS stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Company and Plan management believe that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC and the Plan and related trust continue to be tax exempt. Therefore, no provision for income tax has been included in the Plan's financial statements.

**9. RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500**

The Plan's Form 5500 does not include certain participant loan receivable balances that have been recorded in the Form 5500 as deemed distributions of participant accounts. The accompanying statements of net assets available for benefits include the aforementioned amounts. A reconciliation of net assets available for benefit per the financial statements to Form 5500 at May 31, 2025 and 2024, is as follows:
